## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Yamamoto of Orient, Inc. Shared Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended March 31, 2024, and the related notes to the financial statements.

### Opinion

### Basis for Opinion

#### Note 1 – Description of the Plan

The following description of the Yamamoto of Orient, Inc. Shared Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan originally effective April 14, 1988 covering all employees of Yamamoto of Orient, Inc., Stash Tea, Southern California Mushrooms, Laguna Investments, Inc., and Yamamoto Enterprises (collectively the Company), who have completed 30 days of service. Participants can enter the Plan monthly. The Plan engages Principal Trust Company and Principal Life Insurance Company (the custodians) to hold and invest Plan assets, execute Plan transactions, and provide Plan compliance and administrative services. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company is the Plan's Sponsor, serves as the Plan Administrator, and is responsible for oversight of the Plan.

##### Contributions

Each year, participants may contribute up to 100% of their annual compensation, as defined in the Plan, into a pre-tax deferral account and/or an after-tax Roth account subject to the limits set by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions (rollovers) from other qualified plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Newly eligible participants are automatically enrolled in the Plan at a 6% deferral rate, unless the participant chooses a different amount, or declines participation in the Plan.

The Plan requires the Company to make a safe harbor nonelective contribution of 3% of participants' compensation as defined by the Plan. The Company may also elect to make other discretionary contributions. There are no additional requirements to receive the discretionary Company contributions. No discretionary contributions were made or declared for the periods presented. Contributions are subject to regulatory limitations.

##### Investment Elections

Participants direct the investment of their and the Company's contributions into various investment options offered by the Plan that are designated by the Plan's Administrative Committee. Participants can change their investment elections daily.

##### Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contributions, when applicable, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses and any related transaction fees for loans and distributions that are paid by the Plan. Allocations are made based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are immediately vested in their deferrals and the Company's safe harbor nonelective contribution, plus actual earnings thereon. Vesting in the Company's discretionary contributions plus actual earnings thereon is based on years of continuous service and occurs gradually. A participant becomes partially vested at the end of one year of credited service and is 100% vested after five years of credited service. A participant becomes fully vested in the entire balance of his or her account upon attainment of normal retirement age, permanent disability or death.

##### Payment of Benefits

On termination of service due to any reason, participants with vested account balances of \$1,000 or less receive an automatic lump-sum distribution, unless the participant requests that it be rolled-over to an Individual Retirement Account (IRA) provider or another qualified retirement plan. Participants with vested account balances of less than \$5,000 and more than \$1,000 receive an automatic distribution to an IRA. Participants with vested account balances of \$5,000 or more may elect to receive benefits in any way permitted by the Plan, choose to leave their balance in the Plan, or rollover their balance into another qualified retirement plan or IRA. Participants may also take in-service and hardship distributions subject to the terms of the Plan and IRS regulations.

#### **Note 1 – Description of the Plan, continued**

##### Notes Receivable from Participants

The Plan allows participants to borrow against their vested account balances. Loans may not be made for less than \$500 and may not exceed the lesser of \$50,000 or 50% of a participant's vested account balance. The loans are secured by the balance in the participant's account. The interest rate for loans is based on the rates available for similar loans from commercial lending institutions. Participants may only have one loan outstanding at a time. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years.

##### Forfeited Accounts

Generally, a participant's unvested portion of the Company's discretionary contributions is forfeited upon termination of employment. Forfeitures are maintained in a separate account and can be used to pay Plan expenses, reduce Company contributions, or allocated to participants.

At March 31, 2024 and 2023 forfeited nonvested accounts totaled \$12,549 and \$0, respectively. During the year ended March 31, 2024, \$3,192 of forfeitures were used to reduce the Company's contribution.

#### **Note 2 – Summary of Significant Accounting Policies**

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed as they are incurred. No allowance for credit losses has been recorded as of March 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

##### Payment of Benefits

Benefits are recorded when paid.

##### Contributions

Contributions from Plan participants and the Company, when applicable, are recorded in the year in which the employee contributions are withheld from compensation.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan permits the payment of Plan expenses to be made from the Plan's assets. Fees are charged to participants on a pro rata basis, equally to participant accounts, or to a participants account for transactions specifically related to that participant.

Certain investment management fees and other charges paid to the Custodians are offset against fund performance in the net appreciation in fair value of investments on the statement of changes in net assets available for benefits and are not, therefore, separately reflected as administrative expenses. Certain Plan expenses are paid directly by the Company and therefore are excluded from these financial statements.

Risks, Uncertainties, and Concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At March 31, 2024, approximately 16% of the Plan's investments were invested in the Fidelity 500 Index Fund.

Subsequent Events

The Plan has evaluated subsequent events through September 12, 2025, the date the financial statements were available to be issued.

**Note 3 – Certified Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held and notes receivable from participants at March 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants, and interest and dividends for the year ended March 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company, the Custodians of the Plan, qualified institutions.

**Note 4 – Tax Status**

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 5 – Fair Value Measurement**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: 1) quoted prices for similar assets or liabilities in active markets; 2) quoted prices for identical or similar assets or liabilities in inactive markets; 3) inputs other than quoted prices that are observable for the asset or liability; 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2024 and 2023.

*Registered Investment Companies (Mutual Funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts (PSA):* PSA's invest in a variety of domestic stock, international stocks, mutual funds, bonds and other securities. The majority of the underlying securities have observable level 1 quoted pricing inputs. While the underlying asset values are generally based on publicly quoted prices, the net asset value (NAV) of each separate PSA is not valued using publicly quoted prices. The NAV provided by the fund managers is used as the practical expedient to estimate fair value. PSA's can be redeemed on a daily basis and each PSA has its own investment strategy. Participants should refer to the individual PSA's prospectus for a more complete description of the PSA and its investment strategy.

*Collective Investment Trust (CIT):* Valued at the net asset value of units of a collective trust. The net asset value, as provided by the fund manager, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities.

#### Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions, if any.

#### Note 8 – Delinquent Employee Deferral Transmittals

During the years ended March 31, 2024, 2023, 2022, 2021, 2019 and 2018, the Company erroneously failed to remit certain employee deferrals and loan payments totaling \$45,254, \$22,486, \$33,270, \$41,101, \$33,384, and \$6,002, respectively, to the Plan in the time period described in 29 CFR 2510.3-102. The contributions and loan payments have since been remitted to the Plan and the Company will make a corrective contribution for lost earnings and will complete any other corrective actions as needed.
