## INDEPENDENT AUDITORS' REPORT

The Trustees  
General Plumbing Supply, Inc. Retirement and 401(k) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of General Plumbing Supply, Inc. Retirement and 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended March 31, 2025 and 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

## Notes to Financial Statements

March 31, 2025 and 2024

### (1) Description of Plan

The following description of General Plumbing Supply, Inc. Retirement and 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### (a) General

The Plan is a defined contribution plan for the employees of General Plumbing Supply, Inc. (the Company). Employees are eligible for participation in the Plan on the earliest entry date on which the employee is at least 18 years old and has completed one year of service (minimum 1,000 hours). Entry into the Plan is permitted on the earlier of the first day of April, July, October or January of the year after which the employee becomes eligible. The Plan's trustee is John Hancock Trust Company, LLC (John Hancock). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### (b) Contributions

Contributions to the Plan are made by the participant through salary reductions and by the Company through discretionary contributions. Participants may elect to contribute 100% of their compensation on a before tax basis as defined by the Plan, subject to certain limitations under Sections 401(k) and 415 of the Internal Revenue Code (IRC). The Plan allows for discretionary employer matching contributions. The employer will contribute an amount equal to the sum of 100% of the amount of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's compensation but do not exceed 5% of the participant's compensation.

#### (c) Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, (b) Plan earnings, and (c) charged with an allocation of investment and administrative expenses. Allocations are based on a participant's earnings, account balance or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### (d) Investment Options

Participants direct their contributions to invest in several investment options with John Hancock. The Plan currently offers various mutual funds and a common/collective trust as investment options for participants.

#### (e) Vesting

Participants are immediately vested in all contributions withheld from employees plus actual earnings thereon. Participants are also immediately vested in all of the Company's safe harbor contributions plus actual earnings thereon. Profit sharing contributions are vested on a five year graded schedule.

### Notes to Financial Statements, Continued

#### (1) Description of Plan, Continued

##### (f) Notes Receivable from Participants

The provisions of the Plan allow for loans to the participants at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest of prime rate plus 1% and provide for periodic repayment over a period not to exceed five years. Principal and interest is paid ratably through weekly payroll deductions.

##### (g) Payment of Benefits

On termination of service, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

##### (h) Operating Expenses

Certain significant costs of the Plan are paid for by the Company, including audit fees.

##### (i) Forfeitures

Forfeited non-vested contributions can be used to reduce employer contributions or offset administrative expenses. There were no forfeited accounts during the years ended March 31, 2025 and 2024.

#### (2) Summary of Significant Accounting Policies

##### (a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### (b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes, therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

##### (c) Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the common/collective trust, which is stated at net asset value (practical expedient). Fair value is the price that would be received from the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for a discussion of fair value measurements. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### (2) Summary of Significant Accounting Policies, Continued

##### (d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative fees and expensed when they are incurred. No allowance for credit losses has been recorded as of March 31, 2025 and 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### (e) Contributions

Contributions from Plan participants and the Company contributions are recorded in the year in which the participants' compensation is earned.

##### (f) Payment of Benefits

Benefits paid to participants are recorded when paid.

##### (g) Subsequent Events

The management of the Plan has evaluated subsequent events through the date of the report which is the date the financial statements were available to be issued.

#### (3) Fair Value Measurements

A framework has been established for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

(3) Fair Value Measurements, Continued

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025 and 2024.

- Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Common/collective trust - The fund is a bank collective trust fund for which Reliance Trust Company serves as trustee and investment manager. The common collective trust does not have a readily determinable fair market value and is valued based upon a net asset value practical expedient on the last day of the calendar year. There are no unfunded commitments and no withdrawal restrictions.

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There were no transfers between levels 1 and 2 during the years ended March 31, 2025 and 2024.

(4) Investment Information Certified by Trustee (Unaudited)

The financial information relating to the Plan's assets at March 31, 2025 and 2024, as well as investment income and investment transactions for the years then ended, have been derived from information provided by John Hancock and have been certified by them as complete and accurate. The incorporation of this financial information in the accompanying financial statements is based solely on their certification and has not been audited by independent auditors.

(5) Parties-in-Interest Transactions

The Plan receives services from a third party contract administrator, an asset custodian, and an investment advisor. During the years ended March 31, 2025 and 2024, the fees paid by the Plan for these services amounted to \$117,480 and \$102,622, respectively. Additionally, notes receivable from participants qualify as party-in-interest transactions.

(6) Tax Status

The IRS has determined and informed the Plan Sponsor by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(8) Risks and Uncertainties

The Plan invests in various investments, which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
