We have performed audits of the accompanying financial statements of Hansen Plastics Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

MARCH 31, 2025 AND 2024

(1) DESCRIPTION OF PLAN:

The following description of the Hansen Plastics Corp. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General -

The Plan is a defined contribution plan covering all eligible employees of Hansen Plastics Corp. (Company). Employees who are eighteen years of age are eligible for the elective deferral and employer matching portion of the Plan as of their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustee is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, monitoring the investment performance and reports of the plan.

Contributions -

For the plan years ended March 31, 2025 and 2024, the employer matching contribution is discretionary. During the plan year ended March 31, 2025 and 2024, the employer did not make a discretionary matching contribution.

The Plan allows discretionary Company profit sharing contributions to the Plan. For the years ended March 31, 2025 and 2024, the employer did not make a discretionary profit sharing contribution.

(1) DESCRIPTION OF PLAN (continued):

Contributions -

Each year, participants are allowed to contribute to the Plan up to 100% of their pretax annual compensation, with such contributions not to exceed the maximum allowable by law annually. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit plans or defined contribution plans (rollover). The participant directs the investment of their contributions and Company contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Contributions are subject to certain IRS limitations.

Participant Accounts -

Each participant's account is credited with the participant's contributions, Company matching contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting -

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Participants were immediately vested in the Company discretionary matching contributions, plus actual earnings thereon.

Payment of Benefits -

A participant who is terminated by reason of death, disability, retirement, or any separation from service, shall receive the vested amount in their separate account as a lump-sum payment. The manner in which distribution is made shall be determined after consulting with the participant or beneficiary.

Forfeitures -

Forfeited non-vested accounts at March 31, 2025 and 2024 were \$0. These accounts can be used to offset plan administration expenses. For the years ended March 31, 2025 and 2024, no forfeitures were used to reduce plan expenses.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting -

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates -

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition -

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policy utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net (depreciation) or appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions -

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits -

Benefits are recorded when paid.

Expenses -

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued):

Subsequent Events -

The Plan has evaluated subsequent events through December 2, 2025, the date the financial statements were available to be issued.

(3) FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025 and 2024.

(3) FAIR VALUE MEASUREMENTS (continued):

Pooled separate accounts: The Plan invests in pooled separate accounts (“PSAs”). Each PSA invests solely in a single underlying mutual fund and is valued daily based on the publicly quoted net asset value (“NAV”) of that mutual fund. As the PSA unit values are determined directly from observable market prices of the underlying mutual funds and are available to participants and plan sponsors each day, management considers these investments to have readily determinable fair values. Accordingly, the PSAs are classified as Level 1 within the fair-value hierarchy in accordance with ASC 820.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Accordingly, mutual funds are classified as Level 1 within the fair-value hierarchy in accordance with ASC 820.

(4) GROUP ANNUITY CONTRACT:

The Plan entered into a fully benefit-responsive guaranteed investment contract with Principal totaling \$574,564 and \$645,958 for the years ending March 31, 2025 and 2024, respectively. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and is currently at a 1.65% annual rate until November 30, 2025. The rate is reset semi-annually. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

(5) TRANSACTIONS WITH PARTIES IN INTEREST:

For the Plan years ended March 31, 2025 and 2024, certain accounting fees were paid by the Plan Sponsor. Certain employees of the Company perform administrative services for the Plan. These employees receive no compensation from the Plan for these services.

Certain Plan investments are managed by Principal Life. Principal Life is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

(6) PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

(7) TAX STATUS:

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the appropriate taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to fiscal year ended March 31, 2022.

(8) RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(9) CERTIFIED INVESTMENTS:

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at March 31, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends for the years ended March 31, 2025 and 2024, was obtained from management and agreed to or derived from information certified as complete and accurate by Principal (the plan administrator).
