Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the 403(b) Thrift Plan of Gateway Community Health Center, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the 403(b) Thrift Plan of Gateway Community Health Center, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from two qualified institutions as of March 31, 2025 and 2024, and for the year ended March 31, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 1. Description of Plan

The following description of the 403(b) Thrift Plan of Gateway Community Health Center, Inc. (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan cover all employees of the Company except for those who are non-resident aliens, classified or treated as independent contractors or other non-employees by the Gateway Community Health Center, Inc. (“Plan Sponsor”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan’s Finance Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Board of Trustees. The custodian and recordkeeper of the Plan is Mutual of America Life Insurance Company (“Mutual of America”). Gateway Community Health Center, Inc. (“Plan Sponsor”), amended the plan July 1, 2022 to remove the minimum service requirement and the minimum age requirement is 18 years of age.

Contributions

Each year, participants may contribute the lesser of 90% of annual eligible compensation as defined by the Plan or up to the \$23,000 contribution limit for the plan year 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified contributions plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 4% of eligible compensation. Contributions are automatically invested in a designated investment option selected by the participant. The Company contributed 4% of the first 100% of base compensation until July 1, 2022 when the Plan was amended to contribute 5% of the first 100% of base compensation. The matching Company contributions are invested directly into designation investment options selected by the participants. Contributions are subject to certain statutory limitations.

Funding Policy

It is the policy of the Plan Sponsor to remit the employee contributions as soon as administratively possible.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the employer's contribution, if any, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants have a 100% Vested interest at all times in their accounts attributable to elective deferrals, employee contributions, and rollover contributions. Participants' vesting in employer matching contributions are based on years of service as follows:

Payment of Benefits

Vested benefits are paid to participants upon death, disability, retirement or termination of employment by either arranging for a rollover to another plan, lump sum payment, or installments. Hardship withdrawals are available and are subject to certain limitations.

Upon attaining age 59 ½, a participant employed by the Center may elect certain in-service withdrawals from their vested account balance. Such distributions are subject to certain taxes, fees, and other restrictions. For terminated participants' account balances that are less than \$5,000, the Plan administrator may distribute the entire amount in a lump sum without the participant's consent. If the participant's vested portion is greater than \$5,000, the participant may elect to maintain the vested portion in the Plan.

Forfeited Accounts

Forfeited accounts may be applied to reduce future employer contributions. For the Plan years ending March 31, 2025 and 2024, forfeitures applied were \$53,459 and \$34,768, respectfully.

For the Plan years ending March 31, 2025 and 2024, unapplied forfeitures were \$6,968 and \$3,429, respectfully.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the plan are prepared using the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investments contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. The plan did not hold any investments measured at contract value as of or during the years ended March 31, 2025 and 2024.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

2. Summary of Significant Accounting Policies

Benefits Paid to Participants

Benefits are recorded when paid.

Terminated Employees with Vested Benefits

As of March 31, 2025 and 2024, terminated participants with vested balances in the amount of \$916,036 and \$672,269, respectively, remains in the Plan. The benefit payments are not reflected in the financial statements until benefit claims have been processed and approved for payment.

Excess Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with corresponding reduction to contributions. There were no excess contributions in 2025 or in 2024.

Administrative Expenses

The Plan Sponsor pays for certain direct Plan administrative and other expenses, but this is discretionary, and such expenses are excluded from these financial statements. Additionally, Plan Sponsor employees provide certain administrative duties at no charge to the Plan. At the Plan Sponsor's option, Plan administrative expenses may be paid by the Plan Sponsor or charged to the Plan and deducted from participant's individual accounts. Participants are charged directly for loan and distribution fees.

Certain fees are also paid through revenue sharing from Plan investments to Mutual of America and the Plan's investment advisor and the third-party administrator, which are generally included in the investment appreciation. For the years ended March 31, 2025 and 2024, the Plan paid \$3,681 and \$2,449, respectively, in administrative expenses.

3. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Plan Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

3. Fair Value Measurements (Continued)

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Reported at fair value based on quoted market price of the fund classified within Level 1 of the valuation hierarchy, as of March 31, 2025 and 2024. Mutual funds held by the plan are open end mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

4. Information Prepared and Certified by Custodian

The following information, which Mutual of America Life Insurance Company has certified as complete and accurate, has not been subject to audit procedures:

- Investments in mutual funds and general account, net appreciation (depreciation) in investments and other investment income
- Information presented in the accompanying supplemental schedule

The Plan's independent auditors did not perform any auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. Income Tax Status

The Internal Revenue Service (IRS) has determined and informed the Plan Sponsor by a letter dated March 31, 2017, that the Plan and related trust are designated in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the Plan's effective date, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognized a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities, however, there are currently no audits for any tax periods in progress. The plan administrator has analyzed the tax positions taken by the plan has concluded that as of March 31, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. Tax years that remain subject to examination are 2022 and forward.

6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

7. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Party-in-Interest and Related-Party Transactions

Certain Plan investments are shares of mutual funds managed by Mutual of America. Mutual of America is the plan custodian as defined by the Plan and, therefore, these transactions qualify as a party-in-interest transactions. Fees paid by the Plan for the custodial and record-keeping services amounted to \$3,681 and \$2,449 for the years ended March 31, 2025 and 2024, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

9. Evaluation of Subsequent Events

Subsequent events were evaluated through September 10, 2025, which is the date the financial statements were available to be issued.
