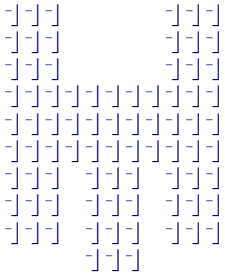

INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of
Gleneagles Country Club, Inc. 401(k) Plan
Delray Beach, Florida

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Gleneagles Country Club, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Gleneagles Country Club, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 31, 2025 and 2024, and for the year ended March 31, 2025, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Gleneagles Country Club, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Gleneagles Country Club, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule of assets held for investment purposes as of March 31, 2025, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of Plan

The following description of the Gleneagles Country Club, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

- a) *General* – The Plan is a defined contribution plan covering all employees of the Gleneagles Country Club, Inc. (the "Club"), except members of a collective bargaining unit and non-resident aliens, who have at least one year of service to the Club and have attained the age of twenty-one. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was formed on April 1, 2000, and was most recently restated on April 1, 2021, as required by the Internal Revenue Service's (IRS) restatement cycle.
- b) *Plan Administration* – The Plan is administered by the Board of Directors of the Club and by Definiti, LLC, a third-party administrator (TPA). The Plan's trustees are members and/or employees of the Club. As of March 31, 2025 and 2024 the investment manager, custodian, and party which directs the custody and management of the Plan's assets is John Hancock Life Insurance Company (USA) (John Hancock).
- c) *Contributions* – Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, and subject to limitations as defined by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. For the years ended March 31, 2025 and 2024, the Club contributed a discretionary match of 50% of the first 4% of base compensation that a participant contributed to the Plan.
- d) *Participant Accounts* – Each participant's account is credited with the participant's contribution, the employer's discretionary matching contribution, and Plan earnings. In addition, participant accounts are credited with forfeitures of terminated participants' non-vested accounts. Allocations are based upon an eligible participant's relative compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- e) *Investment Options* – Upon enrollment in the Plan, a participant may direct the investment of their contributions to any of the investment options offered in the John Hancock program as determined by the Plan Administrator. Participants may change their investment options via phone or Internet access to John Hancock at any time.
- f) *Vesting* – Participants are immediately vested in their salary contributions and rollovers plus actual earnings thereon. Vesting in the Club's discretionary matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant becomes 100% vested after 4 years of credited service or immediately upon death or disability.
- g) *Administrative Expenses* – Individual participants pay for loan and distribution fees, and investment management fees. The Plan Sponsor pays for other costs of plan administration.

1. Description of Plan, continued

- h) *Participant Notes Receivable* – Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their individual vested account balance. Participants may have no more than one loan outstanding at any one time. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loans fund. Loan terms range from 6 months to 5 years or up to 30 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the loan administrator at the time the loan is taken (currently Prime Rate plus 2%). The interest rates on participant loans receivable as of March 31, 2025 and 2024 range from 5.25% to 10.50%. Principal and interest is paid ratably through bi-weekly payroll deductions. Participant loans are reported at their unpaid principal balance plus any accrued interest. The loan balances are secured by the participants' investment accounts, therefore, no allowance for uncollectible loans was deemed necessary. For purpose of presentation on the schedule of assets held for investment purposes, the participants notes receivable are presented as part of the investments for the Form 5500, and are referred to as participant loans.
- i) *Payments of Benefits* – Upon retirement, disability, death, or termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installments over a period not to exceed the participants life expectancy, or an annuity for the life of the participant with or without a term certain guarantee or a survivor beneficiary. In-service distributions are permitted for employees attaining age 59 ½. Hardship distributions are also permitted from all accounts that are fully vested.
- j) *Forfeited Accounts* – Upon termination of employment, the non-vested portion of a participant's account is forfeited. Forfeitures may be used to pay administrative expenses, to reduce future employer contributions, or to be allocated to the accounts of participating employees according to their relative compensation at the inception of the plan year. Total forfeitures available as of March 31, 2025 and 2024 amounted to \$3,437 and \$1,826, respectively. During the year ended March 31, 2025, \$4,349 was forfeited by employees and \$2,738 was applied to administrative expenses.

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

- a) *Basis of Accounting* – The accompanying financial statements are prepared on the accrual basis of accounting.
- b) *Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies, continued

- c) *Payment of Benefits* – Benefits are recorded when paid.
- d) *Valuation of Investments and Income Recognition* – Investments in registered investment companies (i.e., mutual funds held in pooled separate accounts) are valued at quoted market prices, if available, of a national securities exchange on the last business day of the year. Investment options that do not have readily available market quotations are valued according to quotations from the custodian. Purchase and sales of securities are recorded on a trade-date basis. Investment income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.
- e) *Plan Risk and Uncertainties* – The Plan and the Plan assets are sensitive to economic pressures prevalent in the investment market. The pressures primarily stem from interest rates, market and credit risk and their effect on bond rates, mortgage rates, the value of real estate, stock prices, and the overall stability of the market. Certain Plan investments are shares of pooled separate accounts managed by the custodian. Change in the custodian's management may affect operating results of the funds adversely. Additionally, the financial position of the Plan Sponsor, Gleneagles Country Club, Inc., may have a significant impact on the Plan. Specifically, this includes the ability of the Plan Sponsor to continue to make contributions under the program and/or the stability of the Plan Sponsor's operations. Other external factors which may affect the Plan, and the Plan assets include legislation or regulations established by the IRS, ERISA, and/or Department of Labor (DOL).

3. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification (ASC) 820-10, *Fair Value Measurement and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

3. Fair Value Measurements, continued

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following descriptions identify the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of March 31, 2025.

- a) *Noninterest-bearing cash* – The carrying amount reported approximates fair value due to the stable \$1 value.
- b) *Mutual funds held in pooled separate accounts* – Investment portfolio of mutual fund shares that are valued at quoted market prices of a national securities exchange on the last business day of the year of shares held by the Plan at year end.

4. Information Certified by the Plan's Custodian

5. Related Party Transactions

Certain Plan investments include shares of pooled separate accounts managed by John Hancock. John Hancock is the investment manager and custodian as defined by the Plan as of March 31, 2025, and therefore, these transactions qualify as party-in-interest transactions. However, they are not considered prohibited transactions in accordance with appropriate ERISA exceptions.

6. Tax Status

The Plan is utilizing a Non-Standardized Profit Sharing/401k Plan offered by its TPA, Definiti, LLC. The Plan reflects the implementation of the recent legislative changes in the regulations governing qualified tax-deferred arrangements via the IRS's Cycle 3 restatement. The restated Plan received an opinion letter from the Internal Revenue Service dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified and is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although the Club intends the Plan to be permanent and continuing, the Club has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and accrued benefits, to the extent funded or required to be funded, must be distributed to the participants.

8. Subsequent Events

The Plan's management has evaluated subsequent events through January 13, 2026, the date on which the financial statements were available to be issued, and determined there were no events to disclose in these financial statements.
