## Independent Auditor's Report

To the Plan Administrator and Plan Participants

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the CT Management, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statements of net assets available for benefits as of September 30, 2025 and 2024, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements ("financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of September 30, 2025 and 2024, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### 1. Description of Plan

The following description of the CT Management, Inc. Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of CT Management, Inc. and its participating affiliates Cargo Transporters, Inc. and Cargo Integrated Logistics, Inc. (collectively, the “Company” or “Employer”). Employees who have attained age 18 or older and have completed 90 days of service are immediately eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

#### **Contributions**

Eligible employees are automatically enrolled to defer 3% of pre-tax compensation, which will increase by increments of 1% each October 1<sup>st</sup> up to a maximum of 10%, unless they elect an alternative deferral percentage or decline participation in the Plan. Participants may otherwise elect to contribute up to 50% of their pre-tax compensation, as defined by the Plan, not to exceed the limits set by the Internal Revenue Service (“IRS”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“rollovers”). The Plan provides for flexible discretionary matching contributions, up to a maximum of 6% of the participant’s compensation. Prior to January 1, 2025, when the Company suspended the flexible discretionary matching contribution, the rate of match was funded based on the participant’s years of service as follows.

| <u>Number of Years of Service</u> | <u>Employer Contribution</u> |
|-----------------------------------|------------------------------|
| Less than 6                       | 60%                          |
| 6 to 10                           | 80%                          |
| 11 or greater                     | 100%                         |

The Company may also make discretionary profit sharing contributions determined annually by the Board of Directors. Any profit sharing contribution will be allocated based on the ratio the participant’s eligible compensation to the total eligible compensation, as defined. In order to participate in any profit sharing contribution, a participant must be either employed on the last day of the plan year, with no service hour requirement or have at least 501 hours of service, if not employed on the last day of the Plan year. No profit sharing contributions were made in 2025 or 2024.

Upon enrollment in the Plan, a participant may direct participant and Company contributions in any of the investment options offered through the Plan. Participants may change their deferral percentages and investment options at any time.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s and the Company’s contributions and an allocation of the Plan’s net earnings and administrative expenses. Allocations are based on participant contributions, earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### 1. Description of Plan (Concluded)

#### ***Vesting***

Participants are immediately vested in their voluntary contribution, plus actual income or loss thereon. Vesting in the Company's contributions, plus any income or loss thereon, is based on years of continuous service according to the following schedule.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of the participant's vested account balance. Note terms generally range from one to five years. The notes are secured by the balance in the participant's account and bear interest at the prime interest rate plus 1% as published in The Wall Street Journal at the date of application. Participants may only have one outstanding note at any time. Principal and interest are paid ratably through payroll deductions.

#### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement, or separation, a participant or their beneficiary may elect to receive a lump-sum amount, installment or partial payments equal to the value of the participant's vested interest in his or her account. In-service distributions may be made to participants who have reached age 65. Withdrawals may also be made upon circumstances of financial hardship in accordance with provisions specified in the Plan.

#### ***Forfeited Accounts***

Forfeitures of non-vested participant accounts may be used to reduce Company contributions or offset administrative expenses. During 2025 approximately \$35,000 and \$10,000 were used to reduce Company contributions and offset administrative expenses, respectively. During 2024, approximately \$106,000 was used to reduce Company contributions. As of September 30, 2025 and 2024, available forfeited non-vested accounts totaled approximately \$80,000 and \$1,000, respectively.

#### ***Administrative Expenses***

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Distribution and note fees are paid from affected participant accounts. Other fees, including trustee, recordkeeping, and asset fees, are paid by the Plan.

#### ***Basis of Accounting***

The accompanying financial statements have been prepared under the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### 2. Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

Investments are primarily stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts through the Empower Investments Fixed Account. See Note 9.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded at September 30, 2025 and 2024. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Subsequent Events***

Management has evaluated events occurring subsequent to the date of the financial statements through December 30, 2025, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

### 3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments and notes receivable from participants held at September 30, 2025 and 2024, and net appreciation (depreciation) in the fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ending September 30, 2025 and 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC ("Empower"), the trustee of the Plan.

### 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### 5. Income Tax Status

The Plan has adopted a prototype non-standardized plan document sponsored by Great-West (“GW”) Trust Company, LLC (now known as Empower). The IRS has determined and informed GW by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested and nonforfeitable.

### 7. Party-in-Interest Transactions

Certain plan investments are managed by Empower Annuity Insurance Company (“EAIC”), an affiliate of the Plan’s trustee. Fees paid by the Plan to EAIC for recordkeeping services were approximately \$73,000 and \$67,000 in 2025 and 2024.

Fees paid by the Plan to Merrill Lynch for investment advisory services were \$65,000 and \$58,000 in 2025 and 2024.

Fees paid by the Plan to Smith Leonard PLLC for audit services were approximately \$10,000 in 2025.

### 8. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, “Fair Value Measurements and Disclosures” (“ASC 820”), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

#### ***Basis of Fair Value Measurements***

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

### 8. Fair Value Measurements (Concluded)

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at September 30, 2025 and 2024.

*Mutual funds:* Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 9. Investments at Contract Value

The Empower Investments Fixed Account is a group annuity contract issued by EAIC. The contract seeks to achieve consistent returns that support a competitive crediting rate, that may be updated quarterly. The quarterly crediting rate applies to all money deposited in the contract, regardless of when it was deposited. The minimum crediting rate under the contract is 1.70% at September 30, 2025 and 2024.

The contract is invested primarily in bonds that are diversified across a range of fixed-income asset classes. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value with no restrictions or penalties.

Certain events limit the ability of the Plan to transact at contract value with the issuer, however, the plan administrator does not believe that the occurrence of any such event is probable of occurring.
