## INDEPENDENT AUDITOR'S REPORT

To the Participants and Trustees of the  
Asbestos Workers Savings Plan

### Opinion

We have audited the financial statements of the Asbestos Workers Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of June 30, 2025 and 2024, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The supplemental Schedule of Assets Held at End of Year is supplemental information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended. Supplemental information is the responsibility of the Plan's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTES TO FINANCIAL STATEMENTS

JUNE 30, 2025 AND 2024

#### **NOTE 1. ORGANIZATION AND TAX STATUS**

The Plan was established effective May 1, 2021, pursuant to agreements between International Association of Heat and Frost Insulators and Allied Workers' Local 14 of Philadelphia, PA (Local 14) and certain employers that provides for contributions by employers to a trust fund for the purposes of providing defined contribution retirement, annuity and related qualified benefits to employees of the employers. The Fund is financed by employer contributions as specified in the collective bargaining agreements or pursuant to a participation agreement. The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Participants' Eligibility and Vesting**

An employee, who is engaged in covered employment, shall begin participation in the Plan as of the date he or she first earns one (1) hour of service. Upon attaining participant status, the employee shall be credited with all contributions required to be remitted on the employee's behalf. Each participant shall be immediately vested in his or her account with respect to amounts attributable to the employer contributions based upon the number of hours of service completed. Once vested, the participant's account and all future contributions to such account shall be non-forfeitable.

#### **Participant Accounts**

Contributions to the Plan are invested as directed by the participants in various mutual funds and stable value funds. Participants must evaluate their own investment goals and objectives and choose funds best suited to achieve those goals and objectives. Poor investment performance by the funds selected by the participants may cause their vested balances to be lower than the amounts contributed to the Plan on their behalf.

Each participant's account is credited with an employer's contribution and the participant's earning. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account balance.

#### **NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Method of Accounting** - The financial statements are prepared using the accrual basis of accounting.

## **NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

**Investments and Investment Income Recognition** - Investments in mutual funds are carried at fair value, as provided by the custodian, which generally represents the net asset value of the funds as of the last business day. The investment in the common collective trust - stable value is reported at Net Asset Value (NAV) as reported by the Trust.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Revenue Recognition** - The Plan is funded by contributions from participating employers under the terms of collective bargaining agreements (CBA). Employer contributions are accounted for as exchange transactions. The contributions are due on a monthly basis. It is the policy of the Trustees to pursue monies due.

**Contributions Receivable** - Contributions due and not paid prior to year-end are recorded as contributions receivable. The Plan believes that the receivables are fully collectible; therefore, no allowance for credit losses is recorded.

**Participant Distributions** - Benefit payments to participants are recorded upon distribution.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

## **NOTE 3. PRIORITIES UPON TERMINATION**

It is the intent of the Trustees to continue the Plan in full force and effect. However, in order to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants. In the event of termination, participants would become 100 percent vested in their accounts. In the event the Plan terminates, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will be the opinion of the Trustees brought about to purpose of the Plan.

## **NOTE 4. TAX STATUS**

The Plan has filed its determination letter application with the Internal Revenue Service. The Plan believes it is in compliance with the applicable requirements under Section 401(a) of the Internal Revenue Code and, therefore, exempt from Federal income tax under provisions of Section 501(a). The Plan's administrator and counsel believe the Trust is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

#### **NOTE 4. TAX STATUS (continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, Plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

#### **NOTE 5. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

##### **Basis of Fair Value Measurement:**

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the period.

For the years ended June 30, 2025 and 2024, there were no transfers in or out of levels 1, 2, or 3.

**NOTE 6. FUNDING POLICY**

The Plan is funded by employer contributions as specified in the collective bargaining agreements and participation agreements. The journeyman contribution rates were \$4.50 per hour for the period July 1, 2023 to April 30, 2024, \$6.00 per hour for the period May 1, 2024 to April 30, 2025, and \$7.50 per hour for the period May 1, 2025 to June 30, 2025. The apprentice contribution rates were \$3.00 per hour for the period June 1, 2023 to April 30, 2024, \$4.50 per hour for the period May 1, 2024 to April 30, 2025, and \$6.00 per hour for the period May 1, 2025 to June 30, 2025.

**NOTE 7. RELATED PARTY TRANSACTIONS**

The Plan shares its office facilities, office personnel, equipment, and certain other expenses with the Asbestos Workers Philadelphia Health and Welfare Fund (the Welfare Fund) and the Asbestos Workers Philadelphia Pension Fund (the Pension Fund). The Plan, the Welfare Fund, and the Pension Fund, have common Trustees. Shared administrative expenses are paid initially by the Welfare Fund and are allocated between these entities based on the cost allocation study.

**NOTE 7. RELATED PARTY TRANSACTIONS (continued)**

For the year ended June 30, 2025, the Welfare Fund reimbursed the Plan \$4,098 for Plan's portion of interest and liquidated damages less the Plan's portion of the shared administrative expenses. For the year ended June 30, 2024, the Plan reimbursed the Welfare Fund \$10,730 for the Plan's share of the shared administrative expenses less the Plan's share of interest and liquidated damages. As of June 30, 2025 and 2024, the Plan was owed \$23,733 and \$4,634, respectively from the Welfare Fund.

The Welfare Fund makes payments to the Local 14 Building Fund (the Building Fund) for the use of office space. Rental payments made to the Building Fund during each of the years ended June 30, 2025 and 2024 totaled \$83,688, which is shared between the Plan, the Welfare Fund, and the Pension Fund based on the cost allocation study. The Plan's share of the rent totaled \$1,029 for each of the years ended June 30, 2025 and 2024.

Certain plan investments are shares of mutual funds and stable value funds managed by John Hancock. John Hancock is the custodian and recordkeeper, and, therefore, these transactions qualify as party-in-interest transactions. These transactions have been denoted as such on the supplemental schedule of assets held at end of year.

These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

**NOTE 8. RISKS AND UNCERTAINTIES**

The Plan invests in various investments. Investments are exposed to various risks such as economic, interest rate, market and sector risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 9. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through November 25, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
