NOTE 1. DESCRIPTION OF PLAN

The following description of Tarditi, Inc. 401(k) Profit Sharing Plan (“Plan”) provides only general information. Tarditi, Inc. (“Company”) is a California company. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Company who have completed six months of service. Employees may join the Plan and begin deferring on the first entry date after meeting the eligibility requirements. Plan entry dates are on the first day of each calendar month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to the maximum allowed by law of pretax annual compensation, as defined in the Plan document, into the Plan. Contributions are subject to certain limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

During 2025, the Company made discretionary employer contributions of \$296,141. Company contributions are invested based on the participant’s direction. The Company elected not to make a discretionary profit-sharing contribution for 2025.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Vesting

Participants are immediately vested in their voluntary contributions and employer contributions plus actual earnings thereon.

Investment Options

Upon enrollment in the Plan, a participant may direct all contributions into any of the mutual fund or other investment options the Plan offers or select a portfolio of funds selected by the Plan financial advisor based on an investment policy. Participants may change their investments options daily via the internet after their initial enrollment in the Plan.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's account or periodic payments over the participant's life expectancy. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or elect to leave it in the Plan.

Forfeitures

Amounts forfeited from a participant's account may be used to reduce Company contributions made pursuant to the Plan or to pay reasonable Plan expenses. At March 31, 2025 and 2024, there were no forfeited non-vested account balances.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, of which the Plan has none.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan trustees determine the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the recordkeeping and investment advisor are charged directly to the participants account and are included in contract administrator fees and other fees. All other investment-related expenses are reflected as charges against net appreciation (depreciation) of fair value of investments as not paid directly by the Plan.

Subsequent Events

The Plan has evaluated subsequent events through January 12, 2026, the date the financial statements were available to be issued.

NOTE 4. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements* (“ASC 820”), is the framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at March 31, 2025 and 2024.

Valuation methodologies used are as follows:

The fair values of common stock, corporate bonds, and regulated investment companies aka mutual funds are based on quoted market prices.

Common/collective trust:

The Plan had \$456,479 and \$429,973 as of March 31, 2025 and 2024, respectively, in common/collective trusts. The Trustee has certified the amounts held in the Plan to be complete and accurate. The net asset value of \$1 per unit is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the Plan would sell the investment in the underlying investment for an amount different from the reported net asset value. The common/collective trust can defer payments over a period of time and has ability to pay less than value of \$1 per unit and other restrictions as contained in the Declaration of Trust. The Plan has concluded that the net asset value as adjusted and reported by the issuer of the stable value fund approximates fair value.

It is possible that the redemption rights may be restricted or eliminated in the future. Due to the nature of the investments, changes in market conditions liquidity requirements and the economic environment may significantly affect the net asset value of the target retirement funds and the stable value fund and consequently, the fair value of the Plan's investments.

NOTE 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 6. TAX STATUS

The Plan was amended and restated effective April 1, 2021. The Plan obtained its latest opinion letter on July 13, 2021, in which the Internal Revenue Service stated that the Volume Submitter Prototype Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal and California taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8. RELATED PARTY, PARTY IN INTEREST AND PROHIBITED TRANSACTIONS

The Plan assets are in an omnibus account held by Charles Schwab Bank which is a Trustee, per contract between the Plan and Bank and accordingly transactions with Charles Schwab Bank and affiliated entities qualify as exempt party-in-interest transactions. Charles Schwab Bank received \$4,235 in indirect compensation from the Plan which has been disclosed as required.

Financial Decisions, Inc. is the ERISA 3(38) Advisor and an affiliated corporation, Fred M Lee Corporation dba Financial Decisions, is the record keeper and third party administrator and these entities are party-in-interest. The providers have supplied the Plan required disclosures and the services the vendors provide qualify as exempt party-in-interest transactions. Total direct compensation of fees paid to Fred M Lee Corporation dba Financial Decisions and Financial Decisions, Inc. in 2025 was \$19,304 for recordkeeper fees and \$6,412 for investment manager fees. Investment advisor fees paid to BFC Planning Inc. was \$11,363. These fees have been disclosed as required by Department of Labor regulations. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

The late deposit of certain employee deferrals results in a prohibited transaction. In 2023, deposits of \$5,657 were remitted late, as disclosed in the supplemental schedule of delinquent participant contributions. The Plan corrected lost earnings for these late deposits during the Plan year ended March 31, 2025.
