INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of The GB Group, Inc. Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The GB Group, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of, and for the years ending June 30, 2025 and 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis-of-Matter

Effective July 1, 2025, the Plan merged with Valcourt Building Services, LLC. 401(k) Plan. Additional details discussing the merger are discussed in Note 8.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.

- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1. DESCRIPTION OF PLAN & TRUST

The following description of the GB Group Inc Retirement Plan (Plan) is for general information purposes only. Participants should refer to the Plan document for a more complete description of Plan's provisions.

General – The Plan is a defined contribution 401(k) profit sharing plan covering substantially all employees of The G.B. Group, Inc. (the Company). Employees are eligible to participate in the Plan once they have attained age 21 and completed 1 year of service. The Plan has an open enrollment period, twice a year, for eligible participants. Participants may enter the plan on the first day of July or the first day of January. The Plan is operated in reasonable and good faith compliance with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Each year, participants may defer a percentage of their compensation up to the maximum percentage allowable not to exceed the limits of Code Section 401(k), in the form of pretax elective deferrals. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan sponsor has adopted a safe harbor matching contribution provision whereby the Plan sponsor will make a matching contribution equal to a participant's deferral rate, but not to exceed a maximum of 4% of participant's compensation for the plan year. The Plan sponsor made safe-harbor contributions totaling \$166,377 and \$169,717 for the years ending June 30, 2025 and 2024, respectively. At the plan year end, the Plan sponsor may also make an additional matching employer contribution on behalf of each "eligible" participant limited to 4% of participant's compensation for the plan year. The Plan sponsor elected to not make a discretionary non-elective contribution to participants for the years ending June 30, 2025 and 2024.

Participant Accounts – Each participant's account is credited or debited with (1) the participant's contributions by payroll deduction, (2) the participant's portion of employer matching, (3) an allocation of earnings and losses, (4) any loans made to or repaid by the participant, and (5) an allocation of Plan expenses.

Vesting – Participants are immediately vested in their voluntary contributions, safe harbor contributions and related earnings at all times. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 0 percent vested after one year of credited service and continues to vest in increments of 20 percent until 100 percent vested after six years of credited service. In determining years of service for vesting purposes, years of service attributable to service prior to the effective date of the Plan or a predecessor plan are excluded.

Payment of Benefits – The Plan provides for the payment of benefits to the participant (or, if applicable, the beneficiary) at retirement, death, disability, financial hardship, or termination of employment. In-service distributions of a participant's rollover funds are available at any time. In-service distributions of all vested holdings are also available, providing the participant is at least age 59 1/2. The normal form of payment is a lump sum cash payment. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of a lump sum cash payment or rolled over to an individual retirement account. In addition, the Plan allows for hardship distributions if certain criteria are met. Participants must begin receiving benefits by the year following attainment of age 70-1/2 (participants can defer distribution if actively employed).

Forfeitures – When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures can be used to pay for the administrative fees of the Plan, At June 30, 2025 and 2024, forfeited nonvested accounts had zero balances. No forfeited amounts were used to reduce administrative fees for the years ended June 30, 2025 and 2024, respectively.

NOTE 1. DESCRIPTION OF PLAN & TRUST (Continued)

Participant Investment Options – Participants are allowed to invest in a variety of investment choices as more fully described in the Plan’s literature. Participants may change their allocation on a daily basis.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of fifty percent (50%) of their vested interest or \$50,000, whichever is less. Loans bear a fixed rate of interest determined on the date of the advance by the plan administrator. The loans are secured by the participant's vested account and must be repaid over a term not to exceed 5 years. Principal and interest are paid ratably through payroll deductions. Loans are segregated investments, and to the extent a participant borrows, his or her account will not share in the earnings and gains in value attributable to other plan investments. The interest that participants pay on their loans will be directly credited to their accounts. In the event of default, the unpaid loan principal will be offset against the participant's vested account balance.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting which is in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees determine the Plan’s valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes to participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded when received and credited to the participants' accounts. Related fees are recorded as administrative expenses and are expensed when they are incurred. As of June 30, 2025, and 2024, no allowance for credit losses has been recorded. The Plan has notes receivable from participants outstanding at June 30, 2025, and 2024 of \$0, and \$121,146, respectively, with interest rates between 4.25% and 9.5% per annum on loans outstanding as of June 30, 2024

Payments of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses charged by John Hancock Life Insurance Company are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events – The Plan Administrator has evaluated subsequent events through December 22, 2025, the date the financial statements were available to be issued. Effective July 1, 2025, the Plan merged with Valcourt Building Services 401(k) Plan.

NOTE 3. CERTIFIED INFORMATION

The Plan administrator has elected the alternative method of compliance permitted by Section 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, investment information and notes receivable from participants disclosed in the accompany financial statements and supplemental schedule, including investments held at June 30, 2025 and 2024 and net appreciation (depreciation) in fair value of investments, and interest for the years then ended, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the custodian.

NOTE 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB), *Accounting Standards Codification ASC 820 Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 4. FAIR VALUE MEASUREMENTS (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts: Valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

NOTE 5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by John Hancock Life Insurance Company and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included as a reduction of the return earned on each fund. In addition, redemption fees and check fees are paid from applicable participant accounts to John Hancock Life Insurance Company. Additionally, the Plan issues loans to participants, which are secured by the participant's account balance. These transactions qualify as party-in-interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6. INCOME TAX STATUS

The Plan sponsor has adopted a volume submitter profit sharing plan with a cash or deferral arrangement that received a favorable opinion letter from the IRS on June 30, 2020. The Plan sponsor and administrator believe that the Plan, as amended, is qualified pursuant to the various requirements of the Internal Revenue Code and have indicated that they will take whatever action is required, if any, to maintain the Plan as a qualified plan. Accordingly, they believe that the Plan is a qualified plan and its related trust is exempt from current income taxes.

U.S. GAAP require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. Plan management has determined that no such disclosure is required. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7. PLAN TERMINATION

The Board of Trustees has the right under the Plan document to terminate this Plan subject to the provisions of ERISA. In the event of termination, each participant, retired participant, former participant and beneficiary shall be entitled to receive any amount credited to that person's account.

NOTE 8. MERGER

In 2024, the GB Group, Inc. was brought in as a strategic partner to facilitate growth and expansion for their new parent company, The Valcourt Group. Since the new parent company had an existing pension plan, it was decided that the GB Groups, Inc. 401(k) Plan would merge with the Valcourt Building Services, LLC 401(k) Plan and close.

In June 2025, the Plan assets were transferred from John Hancock Life Insurance Company to Principal, in preparation for the merger, and effective July 1, 2025, the Plan finalized its merger with Valcourt Building Services 401(k) Plan. The vesting schedule for all participant accounts, that were transferred to Valcourt Building Services 401(k) Plan, remained unchanged.

NOTE 9. RISKS AND UNCERTAINTIES

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 10. RECONCILIATION OF THE 5500 TO FINANCIAL STATEMENTS

There were no differences between the information in the separate financial statements and the assets, liabilities, income, expenses, and changes in net assets reported in Schedule H of Form 5500.
