### ***Opinion***

We have audited the financial statements of Security Police Fire Professionals of America and Participating Employers Health and Welfare Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA). The financial statements comprise the statements of benefit obligations and net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in benefit obligations and net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of March 31, 2025 and 2024, and the changes in its net assets available for benefits for the year ended March 31, 2025, in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

### 1. Description of the Plan

The following description of the Security Police Fire Professionals of America and Participating Employers Health and Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### *General*

The Plan is a collectively bargained multiemployer health and welfare plan covering eligible members of the International Union, Security, Police and Fire Professionals of America (SPFPA or the Union) based on collective bargaining agreements between participating employers and the Union. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan is administered by the Board of Trustees (Trustees or Plan Administrator). The Trustees have engaged Lawrence C. Musgrove Associates, Inc. to serve as the Plan's third party administrator (TPA).

#### *Benefits*

The Plan provides health, life, and related benefits through fully insured and self-insured plans for substantially all full-time union members and part-time members, as directed by the Trustees, of participating employers. Management has been advised and maintains that all health care options comply with the requirements of the Affordable Care Act. In certain circumstances, the Plan also provides for contributions to the Union's related 401(k) retirement plan, Security Police Fire Professionals of America Retirement Plan (the Retirement Plan). The Plan does not provide for postretirement benefits.

#### *Employer Contributions*

The Plan is funded primarily by participating employer contributions. Employer contributions are based on collective bargaining agreements in effect between the participating employers and the Union. In certain instances, employer contributions in excess of amounts members have designated to pay for their health and welfare coverage are automatically deposited into 401(k) retirement accounts, which are established for them in the Retirement Plan. The Retirement Plan financial information is excluded from these financial statements.

#### *Employee Contributions*

Certain participating employers offer their employees the option to purchase coverage in excess of that offered by the employer. This additional coverage is paid for through the employer's withholding premiums from the employee and remitting the amounts to the Plan. The Plan also accepts employee pretax 401(k) deferrals from certain participating employers and forwards this money to the Retirement Plan.

### 2. Summary of Significant Accounting Policies

The following is a summary of certain accounting policies followed in the preparation of these financial statements.

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities; and the benefit obligations at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

### ***Cash and Cash Equivalents***

Plan management considers investments with a maturity date of 90 days or less to be cash equivalents.

The Plan maintains its cash account with Comerica Bank and Wells Fargo Bank (the Bank). The amounts are maintained in a fiduciary account and do not become assets or liabilities of the Bank. As a result, should there be a Bank failure, these deposits are secure. Management believes that any risk associated with these deposits is negligible.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Payment of Benefits***

Premiums paid by the plan are recorded as insurance premiums in the accompanying statement of changes in benefit obligations and net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processors.

### ***Rebate Receivable***

Refunds and rebates due from the Plan's pharmacy benefit manager are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$2,809,763 have been netted with claims paid in the accompanying statement of changes in benefit obligations and net assets available for benefits for the year ended March 31, 2025.

### *Claims Settlement and Stop Loss Insurance*

The Plan maintains claims settlement insurance coverage and stop loss insurance to manage its exposure to significant claims. Claims settlement insurance provides protection by reimbursing the Company for claims that exceed a predetermined amount. Premiums for claims settlement insurance are expensed over the coverage period. Stop loss insurance provides protection against catastrophic or unpredictable losses by reimbursing the Company for claims that exceed a predetermined amount. No stop loss have been netted with claims paid in the accompanying statement of changes in benefit obligations and net assets.

Premiums for claims settlement and stop loss insurance are included in premium payments in the accompanying statement of changes in benefit obligations and net assets available for benefits.

### *Contributions and Contributions Receivable*

Employer contributions are recognized in the period during in which participants covered employment is performed. Employee contributions are recognized in the period that employers' make the respective payroll deduction from the participant's compensation. The related contributions receivables represent contributions for the Plan year which had not yet been received as of year-end. All amounts were subsequently collected.

## **3. Benefit Obligations**

Health and other costs incurred by participants are covered by insurance contracts or health reimbursement accounts (HRAs) or are self-insured by the Plan. With respect to the benefits covered by insurance, there are no costs to the Plan other than the insurance premiums payable. There are no retrospective rated policies.

The Plan is primarily self-insured for its medical, dental, and prescription programs; vision programs are fully insured. The self-insured medical plan is administered by Blue Cross Blue Shield of Michigan (BCBSM). The Plan has specific stop-loss protection purchased from BCBSM in the amount of \$750,000. The Plan offers no post-employment or post-retirement coverage other than as required by the Consolidated Omnibus Budget Reconciliation Act (COBRA).

The self-insured dental and insured vision programs are administered by BCBSM. As management feels there is little exposure to catastrophic losses in these programs, no stop-loss protection is in force. The benefit obligations for these programs are limited to the self-insurance payments and insured premiums payable as of March 31, 2025.

Benefit obligations include health claims currently payable, health claims incurred but not yet reported, and premiums payable. Claims paid by the claims processor prior to the year-end that are not reimbursed by the Plan as of year-end are recorded as claims payable and included in claims payable. Premiums not yet paid by the Plan related to coverage at or before year-end are included in premiums due to insurers.

The medical self-insured claims incurred but not reported (IBNR) represent estimates of claims that had been incurred on or before the statement of benefit obligations and net assets available for benefits date but had not been reported or paid by that date. The amounts were primarily estimated by BCBSM. BCBSM uses a computer-based model to estimate IBNR for self-insured accounts claims liability. The model is based on historical claim payment "lag patterns." The pattern of historical

claim payments determines the estimated claims run out for an incurred period. BCBSM uses the most recent data available in determining the group's outstanding liability. In addition, the IBNR projections are based on up to 48 months of data to achieve the statistically valid historical averages.

The following is a summary of the Plan's changes in self-insured claims payable, premiums payable, and claims IBNR:

Any excess of plan obligations over net assets will be funded by future employer and employee contributions.

In October 2018, the Plan was amended to include an HRA. The HRA became effective December 1, 2018 for those participants that were in the self-insured medical plan (BCBSM) on or before May 31, 2018 and continued without break-in coverage through and as of December 1, 2018. The HRA per eligible participant is set at \$1,000 and may be used to reimburse the participant for qualified health care expenses (as defined by the Plan) incurred by the participant for health care of a covered person, as provided by the Internal Revenue Code (IRC). The Trustees terminated the HRA benefit effective February 28, 2021. HRA Claims for periods prior to February 28, 2021 that are still outstanding are \$0 and \$65,417 as of March 31, 2025 and 2024, respectively. For the year ended March 31, 2025, HRA expenses of \$65,417 are included in self-insured claims on the statement of changes in benefit obligations and net assets available for benefit.

#### 4. Fair Value Measurement

GAAP provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under GAAP are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025 and 2024.

*Certificates of Deposit* - Certificates of deposit are valued at cost plus accrued interest, which approximates fair value.

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*U.S. Treasury Obligations* - U.S. Treasury Obligations are valued based on quoted market prices of identical instruments in active markets.

## **5. Income Tax Status**

The Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(C)9 of the IRC, and, accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained a favorable tax determination letter from the Internal Revenue Service (IRS), dated November 6, 2006, and the Plan Administrator believes that the Trust,

as amended, continues to qualify and to operate in accordance with applicable provisions of the IRC. No federal or state income taxes have been recorded in 2024 for unrelated business taxable income. The Plan and Trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the Trust.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS and various states throughout the United States. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 6. Plan Termination

Although the Trustees have not expressed intent to do so, the Trustees may terminate the Plan pursuant to their authority under the trust agreement and the provisions of ERISA. In no event will the termination of the Plan or Trust result in a reversion of any assets to a participating employer. Termination will not result in reversion of trust fund assets to the Union, participants, employers, or dependents. In the event of Plan termination, the fund's assets will be paid out in the form of benefits to its participants and covered dependents and continue to be used to pay reasonable administrative expenses and to distribute and apply remaining surplus as the Trustees so determine, until no assets remain.

### 7. Plan Administrative Expenses

Fees and expenses relating to the administration of the Plan are the responsibility of the Plan. Administrative expenses presented in the statement of changes in benefit obligations and net assets available for benefits consist of the following:

Additionally, administrative fees paid to BCBSM of \$1,842,347 are included as claims settlement expenses and stop-loss insurance premiums on the statement of changes in benefit obligations and net assets available for benefits for the year ended March 31, 2025.

### 8. Party-in-Interest and Related Party Transactions

Certain expenses paid by the Plan are considered party-in-interest transactions. The Plan paid for third-party administrator fees, investment advisory, legal, Plan audit, Trustee travel, and education fees, which qualify as party-in-interest transactions and are exempt from prohibited transaction rules.

The Plan is related to the Retirement Plan through common control. As discussed in Note 1 above, the Plan receives employer and employee contributions on behalf of the Retirement Plan. For the year ended March 31, 2025, the plan had transferred contributions totaling \$14,253,527 to the

Retirement Plan. Any contributions received but not transferred to the Retirement Plan as of the Plan's year end are included in the payable to the Retirement Plan on the statements of benefit obligations and net assets available for benefits. As of March 31, 2025 and 2024, the Plan had collected but not yet remitted \$1,731,219 and \$1,979,652, respectively.

During the year ended March 31, 2024, the Plan and the Retirement Plan hired a Plan director whose salary and benefits are initially paid by the Plan. The Retirement Plan's portion of the expense for the year ended March 31, 2024 was \$71,907 which is included as a receivable on the statement of benefit obligations and net assets available for benefits.

The total amount due from the Retirement Plan as of March 31, 2025 and 2024 is \$0 and \$71,907, respectively.

### 9. Settlements with Participating Employers and Contingencies

In a prior year, the Plan filed suit against Trinity Protection Services, Inc's (Trinity) Chief Executive Officer (CEO), in order to collect the amount unpaid by Trinity. The lawsuit was settled under the following terms, the CEO paid the Plan a lump-sum amount of \$25,000 and required further payments of \$40,000 in installments of \$500 per month beginning in December 2017. For the year ended March 31, 2025, included in additions to net assets attributed to "other income" is \$3,000 relating to this settlement. The outstanding amount from this settlement amount was \$0 and \$3,000 as of March 31, 2025 and 2024, respectively.

Subsequent to Plan year end, the Plan reached a settlement with a former service provider. See Note 11 for further details.

### 10. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of changes in benefit obligations and net assets available for benefits.

As of March 31, 2025 and 2024, respectively, there were one and five investments held, which individually accounted for more than 10% of total investments. See the supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at March 31, 2025.

The Plan's benefit obligations are reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

### 11. Subsequent Events

Subsequent events were evaluated by the Plan's management through January 13, 2026, the date the financial statements were available to be issued. Effective April 1, 2025, the Plan was restated to change the Plan fiscal year end to December 31. In December 2025 the Plan and the Retirement Plan signed a settlement agreement with a former service provider. The Plan initially receives all settlement funds, and then allocates a portion to the Retirement Plan.
