Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2025 Financial Statements

We have performed an audit of the financial statements of Northern Counties Health Care Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of March 31, 2025, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2025 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the banks or similar institutions or insurance carriers in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the year ended March 31, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion on the 2025 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2025 Financial Statements section:

- The amounts and disclosures in the accompanying 2025 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

1. Description of Plan

The following description of Northern Counties Health Care Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a tax-exempt, defined contribution plan sponsored by Northern Counties Health Care, Inc. (the Organization). The Plan was adopted on April 1, 1992 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Variable Annuity Life Insurance Company (VALIC) and VALIC Trust Company, Inc. are the custodians of the Plan.

Eligibility

The Plan is available to all Organization employees for elective deferrals. Employees may begin making elective deferrals to the Plan upon hire. Employees become eligible for the employer match and non-elective contributions on the first day of the calendar quarter after completion of one year of service and attainment of age 18.

Contributions

Each year, eligible employees may make contributions to the Plan through salary deferrals up to 100% of eligible compensation, as defined in the Plan. The maximum amount that a participant may contribute is limited to provisions of the Internal Revenue Code (the Code).

For employees hired prior to April 1, 2011, the Organization matches 1% of eligible compensation if a participant contributes at least 2% of plan compensation. The Organization also makes a 3% discretionary contribution on eligible plan compensation. For employees hired on or after April 1, 2011, the Organization contributes 4% of eligible compensation if a participant contributes at least 2% of plan compensation. These employees are not eligible for the discretionary contribution.

The Plan includes automatic enrollment, where new employees are automatically enrolled to defer 2% of eligible plan compensation. Eligible employees are given a reasonable period to elect a different percentage or elect not to make deferral contributions into the Plan.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contributions and an allocation of plan earnings and losses, and certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. A participant's account shall be reduced by any distributions.

Investments

Upon enrollment in the Plan, a participant may direct his or her account balance among the various investments offered by the Plan. The Plan currently offers investments in various mutual funds and fixed-interest accounts.

Vesting

Participants are immediately vested in their elective deferrals and actual earnings thereon. Vesting in the Organization's contribution portion and actual earnings thereon is based on years of continuous service. A participant hired prior to April 1, 2011 is immediately 100% vested. A participant hired on or after April 1, 2011 vest over a three-year period, with one-third of the total vesting each year.

Forfeitures

Participants who terminate their employment prior to becoming 100% vested forfeit their nonvested account balances. These benefits plus accumulated interest are used to reduce the Organization's contributions to the Plan. There were \$12 and \$1,024 of forfeited nonvested accounts at March 31, 2025 and 2024, respectively. During the year ended March 31, 2025, \$7,835 in forfeitures was used to reduce employer contributions.

Payment of Benefits

Participants shall become eligible to receive their vested account balances upon retirement (normal retirement age is 62), death, disability, or termination. Participants may withdraw their vested account balances upon attaining age 59½. Participants may receive their benefit payments in a single lump-sum payment or a monthly annuity.

Notes Receivable from Participants

Participants may borrow up to \$50,000, subject to certain limitations and vested account balance, as set forth in the Plan document.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for a summary of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances, plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms in the Plan document.

Administrative Expenses

Certain administrative expenses are paid by the Organization; however, certain expenses including investment advisory services and loan administration fees are paid by the Plan.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

Management has considered transactions or events occurring through January 12, 2026, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Fully Benefit-Responsive Investment Contracts

The VALIC Fixed Account Plus, VALIC Short-Term Fixed Account and AIG Fixed-Interest Option (the Contracts) are included in the financial statements at contract value. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The Contracts are in guaranteed fixed-interest accounts. VALIC and AIG maintain the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The guaranteed minimum crediting interest rate is declared periodically with interest credited on a daily basis at an annual effective rate. The plan administrator is not aware of any withdrawal fees or restrictions on the withdrawal of funds from the Contracts upon separation of service; accordingly, these investments are considered to be fully benefit-responsive.

4. Income Tax Status

The Organization has adopted the VALIC Retirement Services Company Volume Submitter 403(b) Plan, which received a favorable advisory letter dated April 5, 2018, from the Internal Revenue Service stating that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the advisory letter. However, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

5. Information Prepared and Certified by Custodians

The investments, notes receivable from participants, investment transactions, net appreciation in fair value of investments, and interest and dividends were obtained by management and agreed to or derived from the information certified by the custodians as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits;
- Statement of Changes in Net Assets Available for Benefits; and
- Schedule H, line 4i - Schedule of Assets (Held at End of Year).

6. Parties-in-Interest

Certain of the Plan's investments and notes receivable from participants are managed by the custodians; therefore, these transactions qualify as party-in-interest transactions. Fees paid to the custodians are reported as administrative expenses on the statement of changes in net assets available for benefits. 7. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The following is a description of the valuation methodologies used for assets measured at fair value at March 31, 2025 and 2024:

Mutual funds are valued using market quotations.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.
