**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Rightway Fasteners, Inc. Retirement Savings Plan (the “Plan”), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering all employees of Rightway Fasteners, Inc. (the “Company”) who have met eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: All employees over the age of 21 are eligible to enter the Plan on April 1 or October 1 following the completion of one year of service.

Contributions: Each year, participants may contribute pre-tax amounts up to the allowable limits established by the Internal Revenue Service. Each participant may direct their contributions and the Company contributions into any of the investment options available under the Plan. The Company has the option to contribute a discretionary matching contribution. For the year ended March 31, 2025, the Company matched 75% of the first 4% of compensation contributed by each participant. A discretionary profit sharing contribution may also be made by the Company without regard to current or accumulated profits. The Company did not make a profit sharing contribution for the year ended March 31, 2025.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and an allocation of (a) the Company’s contributions and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Forfeited Accounts: Forfeited balances of terminated participants’ non-vested accounts shall be used first to pay expenses of administering the Plan and then to reduce Company contributions. For the plan year ended March 31, 2025, \$9,409 of forfeited amounts were used to offset administrative expenses or to reduce employer contributions. At March 31, 2025, there were no forfeited non-vested accounts. At March 31, 2024, forfeited non-vested accounts totaled \$478.

Vesting: Participants are 100% vested in their contributions together with actual earnings thereon. Company contributions and earnings thereon become vested as follows:

<u>Vesting Service</u>	<u>Vesting Percentage</u>
2 years but less than 3	25%
3 years but less than 4	50%
4 years but less than 5	75%
5 years or more	100%

One year of service is earned for every Plan year the participant has at least 1,000 hours of service.

Administrative Expenses: Loan origination fees associated with notes receivable from participants and the Plan’s record keeping and custodian fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by the Company. Administrative expenses paid by the Plan during the year ended March 31, 2025 were \$38,585.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The maximum number of outstanding loans at any given time is one. Loan terms range up to 5 years, with the exception of loans for the purpose of purchasing a principal residence, which shall not exceed 10 years. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits: The Plan provides benefits for retirement, disability, death, or termination of employment. Benefits are payable as lump sums equal to the participant's individual vested account balance. If a participant's employment with the Company is terminated on or after attaining the age of 65, or if employment is terminated at an earlier age because of disability, the participant is entitled to receive 100% of the value of the participant's account. In the event that the termination of employment of a participant is caused by death, the entire amount then in the participant's account shall be paid to the participant's beneficiary. If the participant's employment with the Company is terminated before age 65 for any reason other than death or disability, the participant shall be entitled to an amount equal to the vested percentage of the Company discretionary matching and profit-sharing contributions balance in the participant's account and 100% of the participant's voluntary contributions plus earnings thereon.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through January 13, 2026, which is the date the financial statements were available to be issued.

Effective July 1, 2025, the OSR, Inc. 401(k) Plan merged into the Plan. In August 2025, approximately \$744,000 (unaudited) of plan assets, including participant notes receivable, were transferred to the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting and have been prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes therein, and disclosure of the contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties: The Plan provides for investment in various securities. Investment securities are exposed to various risks, such as interest rate, market, liquidity, and credit risks. Due to level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to change in valuation assumptions, it is reasonably possible that changes in the fair values of investment securities will occur or will continue to occur in the near term and that such changes could materially affect participants' account balances reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value, as more fully disclosed in Note 3. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Termination of the Plan: Although it has not expressed intent to do so, the Company has the right to discontinue its contributions and terminate the Plan subject to the provisions of ERISA. In the event the Plan is discontinued, the Plan's assets will be distributed to participants in accordance with the Plan's provisions and subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in all portions of their accounts.

**NOTE 3 - FAIR VALUE MEASUREMENT**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. The effect of a change in valuation technique or its application on a fair value estimate is accounted for prospectively as a change in accounting estimate. When evaluating indications of fair value resulting from the use of multiple valuation techniques, the Plan is to select the point within the resulting range of reasonable estimates of fair value that is most representative of fair value under current market conditions. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. Transfers between hierarchy measurement levels are recognized by the Plan as of the actual date the event or change in circumstances that caused the transfer.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

**NOTE 3 - FAIR VALUE MEASUREMENT (Continued)**

*Exchange Traded Funds and Mutual Funds:* The fair values of exchange traded fund investments and mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Collective Trust Fund:* The fair value of participation units held in a collective trust is based on the net asset value per unit as reported by the manager. The collective trust provides for daily redemptions by the Plan at reported net asset value per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 - CERTIFIED INFORMATION**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at March 31, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends for the year ended March 31, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Mid Atlantic Trust Company, the trustee of the Plan.

Participant loans of \$396,236 and \$396,331 as of March 31, 2025 and 2024, respectively, and investment income of \$26,541 earned during the year ended March 31, 2025 was not certified.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Mid Atlantic Trust Company is the Plan custodian and, therefore, the Plan's payment of custodian fees to Mid Atlantic Trust Company qualifies as a party-in-interest transaction. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. In addition, at March 31, 2025 and 2024, the Plan had party-in-interest transactions in the form of notes receivable from participants of \$396,236 and \$396,331, respectively.

**NOTE 6 - TAX STATUS**

The Internal Revenue Service issued an opinion letter dated March 31, 2014 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 31, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2023.
