## **INDEPENDENT AUDITOR'S REPORT**

To the Trustees of  
Hart Howerton 401(k) Profit Sharing Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Hart Howerton 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

### NOTES TO FINANCIAL STATEMENTS

MARCH 31, 2025

#### **1. Description of Plan**

The following brief description of the Hart Howerton 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General** -- Hart Howerton, Ltd. (the "Company") established the Plan on October 1, 1982. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The following are companies that are eligible to participate in the Plan under a controlled group, which is considered a single employer plan:

- Hart Howerton, Ltd.
- Hart Howerton Partners, Ltd.

**Eligibility** -- The Plan covers generally all active employees of the Company and its participating subsidiaries not covered by a collective bargaining agreement, non-resident aliens who receive no compensation from the companies which constitutes U.S. source income, and interns and contract assistants. Employees are eligible to participate in the Plan starting from the first day of next month following date of hire. Newly hired employees who have met the eligibility requirement are automatically enrolled in the Plan with a default deferral rate of 4% of their eligible compensation.

**Contributions** -- A participant may contribute up to 100% of his/her annual salary, not to exceed \$23,500 and \$23,000 during the calendar years 2025 and 2024, respectively. The annual base salary for purposes of the Plan is limited by the Internal Revenue Code (the "Code") to \$350,000 and \$345,000 during the calendar years 2025 and 2024, respectively. A participant may also rollover amounts representing distributions from other qualified contribution plans. A participant aged 50 and older is permitted to make an additional catch-up deferral contribution up to \$7,500 during the calendar years 2025 and 2024.

During the years ended March 31, 2025 and 2024, the Company made discretionary profit sharing contributions based on six percent of the employees' eligible compensation, subject to any applicable limitation by the Code. The Companies may also match a discretionary (matching) contribution amount. During the years ended March 31, 2025 and 2024, the Companies did not elect to make any matching contributions.

**Administration of the Plan** -- The Company is the plan sponsor, as defined by ERISA. The trustees are the fiduciaries responsible for the general operation and administration of the Plan as well as the management and control of Plan assets. Empower Annuity Insurance Company of America and Empower Trust Company, LLC (“Empower I”) are the asset custodians and Empower Retirement, LLC “Empower II”, a subsidiary of Empower Annuity Insurance Company of America, is the recordkeeper of the Plan. Blue Ridge Associates is the third-party administrator and is responsible for compliance testing and Form 5500 reporting. Empower II is responsible for recordkeeping and processing of certain administrative functions such as participant loans and benefit disbursements. The participants of the Plan pay certain administrative expenses relating to their loans and benefit disbursements. Certain investment options and service providers rebate a portion of fees to the Plan in the form of revenue-sharing credits. These credits are used to pay or reduce eligible Plan administrative and investment advisory expenses. In accordance with U.S. GAAP, revenue-sharing credits are recorded as reductions of the related expenses, and investment income is presented net of investment expenses in the accompanying financial statements. During the plan year ended March 31, 2025, the Plan applied approximately \$59,026 of revenue-sharing credits to reduce such expenses.

**Trustees** – The Plan is administered by three trustees appointed by the Company’s board of directors. The trustees are officers and/or shareholders of the Company.

**Participant Accounts** -- The Plan credits the participants’ deferral contribution accounts with the participant’s elective salary reduction amount, the Company contribution amount (employer match and/or profit sharing contributions, as applicable), and an allocation of the Plan’s net earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Employees are eligible for employer contributions if they are 21 years of age and have attained one year of service.

Participants are immediately vested in their elective deferral contributions plus actual earnings thereon. The participant’s vesting in the Company’s contribution portion of their accounts plus earnings thereon is based on years of continuous service as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

**Forfeitures** -- Nonvested portions of a participant's account balance will be forfeited when the participant receives a distribution of the entire vested benefits or when the participant incurs five consecutive one-year breaks in service. The forfeited amounts are transferred to a forfeiture account until they are used to reduce future employer non-elective contributions or administrative expenses. Forfeitures available to reduce future employer contributions and expenses were \$8,711 and \$1,824 as of March 31, 2025 and 2024, respectively. Also, administrative expenses were reduced by \$9,649 from forfeited nonvested accounts during the plan year ended March 31, 2025.

**Payment of Benefits** -- On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons and hardship as defined in the Plan, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**Notes Receivable from Participants** -- Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of 4.25 to 8.50 percent, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through automatic payroll deductions. The outstanding loans will mature from May 2026 to November 2032.

## **2. Summary of Significant Accounting Policies**

**Basis of Accounting** -- The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of Estimates** -- The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investments Valuation and Income Recognition** -- Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 5 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** -- Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of March 31, 2025 and 2024, respectively. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits** -- Benefits are recorded when paid.

**Expenses** -- Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. As noted above, certain investment related expenses are offset against net appreciation in fair value of investments.

**Financial Investments with Off-Balance Sheet Risk** -- The Plan held no direct investments in derivatives as of and during the plan years ended March 31, 2025 and 2024.

### **3. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **4. Guaranteed Investment Contract**

The Plan entered into benefit responsive investment contracts with Empower Annuity Insurance Company of America ("EAICA") called the Empower Investments Fixed Account Series V and Guaranteed Portfolio Fund, totaling \$1,659,194 and \$1,481,391 as of March 31, 2025 and 2024, respectively. EAICA maintains the contributions in a general account for both investment contracts. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0 percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The average yield earned by the Plan adjusted to reflect the actual interest rate credited to plan participants was 2.44% and 1.28% in 2025 and 2024, respectively.

On December 16, 2024, all underlying assets of the Guaranteed Portfolio Fund were allocated to the Empower Investments Fixed Account Series V.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuers to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

## **5. Fair Value Measurements**

The framework measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025 and 2024:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

## 6. Related Party and Party In Interest Transactions

Certain Plan investments are managed by Empower I. During the plan year ended March 31, 2025, the Plan paid \$16,114, \$9,650 and \$6,000 to Empower Advisory Group LLC, investment advisor and subsidiary of Empower Annuity Insurance Company of America, Mah & Associates LLP, plan auditor, and Blue Ridge Associates, third party plan administrator, respectively. These transactions qualify as party in interest transactions.

## **7. Summary of Information Certified By Custodian**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of March 31, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the plan year ended March 31, 2025, were obtained by management and agreed to or derived from information certified by Empower I, a qualified institution and the custodian of the Plan.

## **8. Income Tax Status**

The Internal Revenue Service stated in an advisory letter dated June 30, 2020 that the Prototype Standardized Profit-Sharing Plan with CODA (the prototype plan of Crowe LLP Volume Submitter 401(k) Profit Sharing Plan upon which the Plan is based) is acceptable under Section 401(a) of the Code and the related trust is, therefore, not subject to tax under present income tax law. Although the Plan has been amended since receiving the advisory letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or any other tax agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **9. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants will become 100% vested in their employer contributions.

## **10. Subsequent Events**

In July 2025, the Company made corrective qualified nonelective contributions ("QNEC") totaling \$70,844 for operational issues identified by the DOL during their routine review of the audit working papers for the plan year ended March 31, 2023. The QNEC contributions included \$2,484, \$5,849, \$310, \$1,031, and \$61,170 for the plan years ended March 31, 2019, 2020, 2021, 2022, and 2023, respectively. In addition to the DOL findings, the Plan Sponsor also identified operational issues and made QNEC contributions for the plan years ended March 31, 2024 and 2025 in the amount of \$3,377 and \$5,369, respectively.

The Plan's management evaluated subsequent events through January 13, 2026, the date on which the financial statements were available to be issued and except as discussed above, noted no other subsequent events which would have an impact on the Statements of Net Assets Available for Benefits and the related Statements of Changes in Net Assets Available for Benefits or require disclosure in the notes to financial statements.
