## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of  
The Rosedale Products, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Rosedale Products, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024 and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Rosedale Products, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 31, 2025 and 2024, and for the year ended March 31, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Qualified Opinion

In our opinion, except for the possible effects of the matters discussed in the Basis for Qualified Opinion section of our report, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements Section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Qualified Opinion**

As more fully described in Note 11 to the financial statements, the Plan did not maintain appropriate documentation for hardship distributions and participant deferral changes that were made during the year, consequently, we were unable to determine whether any adjustments were necessary.

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Rosedale Products, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter**

As described in Note 6, to the financial statements, the Plan has certain compliance errors with respect to the Plan.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Rosedale Products, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibility for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**1. DESCRIPTION OF PLAN**

Rosedale Products, Inc. and Rosedale Filter Components, LLC adopted a standardized form Sentry Life Insurance Company prototype plan that was effective April 1, 1989. The Plan was restated as of April 1, 2021 and subsequently amended on August 1, 2022 and April 1, 2024.

The following description of the Rosedale Products, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions and restrictions.

a. General

The Plan is a defined contribution plan covering all full-time employees of the companies who have six months of service, are age twenty or older and have accumulated five hundred hours of service or have one year of service with one thousand accumulated hours. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Benefits provided by the Plan are not insured by the Pension Benefit Guaranty Corporation.

b. Contributions

Participants are eligible to contribute a percentage of pretax compensation, as defined by the Plan. Participants as well as after tax compensation, who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 100% of the first 3% of base of compensation that a participant contributes to the Plan. Company matching contributions for the year ended March 31, 2025 and 2024 were \$166,758 and \$158,994, respectively.

c. Participant accounts

Each participant's account is credited with the participant's elective salary deferral, the Company's matching contribution (if applicable) and plan earnings. Allocations of income are based on participants' account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The allocation of forfeitures is based upon individual participant compensation in proportion to the total compensation of all participants.

d. Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after 6 years of credited service and upon death or disability.

e. Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either installments or a lump-sum amount equal to the value of the participant's vested interest in his or her account.

f. Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan bears interest at a rate commensurate with local prevailing rates. Notes receivable from participants at March 31, 2025 and 2024 are \$304,680 and \$326,340, respectively.

g. Forfeited accounts

Any forfeited accounts will be used to reduce plan expenses or are allocated as additional discretionary nonelective contributions. At March 31, 2025 and 2024, there were \$7,518 and \$14,477, respectively, in forfeited accounts. Forfeitures used to cover the profit sharing contributions for March 31, 2025 and 2024 were \$2,436 and \$11,041, respectively.

**2. SUMMARY OF ACCOUNTING POLICIES**

a. Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

b. Investment valuation and income recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net appreciation or depreciation in the fair value of investments consists of the realized gains or losses and the unrealized appreciation or depreciation of those investments.

The units of pooled separate accounts are stated at fair value as determined by issuer of the account based on the net asset value of the underlying investments, as a practical expedient. Individual participant accounts invested in the pooled separate accounts are maintained on a unit value basis. The Plan's guaranteed investment contract with Sentry is valued at contract value.

c. Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

d. Payment of benefits

Benefits are recorded when paid.

e. Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the trustees to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**2. SUMMARY OF ACCOUNTING POLICIES(CONTINUED)**

f. Events occurring after reporting date

The Plan has evaluated events and transactions that occurred between March 31, 2024 and January 12, 2026, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

**3. INFORMATION CERTIFIED BY PLAN CUSTODIAN**

Plan management elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Sentry Life Insurance Company, the Custodian of the Plan, has certified the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for Benefits as of March 31, 2025 and 2024, and the supplemental Schedule H, Line 4i – Schedule of Assets (held at end of year), as of March 31, 2025; and the related investment activity reflected in the statement of changes in net assets available for benefits for the years ended March 31, 2025.

**4. INVESTMENTS AND FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques – Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025 and 2024.

Pooled Separate Accounts – Pooled separate accounts are valued at the net asset value (“NAV”) or equivalent based on units of the pooled separate accounts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

In accordance with fair value measurement guidance, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The following table sets forth additional disclosure of the Plan’s investments whose fair value is estimated using net asset value per share (or its equivalent) as of March 31, 2025:

**5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan participates in the Sentry Guaranteed Income Fund (GIF), which by definition is considered to be a guaranteed investment contract, or GIC. The contract is an insurance company issued general account backed group annuity contract. There are not any specific securities in the general account that back the investments in this account and interest rate is determined annually. All transactions are at contract value. In certain instances, when total distributions or transfers in the GIF within a twelve-month period exceed pre-determined thresholds, transactions in the GIF may face certain restrictions and market adjustments, in accordance with contract terms. This could potentially result in the GIF not being fully benefit-responsive in certain instances.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to guaranteed investment contract. Contract value as reported to the Plan by Sentry, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their account balances at contract value.

The Plans ability to receive amounts due is dependent on the issuers ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**6. TAX STATUS**

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is exempt from income taxes. Sentry Life Insurance Company obtained a favorable tax determination letter from the Internal Revenue Service on March 5, 1993, March 31, 2008, March 31, 2014 and June 30, 2020 for the prototype plan. The Plan had several amendments since the last tax determination letter, and the Plan sponsor believes that the Plan continues to qualify and to operate as designed.

The Plan administrator has identified certain compliance issues with respect to the Plan, including late employee deferral remittances and limited documentation to support loans, hardships, participant opt-outs, and deferral elections. In addition, the Plan has historically treated bonuses as fringe benefits and excluded bonuses from compensation when calculating all contributions made to the plan. The Pan received a legal opinion that based on the Plan terms, law, guidance, and analysis, and the Plan administrator's consistent practices, the Plan has permissibly excluded bonuses from Plan compensation. The Plan sponsor believes that the Plan continues to qualify and to operate as designed. Subsequent to year end, the Plan was amended to explicitly exclude bonuses from compensation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits

As discussed in Note 5, the recoverability of the Plan's investment in the insurance contract is dependent upon the financial condition of Sentry. The Plan's investments are subject to fluctuations in value depending on the value of the underlying securities in the pooled separate accounts.

**8. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of any termination of the Plan, the accounts of each affected participant shall become fully vested.

**9. PROHIBITED TRANSACTIONS**

During the current and previous plan years, the plan sponsor failed to remit to the plan's trustee certain employee contributions totaling \$1,255,152 within the period prescribed by the Department of Labor regulations. Delays in remitting contributions to the trustee were due to administrative errors, and the plan sponsor will make contributions to the affected participants' accounts to compensate those participants on aggregate of approximately \$1,056 for potential lost income due to the delays.

**10. RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS**

The Plan invests in pooled separate accounts and a GIF managed by Sentry Life Insurance Company. Sentry Life Insurance Company is the trustee, custodian and record-keeper of the Plan. Certain Plan investments are managed by Sentry Investment Management, Inc., a wholly owned subsidiary, and therefore, these transactions qualify as party-in-interest transactions. Certain administrative fees related to the administration of the Plan were paid by the Plan or the Plan sponsor. These transactions qualify as party-in-interest transactions.

**11. PLAN DOCUMENTATION**

The Plan allows for hardship distributions for immediate and heavy financial need of its participants with written certification by the participant certifying that he or she has insufficient cash or other liquid assets reasonably available to satisfy the need. During the year ended March 31, 2025, \$29,795 in hardship distributions were made by the Plan without written certification by the participant, consequently, we were unable to determine whether any adjustments were necessary. Additionally, during the year, certain participant deferral election changes were processed without maintaining complete supporting documentation as required by the Plan. As a result, the auditors' were unable to verify the accuracy and completeness of these changes.
