### Note 1: Description of Plan

The following description of the U.S. Tsubaki Holdings, Inc. Collectively Bargained and Hourly Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering union and certain non-union employees of U.S. Tsubaki Holdings, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Eligibility

Eligible employees include employees covered under the collective bargaining agreement and certain non-union employees who are age 21 or older and have completed one year of service. Employees of the Company who have completed one year of service and are age 21 or older are eligible for Company matching contributions and non-elective contributions as of the first day of the following month after meeting eligibility requirements.

#### Contributions

Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan. Participants may also contribute up to 10% of after-tax compensation. Contributions are not to exceed the maximum amounts allowed by the Internal Revenue Services (IRS). Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company contributes 50% of the first 6% of base eligible compensation that a participant contributes to the Plan at U.S. Tsubaki Automotive, LLC (Automotive Division) and at U.S. Tsubaki Power Transmission, LLC (Roller Chain). The Company contributes 25% of the first 6% of base eligible compensation that a participant contributes to the Plan at Central Conveyor Company LLC. In addition, the Company makes a non-elective contribution for eligible participants equal to 4% of a participant's eligible compensation for the Roller Chain and Automotive Division participants. The participants at Central Conveyor Company LLC do not receive a non-elective contribution.

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contribution, the Company's contributions, and allocations of Plan earnings (losses), and charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. A participant's account may be transferred to/from the U.S. Tsubaki Holdings Inc. Retirement Plan at anytime, based on a change of employment status.

#### Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings (losses) thereon. Vesting in the Company's contributions are based on years of continuous service. Participants vest in Company contributions and earnings (losses) thereon on a six year vesting schedule.

#### Notes Receivable From Participants

Notes receivable from participants are loans made to participants from their account balance. Participants may borrow from their account balance a minimum of \$1,000, up to a maximum equal to the lesser of one-half of the participant's vested account balance or \$50,000 reduced by the highest outstanding loan balance in their account during the prior twelve month period. The notes are secured by the balance in the participant's account and bear interest at the Prime rate plus 1.5%. Principal and interest is paid ratably through payroll deductions.

#### Payment of Benefits

Benefits are paid to the participant or beneficiary upon death, disability, retirement or termination of employment, up to the amount of the participant's vested interest in their account. Benefits may be paid in a lump sum distribution or installments if the account balance is greater than \$7,000. If the participant's vested account balance does not exceed \$7,000 but is greater than \$1,000, the Plan administrator will pay an involuntary cashout distribution as a direct rollover to an individual retirement plan. Vested balances less than \$1,000 can be distributed only in a single lump-sum payment. Distributions may be deferred until the participant reaches the age of 70 1/2, providing the account balance is greater than \$7,000. In-service distribution are also permitted, as defined in the Plan document. In addition, hardship distributions from the participant's vested account balance are permitted if certain criteria are met.

#### Forfeitures

As of March 31, 2025 and 2024, forfeited nonvested accounts totaled \$8,256 and \$5,838, respectively. These accounts will be used to reduce future Company contributions and pay Plan administrative expenses. During the year ended March 31, 2025, Company contributions were reduced by \$57,227 and \$17,429 of administrative expenses were paid from forfeited nonvested accounts.

#### Administrative Expenses

Certain expenses are absorbed by the Company, while others are paid by participants out of Plan assets. Certain investment management fees are included in net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustees, and insurance company. See Note 6 for details on inputs, valuation techniques, and fair value measurement level within the fair value hierarchy.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **SECURE 2.0 Act of 2022**

The SECURE 2.0 Act of 2022 (SECURE 2.0), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provisions to elect in the future.

#### **Subsequent Events**

Subsequent events have been evaluated through January 12, 2026, which is the date the financial statements were available to be issued.

### **Note 3: Tax Status**

The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator is not aware of any significant uncertain tax positions taken by the Plan.

### **Note 4: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

### **Note 5: Information Certified by the Trustee of the Plan**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held as of March 31, 2025 and 2024, and net appreciation in fair value of investments, interest, and dividends for the year ended March 31, 2025, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by John Hancock Trust Company LLC, the Trustee of the Plan.

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of March 31, 2025 and 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of March 31, 2025 and 2024. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

### Note 7: Investments at Contract Value

The Plan holds an investment with an insurance company that is comprised of a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings (losses), less participant withdrawals and administrative expenses. The contract value of the investment was \$10,564,538 and \$9,206,084 at March 31, 2025 and 2024, respectively.

The investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. No events are probable of occurring that might limit the ability of the plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

### Note 8: Party-in-Interest Transactions

Certain Plan investments include an insurance contract managed by New York Life Insurance Company as of March 31, 2025 and 2024. New York Life Insurance Company is an affiliate of New York Life Trust Company who was acquired by John Hancock Trust Company LLC. Therefore, these transactions qualify as exempt party-in-interest transactions. Fees incurred and paid by the Plan for the investment management services were \$122,087 for the year ended March 31, 2025.

Notes receivable from participants are also considered party-in-interest transactions. These transactions are not considered prohibited under 29 CFR 408(b) of the ERISA regulations.

### Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
