Note 1. Description of the Plan

General

The following description of True Blue Car Wash LLC 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by True Blue Car Wash, LLC (Plan Sponsor) for the benefit of its employees who have completed 480 hours of service in the three consecutive months following their date of employment are age 18 or older. Entry dates are on the first day of the quarter after eligibility requirements are met. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Ascensus is the trustee of the Plan. Vanguard serves as the custodian of the Plan.

Plan Transfers

Effective October 9, 2023, the Plan merged into the Circle K Retirement Plan. The Circle K Retirement Plan was amended at this time to include special vesting provisions in which True Blue Car Wash employees will follow the prior employer's vesting schedule while included within the Circle K Retirement Plan.

The remaining footnotes describe the Plan prior to the effective date of the Plan merger.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Plan Sponsor make annual contributions of up to 100% of their eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan Sponsor makes matching contributions of 50% of employees' salary deferral amounts on the first 6% of employees' compensation and profit-sharing contributions. Profit-sharing contributions are discretionary as determined by the Plan Sponsor's management. No profit sharing contributions were made during the period from January 1, 2023 through October 9, 2023. Contributions are subject to certain limitations.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Plan Sponsor's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferral contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account is based on years of continuous service. A participant becomes 33% vested in Company contributions at one year of service, 66% vested at two years of service, and fully vested after three years of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes will be secured by the vested balance in the participant's account and bear interest at a rate equal to the prime rate, as specified by the Wall Street Journal.

Principal and interest are paid ratably through payroll deductions. Effective October 9, 2023, \$1,638 of notes receivable were transferred to the Circle K Retirement Plan.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account.

Forfeited Accounts

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures can be used to reduce the Plan Sponsor's contributions to the Plan. At December 31, 2022, forfeited nonvested accounts total approximately \$720. On October 9, 2023, approximately \$40 of forfeitures were transferred to the Circle K Retirement Plan as part of the plan merger.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Plan Sponsor or the Plan, at the Plan Sponsor's discretion.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of October 9, 2023 and December 31, 2022
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the period January 1, 2023 through October 9, 2023

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

Note 4. Related-Party and Party-in-Interest Transactions

Although party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of mutual funds managed by Ascensus Trust Company. Ascensus Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan Sponsor provides certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques through October 9, 2023, the date the Plan merged. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan has no Level 2 or Level 3 securities.

Note 6. Plan Termination

The Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of a termination of the Plan, participants will become 100% vested in their accounts.

As described in Note 1, effective October 9, 2023 the Plan merged into the Circle K Retirement Plan. The plan merger does not constitute a plan termination and participants will continue to receive benefits in the merged plan.

Note 7. Tax Status

The Plan adopted the Ascensus, LLC Non-Standardized Pre-Approved Profit Sharing plan document which received an opinion letter from the Internal Revenue Service on June 30, 2020, which stated that with the Non-Standardized Pre-Approved Profit Sharing plan document is designed in accordance with the applicable sections of the Code. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes the Plan is being operated in compliance with the applicable tax-exempt requirements of the Code and, therefore, believes that the Plan, as adopted and amended, is qualified and the related trust is tax exempt. Therefore, no provision for taxes is included in the Plan's financial statements.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.


