1. Plan Description

The following description of the Proponent 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan's provisions.

General

Proponent, Inc. (formerly Kirkhill Aircraft Parts Co.), or the "Company", established the Plan effective as of April 1, 2008. The Plan is a defined contribution plan covering all employees who have completed one month of service and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to defer a portion of their compensation, pursuant to a salary reduction agreement, to be contributed to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting Provisions

Under the Plan, participant accounts are 100% vested at all times.

Benefit Provisions

Benefit provisions allow participants to receive the vested portion of their accounts as a single lump sum payment, in installments, or as an annuity.

Notes Receivable from Participants (Participant Loans)

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or fifty percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 5.25% to 10.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through bi-weekly payroll deductions. Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' interests would become fully vested and distributed in accordance with Plan provisions.

2. Significant Accounting Policies

Accounting Method

The financial statements of the Plan are prepared using the accrual basis of accounting.

Valuation of Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value of investments.

The unallocated general account fund contract contains provisions for surrender charges and market value adjustments for dispositions prior to the maturity date of the contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits expense is recognized when benefits are paid.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of net assets and disclosure of contingent assets and liabilities, if any, at the date of the financial statements and the reported amounts of increases and decreases in net assets during the reporting period. Actual results could differ from those estimates.

Operating Expenses

The plan sponsor absorbs significant administrative costs that have not been recorded in these financial statements.

Subsequent Events

Management has evaluated the impact of all subsequent events through January 13, 2026, which was the date the financial statements were available to be issued.

3. Tax Status

The Plan adopted a prototype plan sponsored by an insurance company. The insurance company obtained a favorable determination letter from the IRS dated June 30, 2020. The plan has been amended since receiving the determination letter. However, the plan administrator and the plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax positions that are more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of significant other observable inputs, and Level 3 inputs are unobservable and have the lowest priority. The plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 and Level 2 inputs were not available.

Level 1 Fair Value Measurements

The fair value of the pooled separate accounts is based on quoted net asset values of the accounts.

Level 3 Fair Value Measurements

Unallocated General Account Fund: The guaranteed investment contract with an insurance company is not actively traded and significant other observable inputs are not available. Thus, the contract is classified as Level 3. 6. Certification of Assets

Principal Life Insurance Company (“Principal”) serves as the trustee and custodian of the Plan’s assets. In that capacity, Principal holds the Plan’s assets and executes investment transactions. The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulation for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). As permitted under such election, the Plan administrator has obtained certifications from Principal as of March 31, 2025 and 2024, and for the year ended March 31, 2025, that all investment information supplied to the Plan is complete and accurate. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at March 31, 2025 and 2024, and interest, dividends and net appreciation in fair value of investments for the year ended March 31, 2025, was obtained or derived from the certified information.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

8. Party-in-Interest Transactions

The Plan has investments in insurance contracts managed by Principal Life Insurance Company. Principal Life Insurance Company is the custodian of the Plan; therefore, Principal Life Insurance Company is a party-in-interest.

9. Plan Merger

During the year the board of directors of the plan sponsor approved the merger of the Del Rey Capital 401(k) plan into the plan. Assets from the Del Rey Capital 401(k) plan were transferred subsequent to year end.
