### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Plumbers Local Union No. 16 Defined Contribution Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended March 31, 2025 and 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### 1. Description of Defined Contribution Plan

---

The following description of the Plumbers Local Union No. 16 Defined Contribution Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution plan that was established June 2, 1999. The Plan covers all employees (including self-employed persons, sole proprietors or employees owning any interest in an employer, or sharing in the profits and losses of an employer or business organization which is a contributing employer, provided it is approved by the trustees) who (a) work within the trade and territorial jurisdiction of the Plumbers Local Union No. 16 (the “Local 16”) for a contractor signatory to the collective bargaining agreement between Local 16 and the Mechanical Contractors Association of Omaha, Inc. or such other collective bargaining agreements with Local 16 or its affiliates for work performed within the territorial jurisdiction of Local 16, or (b) are employed by Local 16. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### ***Contributions***

Each employee may elect to contribute a portion of their gross compensation (“compensation reduction election”), on a pre-tax basis, as an amount per hour in \$0.50 increments, not to exceed \$9.50 per hour, or if age 50 or older before December 31 of the current Plan year, the maximum contribution will be \$12.50 per hour. Effective January 1, 2026, the Plan was amended to provide for after-tax Roth salary deferral contributions.

Participants may change their compensation reduction elections twice per year. Changes can be submitted between May 1<sup>st</sup> and May 15<sup>th</sup> and between November 1<sup>st</sup> and November 15<sup>th</sup>. The elections are effective the first day of the following month.

#### ***Participant Accounts***

Each participant’s account is credited with the participant’s elective contribution and an allocation of Plan earnings (losses). Administrative expenses are charged equally to participant’s account. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The investments are maintained in individual member accounts managed by Principal Trust Company (“Principal”).

#### ***Vesting***

At any point in time, all participants are 100% vested in their account balance.

#### ***Participant Loans***

No loans are permitted under the Plan to any participant.

### ***Payment of Benefits***

A participant shall be eligible to receive benefits under the Plan upon termination of service due to death, disability or retirement. A participant may elect to receive his benefit under one of the following methods:

- a) Lump-sum payment
- b) Installment payments, either monthly, quarterly or annually, over a period not to exceed the life expectancy of the participant, or
- c) A direct rollover of an eligible rollover distribution
- d) Hardship distributions
- e) Force out distributions

### ***Basis of Presentation***

The accompanying financial statements of the Plan have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting - Defined Contribution Pension Plans*.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### ***Participant Contributions Receivable***

Contributions receivable are presented at the net realizable value of contributions attributable to the Plan as of year-end not yet remitted as determined by Plan management which approximates fair value.

### ***Investment Valuation and Income Recognition***

Investments, except for fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. Principal determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 4 for further discussion of fair value measurements.

Fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts through a guaranteed interest account.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Deposits with Insurance Company***

The Principal Guaranteed Option investment, which is part of the investment contract with Principal, credits interest daily. The crediting interest rate as of March 31, 2025 and 2024 for the contract was 4.85% and 1.90%, respectively. The crediting interest rates are reset upon the maturity of the contracts.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Other***

Audit and legal fees, insurance, investment management expenses, rent and allocable expenses described in Note 5, and fees of any benefit consulting firms are paid by the Plan and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees and costs associated with maintaining accounts of participants are charged to those participants' accounts.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Subsequent Events***

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through January 6, 2026. See Note 1 for a description of a subsequent event.

### 3. Investments Certified by Principal

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Principal, the custodian, except for comparing such information certified by the custodian to information included in the Plan’s financial statements and supplementary information.

### 4. Fair Value Measurements

FASB ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The framework gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methodologies used as of March 31, 2025 and 2024.

*Interest Bearing Bank Account:* Valued at the fair value due to the short-term nature of this instrument.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### 5. Allocable Expenses

---

The Plumbers Local Union No. 16 Pension Plan is administered through an administration office. Various expenses incurred by the administrative office, known as “allocable expenses”, have been divided between the Plumbers Local Union No. 16 benefit funds in the proportion to the funds’ activity. The amount of expenses allocated to the Plan for each of the years ended March 31, 2025 and 2024, was \$3,000, which is included in Administrative Expenses. As of March 31, 2025 and 2024, the Plan owed \$9,000 and \$6,000, respectively.

### 6. Investment Contract with Insurance Company

---

The Plan has entered into an investment contract with Principal. Principal maintains the contributions in mutual funds and a guaranteed interest account. The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Principal.

The mutual funds, as reported to the Plan by Principal, are included in the financial statements at fair value (which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses).

As the guaranteed interest account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest account. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due in accordance with the investment contract is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic developments. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

### 7. Tax Status

---

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to March 31, 2022.

### 8. Plan Termination

---

Although it has not expressed any intent to do so, the Local 16 has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distribution of account balances to participants would be made as soon as practicable after the termination date.

### 9. Related-Party Transactions

---

The guaranteed interest account and the interest bearing bank account are managed by Principal and First National Bank of Omaha (FNBO), respectively. Principal and FNBO are custodians as defined by the Plan, therefore these transactions qualify as party-in-interest transactions.
