Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1: PLAN DESCRIPTION

The following description of 1st Kids, Inc. 403(b) Plan (the Plan), is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Summary Plan Description.

General: The Plan is a custodial account under Code 403(b)(7), established April 1, 2008. The Plan is sponsored by 1st Kids, Inc. (the Employer) for the benefit of its employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Employees are eligible to participate in the Plan on their date of hire. Those employees who work less than twenty hours per week are excluded from the Plan. Participants may elect to contribute to the Plan the maximum amount of annual compensation prescribed under the Internal Revenue Code. The employer may elect to make a discretionary matching contribution to the Plan. Participants are eligible to receive the employer match if they are a minimum age of 21 and have obtained a service requirement of one year. Once a participant becomes eligible to receive the match, they will begin receiving the employer match on a monthly entry date. During the years ended March 31, 2025 and March 31, 2024, the employer contributed 2% of each participant's eligible compensation. The employer also made an additional discretionary contribution of \$335,568 and \$-0- for the years ended March 31, 2025 and March 31, 2024, respectively. This amount was included in employer contributions in the statements of net assets available for benefits as of March 31, 2025 and March 31, 2024.

Participant Accounts: Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's discretionary matching contributions and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are fully vested in all contributions to the Plan, which consists of deferrals, match, and rollover contributions.

Plan Benefits: The benefits to which a participant is entitled are the benefits that can be provided from the participant's individual accounts. Benefits are payable upon retirement or upon total and permanent disability, employment termination, or death. Hardship withdrawals are permitted under the Plan from employee contributions only. The Plan allows for hardships to be taken for a participant's primary beneficiary. The Plan states that any withdrawal will first be taken from a participant's Roth deferral account and then from a participant's pre-tax deferral account.

Plan Termination: Although it has not expressed any intent to do so, the employer has the right to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their accounts.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Significant accounting policies followed by the Plan are listed below:

Basis of Accounting: The accompanying financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See subsequent note for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan follows Financial Accounting Standards Board's (FASB) Accounting Standard Codification (ASC) 2018-13, *Fair Value Measurements* (Topic 820): *Disclosure Framework - Changes to the Disclosure Requirements for Fair Value Measurements*. ASC 2018-13 streamlines the disclosure requirements within Accounting Standards Codification (ASC) Topic 820.

Receivables: The Plan follows FASB ASC 326, *Measurement of Credit Losses on Financial Instruments*. The standard requires recognition of an allowance that reflects a current estimate of credit losses expected to be incurred over the life of the asset. As of March 31, 2025 and March 31, 2024, there were no allowances for uncollectible receivables for either year end.

Risks and Uncertainties: The Plan provides for certain investment options. Investment securities are exposed to various risks, such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America ("GAAP") requires management and the Plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in investment income.

Presentation: Certain March 31, 2024 items have been reclassified to conform to the March 31, 2025 presentation.

The Plan's investments in a money market fund, mutual funds, and an annuity contract (including investments bought, sold, and held during the year) reported investment income of \$180,922 and \$392,865 for the years ended March 31, 2025 and March 31, 2024, respectively. Investment income includes interest, dividends, and net appreciation (depreciation) in fair value of the Plan's investments.

Note 4: FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liabilities;
- Inputs that are derived principally from or corroborated by observable market data by correlation of other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments, apply to investments held directly by the Plan.

Mutual funds and money market fund: The fair values of mutual funds and the money market fund are determined by obtaining quoted prices on nationally recognized securities exchanges (level 1 inputs).

Annuity contract: The fair market value for the fixed contract is equal to the book value less any contingent deferred sales charge (CDSC). The contract does not currently have a CDSC.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: ANNUITY CONTRACT

The Plan is invested in a fixed contract annuity called Best of America Fixed Contract. The fair value of the investment contract at March 31, 2025 and March 31, 2024 was \$133 and \$100, respectively, and is included in investments at fair value in the accompanying statements of net assets available for benefits. The fixed interest rate for 2025 was 2.62% and for 2024 the fixed rate was 2.28%.

Deposits are guaranteed in both principal and interest by Nationwide Life Insurance Company's general account and are credited on a net daily basis at annual effective rates. The contract is not fully benefit responsive. The fixed contract does not have a maturity date.

Note 6: TAX STATUS

Individually designed 403(b) plans currently are not required to submit plans to the Internal Revenue Service for determination. However, the Plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to examinations for a period of three years from the date the Form 5500 is filed.

Note 7: PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. All professional fees for the administration and audit of the Plan are paid by the Plan or the Employer. Fees paid by the Plan during the years ended March 31, 2025 and March 31, 2024, for the services rendered by parties-in-interest, as defined by ERISA, were based on contractual rates for their service.

The Plan invested in an annuity contract managed by Nationwide Trust Company, FSB as of March 31, 2025 and March 31, 2024, and as such, these investments qualify as party-in-interest investments.

Note 8: INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide Trust Company, FSB has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of March 31, 2025 and March 31, 2024, Note 3, and the supplemental Schedule H, line 4i - Schedule of Assets Held for Investment Purposes as of March 31, 2025; and the related investment activity reflected in the statement of changes in net assets available for benefits for the years ended March 31, 2025 and March 31, 2024.
