### **Report on the Audit of the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of Pacific Coast Building Products, Inc. Profit Sharing Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of March 31, 2025, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2025 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended March 31, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

## Notes to Financial Statements

---

### (1) Description of Plan

The following description of the Pacific Coast Building Products, Inc. Profit Sharing Retirement Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### (a) *General*

The Plan is sponsored by Pacific Coast Building Products, Inc. (Employer) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a defined contribution plan which provides for retirement, disability and death benefits for substantially all nonunion employees of the Employer. Employees, other than certain employees hired as a result of an asset acquisition, who have worked 1,000 hours or more within a consecutive twelve month period commencing on their anniversary hiring date or, thereafter, commencing on the first day of each plan year, are eligible to participate in the Plan.

#### (b) *Contributions*

The Employer has agreed to make a minimum annual contribution equal to 5% of the eligible compensation as defined in the Plan document of all participants that are eligible. The approved contribution for the year ended March 31, 2025 was 8% of eligible compensation. Participants may direct his or her account balance into participant directed accounts which may be invested in mutual funds, money market funds currently offered under the Plan and may change their investment options at any time.

#### (c) *Participant Accounts*

Individual accounts are maintained for each of the Plan's participants as well as the participant's share of the Plan's income (loss) and any related administrative expenses. Allocations are based on participant compensation or account balances, as defined. Life insurance policies purchased on behalf of participants are held by the Plan and the increase in the cash surrender value of the policies and the premium expenses are allocated to the respective participants' accounts. As of April 1, 2013, the Plan no longer allows participants to purchase life insurance policies to be held in the Plan. Policies held as of April 1, 2013 by the plan will be maintained in the Plan, subject to the provisions of the Plan document. Participants with life insurance policies held in their individual account or who have terminated or otherwise become excluded participants can elect to maintain a policy, subject to the provisions of the plan document, or surrender a policy for its cash surrender value. If a participant does not make an election, the policy will be surrendered for the cash surrender value on the policy premium due date following the date the participant was terminated or became an excluded employee.

#### (d) *Vesting and Forfeitures*

A participant is 100% vested after three years of credited service or upon death, total disability or attainment of normal retirement age, as defined. Forfeitures of terminated participants' nonvested amounts are used to offset employer contributions. There were \$394,000 and \$595,000 of unallocated forfeitures as of March 31, 2025 and 2024, respectively. There were no forfeitures used during the plan year to reduce the Employer's contribution. Subsequent to the Plan's year end, \$500,000 was used to reduce the 2025 employer's contribution.

#### (e) *Distributions to Participants*

The benefit to which a participant is entitled is the participant's account valued as of the date of distribution. Upon retirement, as defined, or total and permanent disability, a participant may generally elect to receive a lump sum distribution, an annuity, or a combination of these options. In the event of a participant's death, his or her designated beneficiary will be paid in accordance with the terms of the beneficiary designation form.

**(f) Plan Administration**

The Plan is administered by the Administrative Committee and each member of this Committee was appointed by the Board of Directors of the Employer.

**(2) Significant Accounting Policies**

**(a) Method of Accounting**

The Plan's financial statements are prepared on the accrual basis of accounting.

**(b) Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**(c) Risks and Uncertainties**

Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**(d) Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value except for its investments in life insurance policies which are stated at contract value (cash surrender value) as provided by the insurance companies. Money market funds are valued at the closing price reported on the active market on which the individual securities are traded. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

Purchases and sales of investments are reported on a trade date basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes gains and losses on investments bought and sold, as well as held during the year. Interest income is recognized on the accrual basis.

**(e) Fair Value Hierarchy**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10, *Fair Value Measurement* provides guidance for measuring the fair value of assets and liabilities. The objective of a fair value measurement is to determine the price that would be received when selling an asset or paid when transferring a liability. The guidance outlines a fair value hierarchy that gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.
- Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.
- Level 3 - Prices or valuations that require inputs that are both significant to their fair value measurement and unobservable.

**(f) Benefits**

Benefits paid to participants are recorded as deductions from net assets available for benefits when approved and paid by the Plan.

**(g) Administrative Expenses**

Administrative expenses incurred by the Plan are allocated to each participant account based on participant account balances.

**(h) Date of Evaluation – Subsequent Events**

Management has evaluated subsequent events through January 13, 2026 the date on which the financial statements were available to be issued. No subsequent events requiring disclosure existed as of this date.

**(3) Investments**

Trust Company d/b/a Voya Institutional Trust Company (Voya), the trustee of the Plan, have supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of March 31, 2025 and 2024, the statement of changes in net assets available for benefits for the year ended March 31, 2025, and the supplemental schedule of assets (held at end of year) as of March 31, 2025.

**(4) Party-In-Interest Transactions**

Money market funds held by the Plan are managed by Voya, and, as such, transactions in these funds qualify as party-in-interest transactions. Any purchase or sale of these funds are open market transactions at fair market value, and as such, are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

The Plan's investment advisor, SageView Advisory Group, LLC. (SageView), is responsible for selecting and monitoring the investment offerings of the Plan. SageView fees are paid by the Plan.

The Company provides certain accounting and administrative services for which no fees are charged.

**(5) Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue employer contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**(6) Income Tax Status**

The Internal Revenue Service issued its latest opinion letter in June of 2020 which stated that the Plan and its underlying trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, management believes that the Plan's current design and operation is in compliance with the applicable requirements of the Internal Revenue Code and ERISA, and the trust which forms a part of the Plan, is exempt from income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan was restated as of April 1, 2022, and the Plan administrator believes that the Plan continues to be designed and operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 31, 2025, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Profit Sharing Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of March 31, 2025, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

**(1) Description of Plan**

The following description of the Pacific Coast Building Products, Inc. Profit Sharing Retirement Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**(a) General**

The Plan is sponsored by Pacific Coast Building Products, Inc. (Employer) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a defined contribution plan which provides for retirement, disability and death benefits for substantially all nonunion employees of the Employer. Employees, other than certain employees hired as a result of an asset acquisition, who have worked 1,000 hours or more within a consecutive twelve month period commencing on their anniversary hiring date or, thereafter, commencing on the first day of each plan year, are eligible to participate in the Plan.

**(b) Contributions**

The Employer has agreed to make a minimum annual contribution equal to 5% of the eligible compensation as defined in the Plan document of all participants that are eligible. The approved contribution for the year ended March 31, 2025 was 8% of eligible compensation. Participants may direct his or her account balance into participant directed accounts which may be invested in mutual funds, money market funds currently offered under the Plan and may change their investment options at any time.

**(c) Participant Accounts**

Individual accounts are maintained for each of the Plan's participants as well as the participant's share of the Plan's income (loss) and any related administrative expenses. Allocations are based on participant compensation or account balances, as defined. Life insurance policies purchased on behalf of participants are held by the Plan and the increase in the cash surrender value of the policies and the premium expenses are allocated to the respective participants' accounts. As of April 1, 2013, the Plan no longer allows participants to purchase life insurance policies to be held in the Plan. Policies held as of April 1, 2013 by the plan will be maintained in the Plan, subject to the provisions of the Plan document. Participants with life insurance policies held in their individual account or who have terminated or otherwise become excluded participants can elect to maintain a policy, subject to the provisions of the plan document, or surrender a policy for its cash surrender value. If a participant does not make an election, the policy will be surrendered for the cash surrender value on the policy premium due date following the date the participant was terminated or became an excluded employee.

**(d) Vesting and Forfeitures**

A participant is 100% vested after three years of credited service or upon death, total disability or attainment of normal retirement age, as defined. Forfeitures of terminated participants' nonvested amounts are used to offset employer contributions. There were \$394,000 and \$595,000 of unallocated forfeitures as of March 31, 2025 and 2024, respectively. There were no forfeitures used during the plan year to reduce the Employer's contribution. Subsequent to the Plan's year end, \$500,000 was used to reduce the 2025 employer's contribution.

**(e) Distributions to Participants**

The benefit to which a participant is entitled is the participant's account valued as of the date of distribution. Upon retirement, as defined, or total and permanent disability, a participant may generally elect to receive a lump sum distribution, an annuity, or a combination of these options. In the event of a participant's death, his or her designated beneficiary will be paid in accordance with the terms of the beneficiary designation form.

**(f) Plan Administration**

The Plan is administered by the Administrative Committee and each member of this Committee was appointed by the Board of Directors of the Employer.

Benefits paid to participants are recorded as deductions from net assets available for benefits when approved and paid by the Plan.

**(g) Administrative Expenses**

Administrative expenses incurred by the Plan are allocated to each participant account based on participant account balances.

**(h) Date of Evaluation – Subsequent Events**

Management has evaluated subsequent events through January 13, 2026 the date on which the financial statements were available to be issued. No subsequent events requiring disclosure existed as of this date.

**(3) Investments**

Trust Company d/b/a Voya Institutional Trust Company (Voya), the trustee of the Plan, have supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of March 31, 2025 and 2024, the statement of changes in net assets available for benefits for the year ended March 31, 2025, and the supplemental schedule of assets (held at end of year) as of March 31, 2025.

**(4) Party-In-Interest Transactions**

Money market funds held by the Plan are managed by Voya, and, as such, transactions in these funds qualify as party-in-interest transactions. Any purchase or sale of these funds are open market transactions at fair market value, and as such, are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

The Plan's investment advisor, SageView Advisory Group, LLC. (SageView), is responsible for selecting and monitoring the investment offerings of the Plan. SageView fees are paid by the Plan.

The Company provides certain accounting and administrative services for which no fees are charged.

**(5) Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue employer contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**(6) Income Tax Status**

The Internal Revenue Service issued its latest opinion letter in June of 2020 which stated that the Plan and its underlying trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, management believes that the Plan's current design and operation is in compliance with the applicable requirements of the Internal Revenue Code and ERISA, and the trust which forms a part of the Plan, is exempt from income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan was restated as of April 1, 2022, and the Plan administrator believes that the Plan continues to be designed and operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 31, 2025, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
