## INDEPENDENT AUDITOR'S REPORT

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures related to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain other internal control-related matters that we identified during the audit.

***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental Schedule of Assets Held at End of Year is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **NOTES TO FINANCIAL STATEMENTS JUNE 30, 2025 AND 2024**

#### **(1) Plan Description**

The following description of Youth & Family Services, Inc. Retirement & 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

#### **General and Eligibility**

The Plan is a defined contribution plan established for the benefit of the employees of Youth & Family Services, Inc. (the Agency) formed on January 1, 1989. The Plan and the trust of which it is a part are intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees of the Agency who have completed one year of service (1,000 hours) and have attained the age of 18 are eligible to participate in the Plan. Plan entry is offered semi-annually.

#### **Nature of Operations**

The Agency operates various programs serving youth and families in the western counties of South Dakota.

#### **Contributions**

Participants may either defer a percentage of their pretax compensation or make Roth contributions, subject to certain limitations established by the Plan and the Internal Revenue Service (IRS). Participants may roll over amounts representing distributions from other qualified defined benefit or contribution plans. The Agency contributes a matching contribution of 50 percent of the first 3 percent of base compensation that a participant contributes to the Plan. The Plan also provides for discretionary contributions by the Agency, as determined annually by the Board of Directors. The Agency made a discretionary profit-sharing contribution totaling \$182,946 and \$181,618 for the years ended June 30, 2025 and 2024, respectively.

The Plan allows Roth contributions. Contributions to Roth 401(k) accounts are made on an after-tax basis. Future distributions of Roth elected contributions and earnings thereon will not be taxed, if certain criteria are met. Roth elective deferrals to the Plan are permanently designated as Roth elective deferrals in participant accounts. Participants' Roth deferrals and gains and losses attributable to such deferrals are accounted for separately.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Agency's contributions, Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined.

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in the Agency's matching and discretionary contributions based on years of credited service. A year of credited service is defined as 1,000 hours worked by a participant within a plan year. A participant is 20 percent vested after two years of service, as defined, and continues to vest at the rate of 20 percent for each successive year of service until they are 100 percent vested after six years of service, or if less than six years, upon reaching normal retirement age or termination of the Plan.

#### **Forfeitures**

At June 30, 2025 and 2024, forfeited nonvested accounts totaled \$11,473 and \$14,411, respectively. These balances will be used to reduce future employer contributions and administrative expenses. During the year ended June 30, 2025, the Plan's employer contributions and administrative expenses were reduced by \$2,870 and \$9,991 from forfeited nonvested accounts, respectively.

#### **(1) Plan Description**

##### **Investment Options**

Participants direct their account balance to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options and terminate contributions at any time throughout the year.

##### **Participant Notes Receivable**

The Plan does not allow participant loans.

##### **Payment of Benefits**

Benefit payments are made as soon as administratively feasible following the date on which a distribution request is made or is otherwise payable. Upon termination of service for any reason, a participant or their beneficiary may receive a lump-sum distribution equal to the value of the participant's vested interest in their account balance. If no election is made upon termination of employment, distributions between \$1,000 and \$5,000 are deposited into an individual retirement account, benefits less than \$1,000 are paid in one lump sum as soon as administratively feasible.

##### **Subsequent Events**

The Plan has evaluated events through January 8, 2026, the date at which the financial statements were available to be issued.

#### **(2) Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

##### **Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts and disclosures reported in the financial statements. Actual results may differ from those estimates.

##### **Risks and Uncertainties**

The Plan provides for various investment options. Investments are exposed to various risks, such as interest, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

##### **Investment Valuation and Income Recognition**

Shares of mutual funds are valued at fair value, as determined by the Capital Bank and Trust Company (the Trustee), which represent the net asset value of shares held by the Plan at year end (Notes 4 and 7). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **(2) Summary of Significant Accounting Policies**

##### **Payment of Benefits**

Benefits are recorded when paid.

#### **(3) Plan Termination**

Although it has not expressed any intent to do so, the Agency has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their entire account.

#### **(4) Investments – Information Certified by Trustee**

Capital Bank and Trust Company (the Trustee) holds the Plan's investments, executes investment transactions, and performs all related accounting functions.

In accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the Plan Administrator has received certification from the Trustee as to the accuracy and completeness of certain financial information of the Plan as of June 30, 2025 and 2024 and for the year ended June 30, 2025. The Trustee has certified information contained in the following:

Statements of Net Assets Available for Benefits (except for contributions receivable)  
Statement of Changes in Net Assets Available for Benefits (except for contributions, benefits paid to participants, and administrative expenses)  
Supplemental Schedule of Assets Held at End of Year

Market volatility of equity-based investments may substantially impact the value of such investments at any given time. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. It is possible that the value of the Plan's investments, both in total and in individual participant accounts, has changed significantly since June 30, 2025.

#### **(5) Income Tax Status**

Effective April 7, 2021, the Plan adopted a non-standardized form of a prototype plan sponsored by American Funds Distributors, Inc. This prototype plan has received an opinion letter from the Internal Revenue Service (IRS) as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the determination letter, however, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code (IRC). Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **(6) Participant Withdrawals**

Vested, undistributed account balances of separated Plan participants totaled approximately \$1,704,000 and \$1,566,000 as of June 30, 2025 and 2024, respectively.

**(7) Recurring Fair Value Measurements**

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

Fair value measurements are framed in a three level hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

- Level One: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level Two: Inputs to the valuation methodology include
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level Three: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

No liabilities are measured at fair value on a recurring basis. The following table presents the assets carried at fair value in the accompanying Statements of Net Assets Available for Benefits by fair value hierarchy. All investments are measured at fair value on a recurring basis.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**(8) Related Party Transactions**

Fees for legal and professional services rendered to the Plan may be paid by the Agency at its discretion. Certain Plan investments are shares of mutual funds which are managed by Capital Bank and Trust Company.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
