INDEPENDENT AUDITOR'S REPORT

To the Hunton Andrews Kurth LLP Retirement Program Investment Committee:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Hunton Andrews Kurth LLP Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of March 31, 2025 and 2024, and for the year ended March 31, 2025, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Auditor's Responsibilities for the Audit of the Financial Statements, Continued:

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of March 31, 2025, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

1. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements of the Hunton Andrews Kurth LLP Retirement Savings Plan (the Plan) have been prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and Fidelity Management Trust Company (the Trustee, or Fidelity).

Securities traded on national securities exchanges are valued at the last reported sales price on the last day of the Plan year.

The Plan presents, in the statement of changes in net assets available for benefits, the "gain on investments", which consists of the realized gains and losses and the unrealized appreciation or depreciation on investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants, deemed to be in default by the plan administrator, are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments

Benefit payments to participants are recorded when paid.

1. Summary of Significant Accounting Policies (continued)

Risks and Uncertainties

The Plan's assets are invested in various financial instruments, including stocks, common/collective trusts, money markets, cash, fixed income securities and mutual funds. Investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the financial statements.

2. Description of Plan

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan that is intended to constitute a qualified profit-sharing plan under section 401(a) of the Internal Revenue Code of 1986, as amended (the Code). The Plan is sponsored by Hunton Andrews Kurth LLP (the Firm), and the assets of the Plan are held by Fidelity Management Trust Company (Fidelity), a third-party Trustee. Fidelity is also the recordkeeper for the Plan.

Through March 31, 2025, the Plan was administered by the Hunton Andrews Kurth LLP Benefits Committee, members of which were appointed by the Firm's Executive Committee. Effective April 1, 2025, the Plan is administered by the Hunton Andrews Kurth LLP Retirement Program Investment Committee (the "Investment Committee"), members of which are appointed by the Firm's Executive Committee.

Participant Contributions

Partners, counsel, associates and staff employees who work or are expected to work at least 1,000 hours during the year are eligible to make 401(k) contributions. Part-time employees who worked at least 500 hours during the prior fiscal year are eligible to make 401(k) contributions. Other than certain eligible partners, foreign nationals working in non-U.S. offices are not eligible.

2. Description of Plan (continued)

Eligible participants may make 401(k) contributions to the Plan in specified amounts of their compensation, including a portion of any bonuses or matrix payments received, up to a maximum of \$23,500 for calendar year 2025 and \$23,000 for calendar year 2024. Participants who have attained age 50 may also make catch-up 401(k) contributions of up to a maximum of \$7,500 for calendar years 2025 and 2024. Participants ages 60-63 as of December 31, 2025 may make super catch-up 401(k) contributions of up to a maximum of \$11,250 for calendar year 2025. Participants may elect traditional pre-tax 401(k) contributions, after-tax Roth contributions, or a combination thereof. For administrative purposes, the maximum percentage of compensation that can be contributed each pay period is limited to 50% for regular 401(k) deferrals and 50% for catch-up 401(k) deferrals with a combined limit of 75%.

Participants direct the investment of their contributions into various investment options offered by the Plan, including 8 mutual funds, 13 common/collective trusts, and a brokerage account. The brokerage account is a self-directed vehicle, which allows participants to invest up to 99% of their vested accounts in individual stocks, bonds, and a broad array of mutual funds.

Firm Contributions

Counsel and staff employees who work at least 1,000 hours during the year, become eligible for Firm contributions as of the April 1 or October 1 after one year of service. Partners of the Firm who work or are expected to work at least 1,000 hours during the year become eligible for Firm contributions as of the April 1 or October 1 after joining the Firm.

Generally, foreign nationals working in a non-U.S. office and associates are not eligible for Firm contributions.

Firm contributions are allocated as of the last valuation date of the Plan year on behalf of eligible participants who are employed by the Firm on the last day of the Plan year or staff employee and partner participants who died or became disabled during the Plan year, and staff employee participants who retired during the Plan year. Firm contributions are allocated in a manner intended to comply with Section 401(l) of the Code. The minimum allocation of Firm contributions on behalf of staff employee participants and non-highly compensated counsel participants is 7.5% of earnings (as defined by the Plan), and the allocation to highly-compensated counsel participants is 5.6% of earnings (as defined by the Plan).

Profit sharing contributions for partners equal approximately 5% of earnings (as defined by the Plan) plus 5% of earnings in excess of the FICA wage base in effect on the first day of the Plan year.

Firm Contributions (continued)

All Firm contributions are participant directed. Forfeitures are used to reduce Firm contributions during the year the forfeiture occurs. Forfeitures were \$165,443 for the Plan year ended March 31, 2025. Forfeitures of \$395,000 were applied to Firm contributions for the Plan year ended March 31, 2025. The remaining available forfeiture balance was \$5,225 at March 31, 2025 and \$234,782 at March 31, 2024.

Additional Partner Contributions

In addition, the following amounts are allocated as an age-weighted contribution to partners' Profit Sharing accounts based on each partner's age on the last day of the Plan year:

When added to the maximum 401(k) contribution for the year, the total contribution allocation for a partner who is 50 or older totals an amount not to exceed \$70,000 for the Plan year ended March 31, 2025.

Investments

All investments in the Plan are participant directed.

Vesting

Participants are at all times fully vested in their accounts attributable to participant salary deferral contributions and Firm Basic contributions under the Plan. Participants who have a total and permanent disability, die, or reach normal retirement age while in the service of the Firm have a fully-vested, nonforfeitable interest in their Profit Sharing accounts. Otherwise, participants become fully vested in their Profit Sharing accounts after three years of continuous service.

2. Description of Plan (continued)

Payment of Benefits

The normal retirement age is 62; however, the Plan allows for early retirement at age 55 if the participant has 20 years of credited service. Benefit payments represent the balance in the participant's account which may be paid out at the participant's direction in a lump sum, installment payments or partial distributions.

Notes Receivable from Participants

Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum of the lesser of \$50,000 less the participant's highest outstanding loan balance during the previous 12 months, or 50% of vested benefits, exclusive of the participant's deductible account.

Notes receivable from participants carry repayment terms not to exceed five years unless the proceeds of the loan are used to purchase a primary residence in which case repayment is not to exceed 15 years. Notes receivable from participants are secured by the balance in the participant's account and bear interest at prime plus 2%, and are repaid through payroll deductions.

Expenses

Expenses of administering the Plan, including recordkeeping, custodial, and investment management expenses, are paid from Plan assets. Other expenses of administering the Plan may be borne by the Firm; however, there were none for the year ended March 31, 2025.

3. Fair Value Measurements

The Financial Accounting Standards Board (FASB) has issued guidance for measurement and disclosure of fair value and established a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology are quoted prices for similar instruments in active and inactive markets; and model driven valuations with significant inputs and drivers derived from observable active markets.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement. There were no assets or liabilities whose fair value was determined using Level 3 inputs at March 31, 2025.

3. Fair Value Measurements (continued)

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments carried or disclosed at fair value:

Common/collective trusts: Valued at the net asset value (“NAV”) of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (“SEC”). These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at the cash balance.

BrokerageLink accounts: Accounts primarily consist of stocks, mutual funds, and money market instruments that are valued on the basis of readily determinable market prices, and fixed income securities which are valued based on available information through processes such as benchmarking curves, benchmarking of like securities, sector grouping, and matrix pricing.

The valuation methodologies described above may generate a fair value calculation that may not be indicative of net realizable value or future fair values. While the Plan believes the valuation methodologies used are appropriate, the use of different methodologies or assumptions in calculating fair value could result in different amounts.

4. Investments

All investment information disclosed in the accompanying financial statements, including investments held at March 31, 2025 and 2024, and net realized and unrealized change in the fair value of investments, and interest and dividends for the year ended March 31, 2025, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Trustee, a qualified institution.

Fidelity Management Trust Company, the trustee of the Plan, has certified that the following information is complete and accurate as of and for the year ended March 31, 2025 and 2024:

- Investments, at fair value
- Interest and dividends
- Gain on investments
- Notes receivable from participants
- Interest on notes receivable from participants
- Schedule of assets (held at end of year)

5. Plan Termination

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become fully vested in their accounts.

6. Income Tax Status

The Plan has received a determination letter from the Internal Revenue Service dated June 13, 2020, stating that the Plan, as designed, is qualified under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the determination letter. However, the plan administrator and tax counsel believe the Plan is designed and continues to be operated in compliance with the applicable requirements of the Code and, therefore, believe the Plan is qualified and the related trust is tax exempt.

Management has evaluated the effects of accounting guidance related to uncertain tax positions and concluded that the Plan has no significant financial statement exposure to uncertain income tax positions at March 31, 2025 or 2024. The Plan is not currently under audit by any tax jurisdiction.

7. Parties-in-Interest

A substantial portion of the Plan's assets are invested in funds sponsored by affiliates of Fidelity, the Plan's Trustee. Transactions involving these investments, including notes receivable from participants, are considered to be party-in-interest transactions for which statutory exemption exists under the Department of Labor's Rules and Regulations.

8. Subsequent Events

Management has evaluated subsequent events through January 13, 2026, the date the financial statements were available for issuance, and has determined that there are no subsequent events to be reported in the accompanying financial statements.
