Opinion

We have audited the accompanying financial statements of ROBERTS OXYGEN COMPANY, INC. 1. ORGANIZATION AND PURPOSE

Roberts Oxygen Company, Inc. Health Care Plan and Trust (HCPT) provides for the direct payment of benefits to and for the employees of Roberts Oxygen Company, Inc. (the Employer) and their eligible dependents from a special trust fund set aside for this purpose. This trust fund maintains the HCPT's assets and is administered by Allegiance Benefit Plan Management, Inc. as contract administrator under a trust agreement revised as of July 1, 1996, as amended. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The HCPT prepares its financial statements on the basis of cash receipts and disbursements. As such, contributions are recorded when received rather than when earned. Benefits, insurance premiums, and administrative expenses are recognized when paid rather than when the obligations are incurred.

Estimates

The HCPT prepares its financial statements on the basis of cash receipts and disbursements. As such, no estimates are used in the preparation of the financial statements. However, the benefit plan obligation disclosure (NOTE 5) involves the use of estimates. Actual results could differ from the estimates used in that disclosure.

Cash and Cash Equivalents

The term cash, as used in the accompanying financial statements, includes currency on hand, demand deposits with financial institutions, and short-term, highly liquid investments purchased with a maturity of three months or less. The HCPT has not experienced any losses in such accounts. The HCPT believes it is not exposed to any significant risk with regards to cash and cash equivalents.

The following summarizes the Company's cash in excess of federally insured limits which is not specifically collateralized:

Income Taxes

The HCPT is exempt from federal income taxes under section 501(c)(9) of the Internal Revenue Code and has received a favorable determination letter. Consequently, no provision for income taxes has been provided in the accompanying financial statements. The HCPT obtained its latest determination letter in August 2007, in which the Internal Revenue Service stated that the HCPT, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The HCPT has been amended since receiving the determination letter, including amendments to remain compliant with Federal ACA Regulations. However, the HCPT administrator and the HCPT's tax counsel believe that the HCPT is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the HCPT was qualified and was tax-exempt as of the financial statement date.

The HCPT adopted the provisions of FASB ASC 740, Accounting for Uncertainty in Income Taxes, which requires that a tax position be recognized on a 'more-likely than-not' threshold. This applies to positions taken or expected to be taken in a tax return. Accounting principles generally accepted in the United States of America require HCPT trustees to evaluate tax positions taken by the HCPT and recognize a tax liability (or asset) if the HCPT has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The implementation of FASB ASC 740 had no impact on the HCPT's audited financial statements. The HCPT does not believe their financial statements include (or reflect) any uncertain tax positions. The HCPT is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

3. CONTRIBUTIONS

The employer and employees contribute amounts monthly for the employees and their dependents who are members of the HCPT at a rate which is sufficient to pay reported claims and other expenses when due. Contributions for the years ended March 31, 2025 and 2024 consisted of the following:

While it has not expressed any intention to do so, the Employer has the right under the HCPT to discontinue such contributions at any time and to terminate the HCPT subject to provisions set forth in ERISA. In the event the HCPT is terminated, reasonable notice of such discontinuance shall be given to all participating employees as to the date that such benefits and contributions shall cease. After the date of termination, no liability under the HCPT shall attach to the Employer except for payment of benefits as provided by the terms of the HCPT.

4. BENEFITS

The HCPT pays for specified medical procedures and treatments considered necessary for the well-being of the covered person. Full-time employees and directors of the Employer become eligible for participation on the first of the month following 60 days of continuous full-time employment. The participant may elect to cover their spouse and any children under twenty-six years of age. The termination of coverage does not apply to unmarried handicapped children who are dependent upon the covered employee for support and maintenance. Participation ends on the earliest of HCPT termination or the last day of the calendar month the covered person is no longer in an eligible class or terminates employment.

Payment of benefits is based on predetermined amounts as specified by the HCPT. The HCPT pays for 100% of all eligible network medical expenses after satisfaction of a \$200 deductible per covered person (up to a maximum of two deductibles per family) per calendar year. Eligible non-network medical expenses are paid at a benefit percentage of 80% after satisfaction of a \$400 deductible per covered person (up to a maximum of two deductibles per family) per calendar year.

4. BENEFITS (CONTINUED)

Out-of-pocket maximum charges correspond with the deductibles for in-network eligible medical expenses. Non-network out-of-pocket maximum charges are \$1,000 per covered person per benefit period, up to \$2,000 per family per benefit period. The HCPT does not have a maximum benefit per benefit period or a maximum lifetime benefit threshold.

The HCPT provides prescription drug coverage under a prescription card program. This program requires \$5 co-pay for generic drugs, \$25 co-pay for Preferred Brand drugs, \$50 for Non-Preferred Brand drugs, 20% to a maximum of \$100 for Specialty drugs, \$10 co-pay for mail order generic drugs, \$55 co-pay for mail order Preferred Brand drugs, and \$125 co-pay for mail order Non-Preferred Brand drugs. Prescription drugs covered by the HCPT are not subject to the annual deductible.

The HCPT carries both specific and aggregate stop-loss insurance coverage to provide benefits when the participant or group claims exceed the respective deductibles on a paid basis during the year.

The HCPT also provides for \$50,000 of life insurance and accidental death and dismemberment insurance benefit coverage for each full-time employee participant.

5. PLAN BENEFIT OBLIGATION

The following is an analysis of HCPT benefit obligations payable on March 31, 2025 and 2024:

The HCPT benefit obligations represent estimates based on past experience of claim payments. Such estimates may be more or less than the amounts ultimately paid when the claims are settled. The net change in plan benefit obligations from those estimates vs. actual claims settled resulted in a decrease of \$(450,983) for the year ended March 31, 2025, and a decrease of \$(732,624) for the year ended March 31, 2024.

In calculating this liability, the third-party administrator uses the chain-ladder development method. Claim lag triangles are provided by insurance carriers to estimate the monthly incurred claims, based upon the claim lag experienced by the HCPT. The third-party administrator also calculates the IBNR using the Claims Per Member Per Month (PMPM) Trended Method. This method calculates an average PMPM claims cost for claims not yet paid based upon patterns of claims cost that have been recently incurred.

Overall, the final result is a blend of the two methods discussed. Knowledge of external forces that may affect future health care trends also impact the result of the calculations used, along with actuarial judgment.

6. REFUNDS

Refunds due from the HCPT's PBM are recorded when received. Pharmacy rebates totaling \$729,443 and \$455,310 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the years ended March 31, 2025 and 2024, respectively.

7. ADMINISTRATION

The HCPT's benefits are administered under a contract by Allegiance Benefit Plan Management, Inc., which processes and accounts for all benefit payments. Detailed records are maintained by the contract administrator. The contract administrator receives a fee for this service from the HCPT.

8. PARTY IN INTEREST AND RELATED-PARTY TRANSACTIONS

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the HCPT. Administrative expenses for the HCPT are paid directly by the Company.

Additionally, certain administrative functions are performed by third party administrators and claims processors. Commission, fees, and other administrative costs are netted into insurance premiums and netted information claims payments in the accompanying statement of changes in net assets available for benefits. These transactions are party-in-interest transactions under ERISA.

9. SUBSEQUENT EVENTS

In accordance with FASB ASC 855, the HCPT evaluated subsequent events through December 31, 2025, the date these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.
