To whom it may concern:

I am writing to request a waiver of any late fees or penalties associated with late filing of the 2024 5500-SF for the Blue Ridge Partnership for Children, EFAST ID# A1688939. We are located in the Western North Carolina mountains in an extremely hard-hit area by Hurricane Helene. Our normal office operations were totally disrupted for several months following the Hurricane. Once we were able to resume normal operations, I had multiple family emergencies that had me out of the office working as much as I could remotely. My mother fell and sustained a massive head injury and was hospitalized for a month and a half. While she was in the hospital my daughter had to have emergency brain surgery for an aneurysm that ruptured during surgery. In turn I was out more helping her with her children. We then brought my mother home on Hospice care, and I stayed with my parents to help until she passed. After her passing my father fell into a deep depression and ended up killing himself. As unbelievable as all this sounds it is what happened and in all the chaos and all the grief, our 2024 5500-SF was overlooked. Since this is only an informational return and no funds are due, I am pleading for a waiver of any fees. Please let me know if you have any questions or need further information.
