Opinion on the 2025 Financial Statements

The information has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying supplemental schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Other Matter - 2024 Financial Statement

Employee Benefit Plan as of March 31, 2024, were audited by Freed Maxick P.C. who joined with WithumSmith+Brown, PC effective August 1, 2025, whose report dated January 10, 2025, expressed an unmodified opinion on those statements and included an other-matter paragraph that provided an opinion that the information in the 2024 supplemental schedule was fairly stated in all material respects in relation to the financial statements as a whole.

Notes to Financial Statements

March 31, 2025 and 2024

1. Description of Plan

The following description of Brothers of Mercy Management Company, Inc. Employee Benefit Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is sponsored by Brothers of Mercy Nursing Home Company, Inc., with related employers, Brothers of Mercy, Inc.; Brothers of Mercy Sacred Heart Home, Inc.; Brothers of Mercy Housing Co., Inc.; Brothers of Mercy Montabaur Apartment Complex, Inc.; Brothers of Mercy Facilities Foundation and Brothers of Mercy Management Company, Inc. (collectively referred to as the Company) participating in the Plan. The Plan provides medical and prescription drug benefits to eligible employees of the Company and covered dependents. Eligible employees are part time employees who regularly work 15 or more hours of service a week or full-time employees who regularly work 30 or more hours of services per week. Employees are eligible to enroll once they complete a waiting period of 30 days from the first day they report for employment. Participation begins the first day of the month following completion of the waiting period once all required election and enrollment forms are properly submitted to the Plan Administrator.

Certain Plan assets are held in a trust. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 ("ERISA"), as amended.

Benefits

The Plan provides health benefits (medical and prescription drugs). The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act ("COBRA").

Insured Benefits

The Plan offers one health maintenance organization ("HMO") that participants can choose. Employees can choose between the L1500 or H3000 plan options which include different plan deductibles and out-of-pocket maximums per year as well as specific medical and drug benefits for participating and non-participating providers as outlined in the Plan document. Effective July 1, 2023, the deductible for participating employees of the L1500 plan was reduced to zero. The Company purchases annual insurance contracts for these insured benefits. Premiums for the insured benefits are paid from the assets of the trust.

Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Employee and employer contributions are done via payroll deductions.

Self-Insured Benefits

The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only ("ASO") arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan's trust. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Amendment to the Plan

The provisions of the Plan may be amended at any time by the Plan. Changes must be approved in writing by the Plan and the Plan Administrator.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimate

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have not been reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of changes in net assets available for benefits.

Stop-Loss Coverage

Premiums for stop loss insurance are included in premium payments in the accompanying statements of changes in net assets available for benefits. Stop loss refunds totaling \$1,120,578 and \$612,422 for the years ended March 31, 2025 and 2024, respectively have been netted with claims paid in the accompanying statements of changes in net assets available for benefits.

Concentration of Credit Risk

The Plan maintains its cash in bank demand deposit accounts, which, at times, may exceed federally insured limits. The Plan has not experienced any losses in these accounts and does not believe it is exposed to any significant credit risk with respect to cash.

Subsequent Events

Subsequent events were evaluated through January 13, 2026, the date the financial statements were available to be issued.

3. Claims Incurred But Not Reported

Plan obligations at March 31 for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment. In the event of termination of the Plan, these amounts would be funded by the Company.

4. Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators and the trustee. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

5. Tax Status

The Plan and the trust are required to operate in conformity with the Internal Revenue Code ("IRC") to maintain the tax-exempt status of the trust. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

7. Related-Party and Party In Interest Transactions

Certain Plan assets were invested in a common trust fund managed by the custodian of the Plan. The Plan has several arrangements with service providers. These transactions are party in interest transactions under ERISA.

8. Risks and Uncertainties

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
