Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Brandt Construction Company 401(k) Savings Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The following description of the Brandt Construction Company 401(k) Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General The Plan is a defined contribution plan covering all full time employees of Brandt Construction Company, Brandt, LLC, C & H Brandt Co., Brandt LLP, Mad Dog Concrete, LLC, Mill Creek Mining, Inc., Tickle Asphalt Co. Ltd., and Hy-Brand Industrial Contractors, Ltd. (collectively the 'Company') that are age 18 or older and are not leased or seasonal employees. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA).

Contributions Each year, participants may contribute a percentage of pretax annual compensation (subject to Federal limitations) as defined in the Plan in the form of a salary reduction. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans (referred to as rollover contributions). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3 % of eligible compensation. Contributions related to auto-enrollments are automatically invested in a moderately allocated group of funds until changed by the participant. The Plan provides for Company matching and profit-sharing contributions which are at the discretion of the Company's Board of Directors. The Company did not make matching or profit-sharing contributions in 2025 or 2024. Participants direct the investment of their contributions, matching employer contributions and employer discretionary contributions into various investment options offered by the Plan. The Plan currently offers nine mutual funds.

Participant accounts Each participant's account is credited with the participant's contribution and allocations of the Plan earnings (losses) and charged with an allocation of administrative expenses paid by the Plan and participant's withdrawals. Allocations are based on participant earnings, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting Participant contributions plus actual earnings thereon are always 100% vested. Company matching and discretionary contributions are based on years of continuous service on a sliding scale. A participant after 2 years of credited service is vested at twenty percent, after 3 years forty percent, after 4 years sixty percent, after 5 years of service eighty percent, and after 6 years one hundred percent.

Participant notes receivable Participant loans are not permitted under the Plan.

Payment of benefits On termination of service due to death, disability, or retirement, a participant receives a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Note 2 Summary of Significant Accounting Policies

Basis of Accounting

The Plan's policy is to prepare its financial statements on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments and Income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses on investment transactions are included in net appreciation (depreciation) in the fair value of investments. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Employee deferrals receivable

No participant deferrals were receivable to the Plan as of March 31, 2025 or March 31, 2024.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain administrative expenses relating to investment management fees are paid by the Plan and are reflected in the statement of changes in net assets available for benefits. Certain other expenses related to the general administration of the Plan are paid by the Company and are excluded from these financial statements.

Note 3 Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying Statement of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or 3 inputs were available to the Plan.

Level 1 Fair Value Measurements: The fair value is based on quoted net asset values of the shares held by the Plan at year end. The fair values of common stocks, corporate bonds, and U.S. Government securities are based on the closing price reported on the active market where the individual securities are traded.

The March 31, 2025 Statement of Net Assets Available for Benefits, the investment activities included in the Statement of Changes in Net Assets Available for Benefits for the year ended March 31, 2025 and 2024, and the accompanying Notes to the financial statements were prepared in part or entirely from information certified by the trustee in accordance with CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under Employee Retirement Income Security Act of 1974 (ERISA). The information certified by Matrix Trust Company includes total investments of \$ 8,277,756 and \$ 7,706,668 as of March 31, 2025 and March 31, 2024 and investment gains of \$ 466,289 and \$ 1,009,599 for the years ended March 31, 2025 and March, 31, 2024, respectively.

Note 5 Tax Status

The Internal Revenue Service has determined and informed the Plan via a determination letter dated March 31, 2008 that the Plan and designated trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the IRC. The Plan's Form 5500, *Annual Return / Report of Employee Benefit Plan* for the years ended 2023, 2024 and 2025 are subject to examination by the IRS, generally for three years after they were filed.

Note 6 Related Party transactions

Matrix Trust Company are the record keepers and therefore, these transactions qualify as party in interest. Fees paid by the Plan for administrative fee services amounted to \$ 44,624 and \$ 39,221 for the years ended March 31, 2025 and March, 31, 2024 respectively.

Certain employees and officers of Brandt Construction Company who may also be participants in the Plan, perform administrative services for the Plan. Brandt Construction Company does not charge fees for these administrative services to the Plan.

Note 7 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Note 8 Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.
