# Appendix B: Summary of Actuarial Assumptions and Methods

## A. Funding

Certain assumptions are prescribed as noted below. The other assumptions are estimates derived from historical and recent experience as well as market observations, combined with professional judgment about future expectations.

### Interest for IRS funding purposes

The interest rates used for the 2024 plan year are the 24-month average corporate bond segment rates for April 2024 subject to funding stabilization. Under stabilization, the interest rates used for funding purposes are calculated in the usual manner (24-month average corporate bond rates) but are then constrained to be within a corridor around a 25-year average of those same bond rates. Each of the three segments of the yield curve reflecting the 25-year average rates is constrained to be no less than 5%. For 2024, the stabilization corridor is 5%. It will remain at 5% through 2030 and then increase by 5% per year beginning in 2031 until it reaches 30% for 2035. The interest rate description above reflects that the plan sponsor elected to apply the ARPA provisions beginning with the 2020 plan year. The rates are as follows:

The prior year assumption used RP-2006 combined employee and annuitant healthy mortality tables, projected through the valuation date plus a number of years that varies by age and sex per IRC 1.430(h)(3)-1(c)(3)(ii)(A) using scale MP-2021.

### Salary Increases

4.00%.

### Asset Method

As selected by the plan sponsor, assets are valued at market value.

### Funding Method and Contribution Requirement

Funding method is unit credit actuarial cost method, as prescribed by law. The liability is measured on an accrual-to-date basis using mandated mortality tables and interest rates with no salary projection past the end of the year.

Plan sponsors are required under Internal Revenue Code Section 430 to make a minimum level of contributions to qualified pension plans. Available credit balances can be used to satisfy this required contribution. In general, the minimum required contribution is the sum of the target normal cost and an installment that amortizes the plan's funding shortfall, offset by any plan overfunding, if applicable. If all assumptions are met (including the investment earnings implicitly assumed by the interest rate), funding the plan at the minimum required

contribution level is generally designed to achieve a 100% funded status within fifteen years. Once that is achieved, or for overfunded plans, the minimum required contribution will generally equal the target normal cost reduced by any overfunding.

- Amount: For credited service through March 31, 2025: 3.70% for office staff, 3.92% for the Assistant General President and General Secretary-Treasurer, 4.21% for the General President and 3.25% for all other employees times annual limited rate of pay for each full year of service and completed twelfths of a year up to a maximum of 20 years or 65% of annual rate of pay. Prior service may be subject to different accrual rates if the resulting benefit is greater. A completed twelfth of service is a one-twelfth period in which the participant has earned 80 or more hours of service.

## Early Retirement

- Age Requirement: 55
- Service Requirement: None
- Amount: Normal pension accrued reduced by 1/4% for each month of age less than age 58 to a maximum of 24 months and 1/3% for each month of age less than age 56 to a maximum of 12 months.

For vested participants who separate from service under the Plan prior to age 55, normal pension accrued actuarially reduced from age 62.

If benefits commence on or after age 55 and the participant has 20 or more years of benefit service, the pension is unreduced for early retirement.

### Late Retirement

- Amount: Participants who work past normal retirement date receive the greater of additional accruals to their actual retirement date or the actuarial equivalent of their normal retirement benefit.

### Disability

- Amount: 100% of the benefit employee would have received had he or she separated from service under the Plan the day before he or she died, survived to age 55, and elected the 100% joint and survivor option payable when the participant would have attained age 55. Spouse may elect a lump sum equal to the greater of the actuarial present value of the survivor's annuity, or the actuarial present value of the benefit deferred to age 62.

### Participation

- Age Requirement: None
- Service Requirement: Immediate participation upon employment of International Union of Elevator Constructors.

### Groups Covered

- Group: All employees of International Union of Elevator Constructors

### Service

- Vesting: One vesting credit for twelve consecutive months of covered employment.
- Credited: One pension credit for twelve consecutive months of covered employment. A participant receives credit for working 80 or more hours in a month.

## Appendix A: Summary of Plan Provisions

### Automatic Benefit Forms

- Not Married: Unless an optional election is made, the accrued pension paid as a 120 month certain and life annuity.
- Married: Lifetime monthly annuity to the retiree with 50% of such annuity continuing to the retiree's spouse following the retiree's death. There is a pop-up provision if the spouse predeceases the retiree. The accrued benefit is adjusted such that the value is the actuarial equivalent of the 120 months certain and life annuity.
- Married participants may, with written consent of their spouse, elect an optional form of payment.

### Forms of Benefit

- Life Annuity: The retiree may elect the Life Only Benefit. The accrued pension is adjusted such that the value is the actuarial equivalent of the 120 months certain and life annuity.
- Joint and Survivor Forms: Retirees may elect a joint and survivor annuity with pop-up provision with any percentage continued (e.g., 50%, 66 2/3%, 75%, 100%) to a named beneficiary (who need not be the spouse of the retiree). The benefit under any such election is adjusted such that the value is the actuarial equivalent of the 120 month certain and life annuity.
- Lump Sum: The retiree may elect a lump sum which is the actuarial equivalent of the portion of the accrued benefit based on service prior to March 31, 1998.
- Actuarial Equivalence: 1984 Group Annuity Mortality Tables and 7% interest. For the 50% Joint and Survivor annuity with a Qualified Spouse (Surviving Spouse Annuity), if the Participant is more than 36 months older than the Qualified Spouse, the adjustment is determined as if the Participant is 36 months older than the Qualified Spouse. For lump sum payments, actuarial equivalence is based on 417(e) assumptions (lump sum yield curve in effect for the month prior to distribution).

### Statutory Limits

- Section 415 limit: \$275,000 (previously, \$265,000)
- Section 401(a)(17) limit: \$345,000 (previously, \$330,000)

### Recent Plan Amendments

- Plan Amendment: The accrual rate for credited service through March 31, 2025 changed to 3.70% for office staff, 3.92% for the Assistant General President and General Secretary-Treasurer and to 4.21% for the General President. Prior service maybe subject to higher accrual rates if the resulting benefit is greater.
