The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

#### Note 1. Plan Description

The following description of the Iowa Spring Manufacturing, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**General and eligibility:** The Plan is a defined contribution plan covering substantially all eligible employees of Iowa Spring Manufacturing & Sales Company and Affiliates and Northeast Spring, LLC (collectively, the Company). Employees are eligible to make salary deferral contributions to the Plan and receive safe harbor employer matching contributions once they have completed one year of service and have attained 18 years of age. Once eligible, participants can enter the Plan semiannually on the first day of the plan year and the first day of the seventh month of the plan year. To be eligible for employer discretionary contributions, employees must have worked at least 1,000 hours during the plan year and be employed on the last day of the plan year. The Board of Trustees is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the applicable current Internal Revenue Code (IRC) provisions.

**Contributions:** Employees who are eligible to participate in the Plan may contribute a portion of their eligible compensation, subject to an annual limit, as defined by the Plan and set by the Internal Revenue Service (IRS). The Plan has an auto-contribution feature in which new, eligible employees are automatically enrolled at a 3% deferral rate on the first entrance date, unless the employee specifically opts out of the Plan. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. The Company provides a safe harbor matching contribution equal to 100% of employee deferrals that do not exceed 3% of compensation plus 50% of employee deferrals between 3% and 5% of compensation. The Company, at its discretion, may make additional contributions to all eligible employees, regardless of participation in the Plan. There were no discretionary contributions to the Plan during the year ended March 31, 2025.

**Investment options:** Participants direct the investment of their contributions and any employer contributions into various investments offered by the Plan. Participants may change their investment options at any time.

**Participant accounts:** Each participant's account is credited with the participant's contribution, the Company's matching contribution, and an allocation of: (a) the Company's discretionary contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based upon participant's compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Vesting:** The participant is 100% vested in their elective deferral contributions and safe harbor employer matching contributions, plus actual earnings thereon. The Company's discretionary contributions begin vesting after two years of service and vest at 20% for each successive year until 100% vested after six years of service.

**Payment of benefits:** Participants or their beneficiaries are eligible for benefits upon retirement, termination, hardship, attaining age 59½, death or disability. Participants with vested balances greater than \$5,000 may elect to receive benefits in a lump-sum payment or an annuity. Participants with vested balances less than \$5,000 will receive a distribution in a single lump-sum as soon as administratively feasible, following the event that entitles the participant to a distribution.

#### Note 1. Plan Description (Continued)

**Forfeitures:** Forfeitures from nonvested account balances are used to pay for administrative expenses or reduce employer contributions. During the year ended March 31, 2023, no forfeitures were used to reduce employer contributions. There were approximately \$4,200 and \$1,700 in forfeitures available as of March 31, 2025 and 2024, respectively.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms range from one to five years. A maximum of two notes are available per participant and these notes are secured by the balance in the participants' accounts. Principal and interest are paid ratably through payroll deductions. Notes receivable outstanding at March 31, 2025, mature through July 2034. Notes receivable outstanding at March 31, 2025 and 2024, bear interest at rates from 4.25% to 9.50%.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual basis of accounting.

**Accounting estimates and assumptions:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments sold as well as held during the year. Management and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are treated as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of March 31, 2025 or 2024.

**Payment of benefits:** Benefit payments are recorded when paid.

**Subsequent events:** The Plan has evaluated subsequent events for potential recognition and disclosure through January 9, 2026, which is the date the financial statements were available to be issued.

#### Note 3. Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation of fair value of investments.

#### Note 4. Information Certified or Provided by Reliance Trust Company (Former Trustee) and ADP Retirement Trust Services, LLC (Current Trustee), the Trustees

Effective January 1, 2025, the Plan was modified changing the trustee from Reliance Trust Company to ADP Retirement Trust Services, LLC. The following is a summary of the Plan's asset information as of March 31, 2025 and 2024, and for the year ended March 31, 2025, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Reliance Trust Company and ADP Retirement Trust Services, LLC, qualified institutions:

For the year ended March 31, 2025, the Trustees also certified to the completeness and accuracy of \$25,736 of interest income on notes receivable from participants, \$749,627 of dividend income, \$22,463 of other income and \$563,781 of net depreciation in fair value of the Plan's investments (including investments bought, sold and held during the year).

#### Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

#### Note 6. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

#### Note 7. Fair Value Measurements

Accounting guidance on fair value measurements and disclosures, defines fair value, establishes a framework for measuring fair value and expands disclosures about fair value measurements. This guidance defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. This guidance requires the use of valuation techniques that are consistent with the market approach, the income approach and/or the cost approach. Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset or liability. Inputs may be observable, meaning those that reflect the assumptions market participants would use in pricing the asset or liability developed based on market data obtained from independent sources, or unobservable, meaning those that reflect the Plan's own assumptions about the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. In that regard, this guidance establishes a fair value hierarchy for valuation inputs that give the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The fair value hierarchy is as follows:

- Level 1:** Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2:** Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data.
- Level 3:** Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

A description of the valuation methodologies used for instruments measured at fair value, as well as the general classification of such instruments pursuant to the valuation hierarchy, is set forth below. The level to which an asset or liability is classified is based upon the lowest level of input that is significant to the fair value measurements. There have been no changes in valuation methodologies at March 31, 2025 and 2024. During the year ended March 31, 2025, there were no transfers between Level 3 assets.

**Mutual funds:** Mutual funds are reported at fair value based on the quoted market price of the fund and are classified within Level 1 of the valuation hierarchy.

**Common collective trust fund:** Common collective trust fund is composed primarily of fully benefit-responsive investments contracts that are valued at the net asset value (NAV) of units of the common collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur immediately. If the Plan initiates a full redemption of the collective trust, no notice to the issuer is required.
