## Independent Auditors' Report

### *Opinion*

## NOTES TO FINANCIAL STATEMENTS

March 31, 2025 And 2024

### 1. General Information

#### Description Of The Plan

The following description of the BAC Local Union 15 Supplemental Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering participants who work under the terms of the collective bargaining agreements within the jurisdiction of Missouri and Kansas Bricklayers Local Union No. 15 of the Bricklayers and Allied Crafts Workers International Union, AFL-CIO (BAC Local 15).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Employers of participants contribute to the Plan for each hour worked in covered employment at rates negotiated through collective bargaining or other agreements between BAC Local 15 and participating employers.

Effective April 1, 2023, the contribution rate was \$2.70 for each hour worked. The contribution rate remained unchanged through March 31, 2025. Effective April 1, 2025, the contribution rate was raised to \$2.90 for each hour worked. Contributions are due the month following the hours worked.

#### Participant Accounts

Plan investment decisions are directed by the Board of Trustees. Each participant's account is credited with the employers' contributions and allocations of Plan earnings and charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### Vesting

Participants are automatically 100% vested in all contributions made on their behalf and earnings thereon.

### Notes To Financial Statements (*Continued*)

#### **Benefits**

Participants and/or beneficiaries become entitled to a regular monthly pension benefit upon retirement on or after the age of 55, death, disability or cessation of the participant's employment with the employer. If a participant retires on or after age 55, but before age 62, the participant must withdraw from all employment with contributing employers and disqualifying employment for at least the four months following the March 31 valuation date for which the participant expects to receive benefits. The value of the participant's account is based upon the participant's account balance on the valuation date coincident with or next following the participant's retirement date. Disability benefits are payable to a participant that is totally and permanently disabled and who is qualified for disability benefits under Title II of the Social Security Act. Benefits are the same as normal retirement. Upon retirement, benefits will be paid in a lump sum or in approximate equal installments for a fixed period of years, unless another form of distribution is approved by the Trustees.

#### **Death Benefits And Forfeitures**

Upon a participant's death, the participant's beneficiaries shall be entitled to the full value of the participant's allocated account as of the valuation date coincident with or next following the date of death. The Plan allows for forfeiture of accounts with balances less than \$500 that have no contributions for two consecutive Plan years and the Trustees are unable to locate the participant. For the Plan years ended March 31, 2025 and 2024, no accounts were forfeited.

## **2. Summary Of Significant Accounting Policies**

#### **Basis Of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities, at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

### Notes To Financial Statements (*Continued*)

#### **Investment Valuation And Revenue Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion on fair value measurements. Net change in fair value of investments represents the difference between the aggregate fair value of investments at year-end and the values at the beginning of the year and includes any realized gains and losses in shares that were bought and sold during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### **Payment Of Benefits**

Benefit payments to participants are recorded upon distribution.

#### **Contributions Receivable And Credit Loss Policy**

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This estimate considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at March 31, 2025 or 2024.

#### **Subsequent Events**

Management of the Plan evaluates subsequent events through the date financial statements are available for issue, which is the date of the Independent Auditors' Report.

### **3. Fair Value Measurements**

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

#### **Mutual Funds**

Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### **Common/Collective Trusts**

Valued at the unit value or NAV of shares held by the Plan at year-end. The NAV, as provided by the trustee of the fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. All of the common/collective trusts held by the Plan may be redeemed daily. The common/collective trusts held by the Plan are not required to be reported in the fair value hierarchy. All of the common/collective trusts held by the Plan file an annual report on Form 5500 as a direct filing entity. The common/collective trusts have no unfunded capital commitments.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodologies used at March 31, 2025 or 2024.

#### 4. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Plan Administrator by a letter dated May 14, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the IRC). The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's counsel believe that the Plan is designed and continues to operate in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position, that more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **5. Plan Termination**

Although they have not expressed intent to do so, the Trustees have the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of termination, the rights of all affected participants to benefits accrued to the date of such termination are nonforfeitable. The Trustees shall apply the assets of the Plan first to the expenses incurred by the Plan, then the benefits to those retired participants and beneficiaries, then to all other vested benefits and any other benefits payable under the Plan.

### **6. Administrative Agreements And Party In Interest Transactions**

The Plan has an agreement with Wilson-McShane Corporation to provide administrative services.

The Plan has an agreement with Segal Marco Advisors to act as a Plan consultant. During the years ended March 31, 2025 and 2024, the Plan had various investment management agreements and asset custody agreements with Loomis Sayles & Company, L.P., BlackRock Institutional Trust Company and Commerce Trust. Plan investments were managed by these investment managers and asset custodians. These transactions qualified as exempt party in interest transactions.

### **7. Significant Contributing Employers**

For the year ended March 31, 2024, there was no concentration of total employer contributions. For the year ended March 31, 2025, contributions from one employer represented 11% of total employer contributions; this employer had outstanding contributions receivable of \$25,013 as of March 31, 2025.

### **8. Risks And Uncertainties**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and amounts reported in the statement of net assets available for benefits.
