## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed an audit of the financial statements of the Plastic Suppliers, Inc. Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2025 and 2024, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended October 31, 2025 and 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Notes 1, 2, and 6 to the financial statements, the Board of Directors of the Plastic Suppliers, Inc. approved a plan to terminate the Plan effective February 28, 2025 and management determined that liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2024 financial statements to the liquidation basis of accounting used in presenting the 2025 financial statements. Our opinion is not modified with respect to this matter.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Other Matters

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1: DESCRIPTION OF THE PLAN

General

The following description of the Plastic Suppliers, Inc. Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

The Plan is a defined contribution 401(k) retirement plan covering all non-union, non-leased employees of Plastic Suppliers, Inc. (the “Company”). Effective September 15, 2025, the Company changed its legal name to PSI Winddown, Inc. The Plan also excludes employees of affiliated employers unless the Plan has specifically been adopted by the affiliated employer. The Trustees of the Plan Sponsor control and manage the operation and administration of the Plan. Voya Institutional Trust Company is the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Board of Directors authorized Company management to file a petition for relief under the United States Bankruptcy Code. The Company filed a petition for relief under Chapter 11 of the United States Bankruptcy Code on December 22, 2024, with the United States Bankruptcy Court for the District of New Jersey, Case number 24-22549. The confirmation of the Company’s Amended Plan of Liquidation was approved by the court on August 21, 2025. During 2024 and 2025, participants continued to make contributions to the Plan.

The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022. This legislation includes a vast array of both mandatory and optional provisional changes to retirement plans, becoming effective in 2024 and beyond. Plan management adopted mandatory provisions effective for the plan years ended October 31, 2025.

Contributions

Employees are eligible to receive profit sharing contributions if they have completed 1,000 hours of service during, and are employed at the end of the Plan’s fiscal year. Entry date for profit sharing contributions is considered the first day of the plan year coinciding with or next following when the requirements are met. The Company’s Board of Directors determines the amount, if any, of discretionary employer profit sharing contributions during each Plan year. The Company’s profit sharing contribution and forfeitures are allocated based on a social security integration formula. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations. There was no discretionary contribution for the years ended October 31, 2025 and 2024.

The Plan includes elective deferral and employer match features with no age or service requirements. Employees may contribute up to 100% of their pre-tax annual compensation, as defined in the plan document, subject to the maximum permitted by the IRC. Elective deferrals of 3% are automatically made to the accounts of Plan participants who fail to make an election and are then increased by 1% per year to a maximum of 10%. The Company’s current employer match is 25% of the participant’s contributions that are not in excess of 10% of the participant’s compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions).

Notes Receivable from Participants

Participants are able to borrow a minimum of \$1,000 up to 50% of their vested account balance not to exceed \$50,000 in a rolling twelve month period. Participants may have one loan outstanding at any one time. Loan terms generally range from twelve months to five years. Loans are secured by an assignment of the participant's vested interest in the Plan and bear interest at a rate of prime plus 2% fixed as of the first day of the month of the borrowing. Due to the plan termination, there were no balances remaining at October 31, 2025, of notes receivable from participants.

Interest paid by the participant's on their loans is included in "Interest income participant loans" in the accompanying statement of changes in net assets available for benefits. Principal and interest are paid ratably through payroll deductions.

Participant Accounts

Individual accounts are maintained for each Plan participant to reflect the participant's entire interest under the Plan. Each participant's account is credited with the participant's allocation of the Company's contribution, forfeitures of terminated participant's non-vested accounts and investment earnings, and reduced by distributions from the participant's account, fees and investment losses. A separate account is maintained for each participant's employer contribution and employee contribution, which were allowed under the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of the balance in their accounts into various investment options offered by the Plan. Participants may currently choose from a variety of different investment options with varying objectives and degrees of investment risk.

Plan earnings are allocated to each participant's account based upon the earnings of investments selected by the participant.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting of employer contributions for any participant terminated for any cause other than death, disability, or retirement generally occurs as follows:

Vesting (Continued)

Terminated participants who elect to withdraw their vested account balance and all terminated participants with vested account balances of \$5,000 or less will receive a distribution of the vested value; the non-vested value will be forfeited. All other terminated participants' non-vested account balances will be forfeited after a five-year break in service. Participants terminated due to death, disability, or retirement age of at least 65 are fully vested regardless of their years of service.

Payment of Benefits

Benefits are payable to Plan participants in the event of death, retirement, early retirement at age 62 (with 5 years of completed service) or disability. If an employee is terminated prior to one of these events, the unpaid vested benefit is segregated into a specific account. Upon one of these occurrences, a participant whose vested account balance exceeds \$1,000 may elect to receive their vested account balance in the form of a lump-sum payment.

A participant whose vested account balance is more than \$1,000 but less than \$5,000 that does not elect to receive their vested account balance in the form of a lump-sum payment will receive their vested account balance in the form of a roll over distribution to an individual retirement account. A participant whose vested account balance is \$1,000 or less and has not commenced receiving installment payments will receive their vested account balance in the form of a lump-sum payment.

Forfeited Accounts

Forfeitures can be used for the benefit of the Plan. Permissible uses include payment of plan expenses, reduction of employer contributions and to provide an additional allocation to participants of the Plan. Forfeitures of \$13,463 and \$15,027 were reallocated to participant accounts during the 2025 and 2024 plan years, respectively. The unallocated forfeited balances at October 31, 2025 and 2024, were \$0 and \$54,611, respectively.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

In accordance with accounting principles generally accepted in the United States of America, the Plan changed its basis of accounting from the ongoing plan basis to the liquidation basis for effective February 28, 2025, the date on which management determined liquidation to be imminent.

Under the liquidation basis of accounting, assets are stated at their estimated cash value expected to be collected in settling or disposing of assets during the liquidation process and liabilities are stated at their anticipated settlement amounts. Investments are stated at fair value, which approximates the amount the Plan expects to collect.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain amounts and disclosures. Accordingly, actual results may differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/ (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Distributions Paid to Participants

Participant distributions are recognized when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses was recorded as of October 31, 2025 and 2024.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan. Administrative expenses paid by the Company are excluded from these financial statements. Certain administrative functions are performed by the officers and employees of the Company. No such officers or employees receive compensation from the Plan.

Subsequent Events

In evaluating events that may have a material impact on the financial statements, the Company has considered activities through December 16, 2025, the date the financial statements were available to be issued.

NOTE 3: INFORMATION SUPPLIED AND CERTIFIED BY CUSTODIAN (UNAUDITED)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held at October 31, 2025 and 2024, and net appreciation (depreciation) in fair value of investments, notes receivable, interest and dividends for the years ended October 31, 2025 and 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Voya Institutional Trust Company, the trustee of the Plan.

NOTE 4: FAIR VALUE MEASUREMENTS

Accounting standards establish a framework for measuring fair value by providing a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (“Level 1 inputs”) and the lowest priority to unobservable inputs (“Level 3 inputs”). The three levels of the fair value hierarchy are described below:

- Level 1 – inputs to the fair value determination are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.
- Level 2 – other significant inputs including; quoted prices of similar assets and liabilities in active markets, quoted prices for identical assets and liabilities in inactive markets, observable inputs other than quoted prices, inputs derived from or corroborated by observable market data either by correlation or other means.
- Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement and may include the Plan’s own assumptions in determining the fair value of the assets and liabilities.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2025 and 2024.

*Mutual funds:* Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of underlying assets owned by the fund, minus its liabilities and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

*Collective investment trust:* Valued based on NAV of units of the collective investment trust. The NAV, as provided by the custodian, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5: TRANSACTIONS WITH PARTIES-IN-INTEREST

Parties-in-interest are defined under the Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. At October 31, 2025 and 2024, the Plan used Voya Institutional Trust Company (Voya) to act as trustee and record keeper. As such, the investments managed by Voya and the administrative fees paid to Voya qualify as party-in-interest transactions.

Additionally, the Plan held party-in-interest receivables of \$119,732 as of October 31, 2024, in the form of participant loans.

NOTE 6: PLAN TERMINATION

As discussed in Note 1, the Plan was formally terminated pursuant to a resolution adopted by the Board of Directors. No further contributions were made to the Plan after that date, and all participant accounts were fully vested. The Plan Administrator took all necessary steps to distribute plan assets in accordance with applicable IRS and DOL regulations. Distribution of remaining plan assets as of October 31, 2025 is expected to occur during the subsequent plan year.

NOTE 7: TAX STATUS

Voya Retirement Insurance and Annuity, sponsor of the Non-Standardized 401(k) Profit Sharing Plan prototype document, has obtained an opinion letter dated September 1, 2014, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The plan sponsor adopted this Voya restated prototype document on June 30, 2020. The opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require management of an organization to evaluate tax positions taken by the organization and recognize a tax liability if the organization has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. There are currently no audits for any tax periods in progress. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

NOTE 8: VARIOUS RISKS AND UNCERTAINTIES

The Plan holds various investments. Investment securities are exposed to various risks such as interest rates, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that a change in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.
