For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**Note 1 – Description of the Plan**

The following brief description of the Savings Incentive Plan for Employees of Wheeler Brothers Grain Company, LLC (the “Plan”) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

**A. General**

The Plan is a defined contribution plan covering all eligible employees (which excludes union employees, nonresident aliens and leased employees, as defined) of Wheeler Brothers Grain Company, LLC and affiliates (Company) who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The administrative committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's participants. Employees become participants in the Plan on May 1 or November 1 following completion of eligibility requirements.

**B. Contributions**

Each year, participants may contribute, pretax, up to a specified dollar amount determined by the Internal Revenue Service, as defined in the Plan. Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions and the Company matching contribution into various investment options offered by the Plan.

The Company, excluding AT&L Railroad employees, can elect to make discretionary profit sharing contributions to the Plan, which will be allocated to eligible employees employed on the last day of the plan year with at least one year of service (a minimum of 1,000 hours). New employees must also be employed on the first and last day of the plan year. Company profit sharing contributions, if any, are allocated in the same proportion that each participant’s compensation for the year bears to the total compensation of all participants. The Company made a profit sharing contribution of \$323,337 related to the 2025 plan year and \$161,995 related to the 2024 plan year.

The Company may make a discretionary matching contribution to eligible employees subsequent to meeting the eligibility requirements. The Company’s matching contribution was 50% of participant contributions up to 4% (i.e. a maximum match of 2%).

**C. Participant accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, Plan earnings, and administrative expenses, if any. Allocations are based on participant earnings or account balances, as defined. Company profit sharing contributions are deposited in the year following the year the amounts are earned. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**D. *Vesting of Benefits***

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. For profit sharing contributions, participant is 20 percent vested after two years of credited service and continues to vest in increments of 20 percent until 100 percent vested after six years of credited service. Vesting in the Company's matching contribution is based on years of service. A participant is 20 percent vested after one year of credited service and continues to vest in increments of 20 percent until 100 percent vested after five years of credited service.

**E. *Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant with a balance greater than \$5,000 may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account or partial withdrawals. Distributions to participants whose vested accounts do not exceed \$5,000 shall be made in a lump sum payment. In-service withdrawals are allowed for those participants over 59.5 years of age. Upon proof, to the satisfaction of the Plan Administrator, of an immediate and financial need, amounts contributed pretax may be withdrawn for a hardship purpose.

**F. *Forfeitures***

Forfeitures of participants' nonvested accounts are allocated to active participant accounts in the same manner as the Company's profit sharing contributions or can be used for participant true-up contributions or pay Plan expenses. At March 31, 2025 and 2024, forfeited non-vested accounts totaled \$18,733 and \$16,216, respectively. In 2025, forfeitures of \$9,314 were either allocated as additional contributions or used to pay administrative fees.

**G. *Notes Receivable from Participants***

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are available to all participants on a uniform and non-discriminatory basis. All loans must bear a reasonable rate of interest, and loan terms are in accordance with limitations set forth by the Internal Revenue Service. Principal and interest are paid ratably through payroll deductions. Delinquent loans can be considered in "default" and may be considered a taxable distribution. Notes receivable may not exceed five years unless the note is for the purpose of purchasing a personal residence, in which the term may be up to 20 years.

**Note 2 – Summary of Significant Accounting Policies**

**A. *Basis of Presentation***

The Financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States ("GAAP").

Investment contracts held by a defined contribution plan that are fully benefit responsive are required to be reported at contract value because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The statement of changes in net assets available for benefits is prepared using the contract value basis for fully benefit responsive investment contracts.

**B. *Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**C. *Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of April 30, 2025 or 2024. Delinquent loans are treated as distributions based upon the terms of the Plan document.

**D. *Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends, if applicable, are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**E. *Payment of Benefits***

Benefits are recorded when paid.

**F. *Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**G. *Subsequent Events***

The Plan has evaluated subsequent events through January 13, 2026 the date the financial statements were available to be issued.

**Note 3 - Plan Advisory Committee and Custodian**

The Plan provides for selection of an Administrative Committee and Custodian by the Board of Directors of the Company. The Administrative Committee is responsible for the administration of the Plan. Empower Trust Company, LLC administers the Trust Fund, which consists of all assets owned by the Plan. Empower Trust Company, LLC has been granted full authority concerning purchases and sales of investments of the Plan's assets and is the Custodian of all the Plan's investments.

**Note 4 - Information Certified by Custodian (Unaudited)**

The following is a summary of the unaudited information regarding the Plan that was prepared by Empower Trust Company, LLC, the Custodian of the Plan. The Plan Administrator obtained certifications from the Custodian that such information is complete and accurate.

**Note 5 – Fair Value of Plan Assets**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted price in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets
  - quoted prices for identical or similar assets or liabilities in inactive markets
  - inputs other than quoted prices that are observable for the asset or liability
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at net asset value.

*Common Collective Trust:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 6 – Guaranteed Investment Contract with Insurance Company**

The Plan has entered into a traditional fully benefit-responsive guaranteed interest account contract with Massachusetts Mutual Life Insurance Company (MassMutual) totaling \$992,370 and \$930,925 at April 30, 2025 and 2024, respectively. MassMutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charges for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on an annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by MassMutual, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events for example, divestures or spin-offs of a subsidiary that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. The Plan administrator believes that no events are probable of occurring that would limit the Plan's ability to transact at contract value with participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

**Note 7 – Related-Party Transactions and Party-In-Interest Transactions**

Certain Plan investments are managed by the Custodian, Empower Trust Company, LLC, and therefore, these transactions qualify as party in interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. With respect to the Plan's investment in mutual funds, the mutual fund company is considered to be a service provider to the Plan, and as such, is considered a party-in-interest. Fees incurred by the plan for the investment management, recordkeeping and audit services are charged to the plan participants on a pro rata basis. The Plan Sponsor pays directly any other fees related to the plan's operations. Certain fees of administering the Plan are paid to the Trustee by the Plan. These transactions qualify as exempt party-in-interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**Note 8 - Termination of the Plan**

Although the Company has not expressed any intention to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, all remaining Plan assets shall be allocated to the participants as described in the full text of the Plan.

**Note 9 – Tax Status**

The Plan adopted a volume submitter profit sharing prototype plan designed to qualify under Section 401 of the Internal Revenue Code (IRC). The Plan has obtained a copy of a favorable determination letter for the volume submitter profit sharing plan dated June 30, 2020 that the volume submitter profit sharing plan is designed in accordance with applicable sections of the IRC. The Plan is relying on this determination letter. Although the Plan has been amended since that determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

**Note 10 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
