**(1) PLAN DESCRIPTION**

The following description of the St. Mary Community Action Agency Inc 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan. The purpose of the Plan is to encourage employees of St. Mary Community Action Agency, Inc (the "Agency") to systematically save for their retirement with pre-tax dollars and to reward eligible employees for their efforts toward making the Agency successful. The Plan became effective October 1, 1998 and is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA). It is intended to qualify as a profit sharing plan under Sections 401(a) and 401(k) of the Internal Revenue Code.

**Contributions**

Each year, participants may contribute up to a maximum of 100 percent of their pretax or post-tax annual compensation, as defined in the Plan up to the maximum annual dollar limit which is set by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500. The Agency may contribute a discretionary amount to the Plan as determined by the Agency. Currently the discretionary amount is equal to the employee contribution, except that it cannot exceed 5% of the participant's salary. The Plan does not allow rollover contributions.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and the employer's discretionary contribution. The earnings on investments of the Plan are allocated to the account of each participant based upon each participant's prorated balance as computed by the Plan Administrator.

**Eligibility**

Employees of the Agency who have completed one-half year of service and have reached the age of 21.5 are eligible to participate in the Plan. Eligible employees become members by authorizing the Agency to deduct amounts from their qualified compensation.

**Investment Option**

Individual participants may not direct the investment of their funds.

**(1) PLAN DESCRIPTION (CONTINUED)**

**Vesting**

Participants are immediately vested in their elective deferral contributions and related earnings. The participant fully vests in the Agency's contribution and related earnings after three years of service.

**Payment of Benefits**

The time and payment of accrued benefits may be by lump sum or installments (monthly, quarterly, or annual) over a fixed reasonable period of time dependent on termination (death or otherwise), election prior to or after termination, and whether vested accrued benefits exceed \$5,000.

**Forfeitures**

Forfeitures are retained in the Plan and are first used to pay administrative expenses, if any. Any remaining amounts are used to reduce future employer contributions payable under the Plan. The forfeiture account had a zero balance as of March 31, 2025. All forfeiture amounts were allocated as of March 31, 2025.

**Related Party Transactions**

Transactions resulting in Plan assets being transferred to or used by a related party are prohibited under ERISA unless a specific exemption exists. Southern Farm Bureau Life Insurance Company, a current custodian of the Plan, is a party-in-interest as defined by ERISA as a result of having Plan assets invested in its funds. However, such transactions are exempt under Section 408(b)(8) and are not prohibited by ERISA.

**(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America as promulgated by the Financial Accounting Standards Board; however, benefits are recorded when paid.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Risks and Uncertainties**

The Plan has invested substantially all of the Plan assets with Southern Farm Bureau Life Insurance Company, a large regional life insurance company operating in the southeastern United States. The investment is payable strictly from the general assets of the insurance company and the Plan does not require any additional collateral. There are no reserves against the contract value for credit risk or otherwise.

**Investment Valuation and Income Recognition**

Investments are reported at contract value as further described in Note 3.

**Date of Management Review**

Management has evaluated subsequent events through January 14, 2026, the date when the financial statements were available to be issued.

**(3) GUARANTEED INVESTMENT CONTRACT**

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. At March 31, 2025 and 2024, the Plan had investments of \$1,646,853 and \$1,537,373 in the group deposit contract.

With traditional investment contracts, the Plan owns only the contract itself. This investment contract is designed to accrue interest based on crediting rates established by the contract issuers. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3.5 percent. The crediting rate is reviewed on a yearly basis for resetting.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Southern Farm Bureau. The Plan administrator believes the occurrence of such events that would limit the Plan's ability to transact at contract value with Plan participants is not probable.

**(4) INFORMATION CERTIFIED BY CUSTODIAN**

As pursuant to CFR 2520.103-8, the Plan qualified for an ERISA Section 103(a)(3)(c) audit for 2025 and 2024. Information relating to investment assets, investment transactions, investment earnings, and Schedule of Assets (Held at End of Year) was certified as complete and accurate by the custodian, Southern Farm Bureau Life Insurance Company, as of March 31, 2025 and 2024, and for the year ended March 31, 2025.

**(5) TAX STATUS**

The Plan uses a prototype plan document sponsored by Southern Farm Bureau Life Insurance Company. Southern Farm Bureau Life Insurance Company received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Management has analyzed the Plan's tax positions taken on Federal income tax returns for all open tax years (current and prior three years) and has concluded that as of March 31, 2025, no provision for income tax is required in the Plan's financial statements. The Plan's Federal tax return for tax years for which the applicable statutes of limitations have not expired are subject to examination by the Internal Revenue Service.

**(5) TAX STATUS (CONTINUED)**

On December 29, 2022, the Consolidated Appropriations Act of 2023 was enacted, encompassing a suite of retirement provisions colloquially termed "SECURE 2.0." This legislative package builds upon the foundational reforms introduced by the 2019 SECURE Act, with a central aim of expanding participation in the retirement ecosystem and enhancing avenues or asset accumulation. The provisions set forth by SECURE 2.0 will be progressively effective from 2023 onwards.

The Act presents a blend of mandatory and elective provisions. Plan and Organization management will evaluate and decide upon the elective components in alignment with the Plan's objectives and the best interests of participants and the Organization. As of the report date, the Plan has not been formally amended to incorporate the provisions of SECURE 2.0. However, the Plan is operating in compliance with all mandatory elements as prescribed by the Act.

**(6) PLAN TERMINATION**

Although it has not expressed any intent to do so, the Agency has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**(7) ADMINISTRATIVE EXPENSES**

The Agency provides office space, accounting personnel, and other administrative services to the Plan at no cost. The value of these administrative services has not been determined by the Agency for the year ended March 31, 2025, and will not be reimbursed to the Agency.
