## INDEPENDENT AUDITOR'S REPORT

To the Participants and Trustees of  
Pacific Coast Shipyards Metal Trades Trust Fund:

### Opinion

We have audited the financial statements of Pacific Coast Shipyards Metal Trades Trust Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and benefit obligations as of March 31, 2025 and 2024, and the related statements of changes in net assets available for benefits and changes in benefit obligations for the years then ended March 31, 2025 and 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Pacific Coast Shipyards Metal Trades Trust Fund as of March 31, 2025 and 2024, and the changes in net assets available for benefits and changes in benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ### Management Responsibilities for the Financial Statements

**1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements of Pacific Coast Shipyards Metal Trades Trust Fund (the “Plan”) are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Investment Valuation, Transactions and Income Recognition -**

*General*

Investments are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC” 820), *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the “exit price”) in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan’s assumptions about inputs that market participants would use in pricing the investments developed, based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

*Level 1* - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

*Level 2* - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

*Level 3* - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities’ own judgments and estimations or some other pricing method using unobservable inputs.

*Inputs and Valuation Methods* - In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods used for each of the Plan’s investment classes are presented below.

*Mutual funds/exchange-traded funds:* Values are determined using quoted prices in active markets (Level 1).

*Money market fund:* Values are based on amortized cost, which approximates fair value (Level 2).

*Valuation Methods, Consistency* - The valuation techniques used in the accompanying financial statements have been consistently applied.

*Transactions and Income Recognition* - Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Cash**

Cash consists of monies held in two highly liquid checking accounts, of which one is interest bearing, and one interest bearing sweep account. All three accounts are free from significant withdrawal restrictions.

**Participant Contributions – Net of Refunds**

Participant contributions are recognized as income in the same month as benefit coverage is provided net of participant refunds. Contributions refunded to participants are netted against in the participant contributions in the accompanying statement of changes in net assets available for benefits.

**Contributions Receivable**

Employer and participant contributions due and not paid prior to year-end are recorded as employer and participant contributions receivable. An allowance for credit losses is considered unnecessary and is not provided. Employer contributions due as a result of payroll audits have been recorded net of an allowance, as applicable, because collectability is uncertain.

**Deferred Revenue**

Contributions received from retirees' self-pay or Consolidated Omnibus Budget Reconciliation Act ("COBRA") are collected one month in advance of the related premium expense and are recorded as deferred revenue.

**Administrative Expenses**

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

**Payment of Benefits**

Premiums paid are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Premiums not yet paid at year-end are included as an amount currently payable in the accompanying statements of benefit obligations.

**Benefit Obligations**

Accumulated eligibility credits were estimated based on premium costs and the participants' accrued dollar bank. Premiums payable were estimated based on actual premiums paid subsequent to March 31 for March and prior eligibility. The costs of postretirement benefits are paid entirely by the retirees and are not reflected on the statements of benefit obligations.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. The significant estimate affecting the financial statements are the benefit obligations and changes in benefit obligations. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan invests in mutual funds/exchange-traded funds and a money market fund. Such investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**2. DESCRIPTION OF THE PLAN**

The Plan was established in 1953 as a result of collective bargaining agreements to provide welfare benefits for eligible employees and their dependents. The current Plan provides medical, drug, dental, vision, life, accidental death and dismemberment, and long-term disability benefits.

To be initially eligible for benefits, employees must have sufficient contributions made on their behalf in a month based on the current cost of the benefits in which the participant is enrolled. Coverage starts on the first day of the second month after sufficient contributions are received. To remain eligible, an employee must have sufficient contributions made during a month (based on hours worked in the previous month), which provides coverage two months later. The amount of contributions needed to gain initial eligibility and to maintain eligibility is determined by the type of coverage each participant elects.

Employer contributions for each participant are totaled each month in a dollar bank. The Plan provides a subsidy to eligible participants' dollar banks at a defined monthly rate. Effective July 1, 2023, the maximum subsidy was increased from \$200 to \$300 per member per month. Effective July 1, 2024, the maximum subsidy was increased from \$300 to \$559 per member per month. Any contributions over the actual cost of benefits are credited to the participant's dollar bank to be used for any month in which contributions are less than the cost of benefits. If the actual cost of benefits exceeds the balance in the participant's dollar bank by more than the maximum subsidy, an additional payment by the participant to cover the cost of the benefits can be made.

Participants can make additional payments, up to \$7,000 per calendar year, to cover the cost of their benefits, as long as the participant is working for a union employer.

Continuation of health care benefits to persons who would otherwise lose those benefits due to certain events, as mandated by COBRA, has been adopted by the Plan.

All retired participants and their dependents are required to self-pay the cost of their coverage in order to maintain coverage. Retiree eligibility is granted on a monthly basis with self-payments due in advance. The Board of Trustees (the "Trustees"), however, reserves the right to reduce or modify the benefits of the retiree plan, cancel the Plan in its entirety, or require additional contributions from the participants should the assets of the Plan prove insufficient to otherwise continue the retiree plan. During the years ended March 31, 2025 and 2024, the costs of the postretirement benefit plan were paid entirely by retirees. Participants may contribute specified amounts, determined periodically by the Plan's actuary, to extend coverage to eligible dependents.

Participants should refer to the summary Plan description and recent Plan amendments for more complete information.

**3. PRIORITIES UPON TERMINATION**

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

**4. TAX STATUS**

The Plan obtained its latest determination letter, dated October 1954, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

The Plan's administrator has analyzed the tax positions taken by the Plan and has concluded that, as of March 31, 2025 and 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**5. FUNDING POLICY**

The Plan is financed by contributions from employers, self-pay contributions from retirees and participants electing COBRA coverage. The monthly employer contribution rate is specified in the collective bargaining agreements. Contributions from retirees and COBRA participants are determined annually by the Plan's consultant.

**6. CASH CONCENTRATIONS**

The Plan places its cash with financial institutions. The balances are insured by the Federal Deposit Insurance Corporation for up to \$250,000 per institution. Cash balances regularly exceeded the insured deposit limits. Cash at March 31, 2025 and 2024, consisted of the following:

**9. MAJOR EMPLOYERS**

During the years ended March 31, 2025 and 2024, the Plan had three employers that together contributed approximately 70% and 65% of employer contributions, respectively. In the event that an employer suspends contributions, the Plan could terminate coverage to the employers' participants, as required under the Plan document. The Plan would retain the risk of current fixed administrative expenses until the appropriate adjustments were made.

**10. INSURANCE ARRANGEMENTS**

The Plan provides life and accidental death and dismemberment benefits to eligible participants through an experience-rated policy with Standard Insurance Company. Because this policy is experience rated, the premium costs are affected by, among other things, the number and size of claims paid. For the years ended March 31, 2025 and 2024, the Plan's experience-related income totaled \$28,083 and \$25,859, respectively.

**11. SUBSEQUENT EVENTS**

In preparing these financial statements, management of the Plan has evaluated events and transactions that occurred after March 31, 2025, for potential recognition or disclosure in the financial statements. These events and transactions were evaluated through January 6, 2026, the date that the financial statements were available to be issued, and no items have come to the attention of management that require recognition or disclosure..
