Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management, having determined it is permissible in the circumstances, has elected to have the audits of Hannoush Jewelers Profit Sharing and Salary Reduction Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 31, 2025 and 2024, and for the year ended March 31, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

1. DESCRIPTION OF THE PLAN

The following brief description of the Hannoush Jewelers Profit Sharing and Salary Reduction Plan (“the Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established effective April 1, 1984, and most recently amended effective September 1, 2018. In general, employees of Hannoush Jewelers, Inc., become eligible to participate upon completion of 1,000 hours of service within a period of twelve consecutive months. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

The plan sponsor is Hannoush Jewelers Inc., a Massachusetts For-Profit corporation (“the Employer”).

Contributions

Each year, participants may contribute an amount of their compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants may designate some or all of the contributions as Roth deferral contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant. The Company makes a discretionary match contribution equal to 25% of the first 8% of base compensation that a participant contributes to the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Employer profit sharing option

On an annual basis, the Plan can make a profit-sharing contribution at the option of the plan sponsor’s Board of Directors. There were no profit-sharing contributions during the years ended March 31, 2025 and 2024.

Participant accounts

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contributions and plan earnings. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. All accounts are participant directed.

Notes receivable from participants

Participant loans may be granted based on financial hardship or a specified financial need. Participants can borrow from their fund accounts, a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their account balance, whichever is less. Loan transactions are treated as a transfer to (from) the investment fund and from (to) the participant loan fund. All loans must be repaid within five years; however, a longer term may be granted for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear a reasonable rate of interest. Principal and interest is paid ratably through bi-weekly payroll deductions. The amount of any loans unpaid at the date of termination of employment is treated as a distribution to the participant. There were \$67,231 and \$78,098 in loans outstanding on March 31, 2025 and 2024, respectively.

Rollovers

Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans.

Vesting

Participants are immediately vested in their contributions, non-elective contributions, and actual earnings thereon. Vesting in the Employer's contributions plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

Investment options

Upon enrollment in the Plan, a participant may direct employee contributions into various mutual fund options provided by Empower Annuity Insurance Company of America. Participants may change their investment options at any time.

Payment of benefits

On termination of employment, retirement, the attainment of age 65, death, or disability, a participant or their beneficiary may elect to receive either a lump-sum or installments equal to the value of the participant's vested interest in their account. Participants with a vested balance of \$1,000 or less will receive a lump-sum distribution equal to the value of the vested portion of their account. Participants with a vested account balance that exceeds \$1,000 but did not exceed \$5,000 who do not elect a form of distribution will have their vested balances rolled over to an individual retirement account designated by the Plan administrator. Distributions are subject to the applicable provisions of the Plan agreement.

Forfeited accounts

At March 31, 2025 and 2024, forfeited non-vested account totaled \$9,541 and \$6,079, respectively. These accounts are used first to reduce Plan expenses and then to offset employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management, who are responsible for their integrity and objectivity. These accounting policies conform to generally accepted accounting principles and have been consistently applied in the preparation of the financial statements.

Basis of accounting

It is the Plan's policy to prepare its financial statements on the accrual basis of accounting, which is a basis of accounting generally accepted in the United States of America; consequently, revenues are recognized when earned, and expenses are recognized when the obligation is incurred.

Payment of benefits

Benefits are recorded when payable under the terms of the Plan. Refunds of contributions in excess of the Section 401(b) limits are included in this category.

Investments

Other than the Guaranteed Interest Account (GIA), which is stated at contract value, the Plan's investments are stated at fair value, based on available market quotations. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned.

Fair value

Securities traded on the national securities exchange are valued at the last reported sales price on the last business day of the plan year. Investments traded in the over-the-counter market and listed securities for which no sale was reported on that date are valued at the average of the last reported bid and asked prices.

Accounting Codification Standards provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Accounting Codification Standards are described as follows:

- Level 1 valuations reflect quoted market or exchange prices for the actual or identical assets or liabilities in active markets.
- Level 2 valuations reflect inputs other than quoted prices in Level 1 which are observable. The inputs can include some or all of the following into a valuation model:
 - quoted prices on similar assets in active markets
 - quoted prices on actual assets that are not active
 - inputs other than quoted prices such as yield curves, volatilities, prepayments speeds inputs derived from market
- Level 3 valuations reflect valuations in which one or more of the significant valuation inputs are not observable in an active market, there is limited if any market activity, and/or are based on management inputs into valuation model.

Tax status

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirement of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan has adopted Accounting Standards Codification, "Accounting for Uncertainty in Income Taxes." Accounting Standards Codification prescribes a comprehensive model for the financial statement recognition, measurement, classification and disclosure of uncertain tax positions. Management has not identified any uncertain tax positions and, therefore, no liability has been recorded in the financial statements.

Use of estimates

The preparation of financial statements in conformity with the accrual basis of accounting, which is a basis of accounting other than generally accepted accounting principles in the United States of America, requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual result may differ from those estimates.

Operating expenses

All expenses of maintaining the Plan are paid directly by the Plan sponsor, unless the forfeiture account is used, or a combination of both.

Subsequent events

Management has evaluated subsequent events through November 13, 2025, the date which the financial statements were available to be issued.

3. INVESTMENTS

The following section describes the valuation methodologies the Plan uses to measure the financial instruments at fair value.

Mutual funds

Valuation is done on a daily basis. These values are compared to daily valuations received by the custodian through the National Securities Clearing Corp (NSCC) to ensure the accuracy of the valuation. These assets are considered Level 1 investments.

The Plan maintains policies and procedures to value instruments using the best and most relevant data available. In addition, the Plan has an investment management team that reviews valuation, including independent price validation for certain instruments. Further, in most instances, management develops internal valuations of the assets and instruments held in the Plan.

Guaranteed Interest Account – GIA

Empower Retirement Services (ERS) general investment option for defined contribution plans is a Guaranteed Interest Account (the “GIA”) provided through a group annuity contract (“the Contract”). Under the terms of the Contract, a crediting rate is established for amounts invested in the GIA and participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at Contract Value. Contract Value represents contributions plus credited interest less participant withdrawals and fees. Because the guaranteed investment contract is fully benefit-responsive, a crediting rate is established for amounts invested in the GIA and participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at Contract Value. Contract Value represents contributions plus credited interest less participant withdrawals and fees. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant fair value measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. This investment is valued at contract value as stipulated by Accounting Codification Standards and totaled \$577,008 and \$3,286,003 for the years ended March 31, 2025 and 2024, respectively.

4. PLAN TERMINATION

Although it has not expressed any interest to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants are one hundred percent vested in all their accounts.

5. CERTIFIED INVESTMENTS

Other than the fair value of the guaranteed investment contract and the related adjustment from fair value to contract value for fully benefit-responsive investment contracts, certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, included investments held at March 31, 2025 and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended March 31, 2025, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America, custodian of the Plan. The contract value of the guaranteed investment contract was certified by the custodian.

6. RELATED PARTY TRANSACTIONS

During the normal course of business, the Plan has several arrangements with service providers. These transactions are party in interest transactions under ERISA.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and, that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
