INDEPENDENT AUDITORS' REPORT

To the Trustee and Plan Administrator of the
D/T Carson Enterprises, Inc. Employees' 401(k) Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the D/T Carson Enterprises, Inc. Employees' 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of D/T Carson Enterprises, Inc. NOTE 1 - DESCRIPTION OF THE PLAN

The D/T Carson Enterprises, Inc. Employees' 401(k) Retirement Savings Plan ("the Plan") is a defined contribution plan providing retirement income to eligible employees. The Plan was established April 1, 2001 and was subsequently amended and restated April 1, 2015. The Plan is administered by D/T Carson Enterprises, Inc. (the Company). American United Life Insurance Company (AUL), the custodian of the Plan, is responsible for investing and managing the Plan's assets. The Plan consists of a tax deferred savings program under Internal Revenue Code (IRC) Section 401(k) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective September 1, 2021, the Plan restated their Volume Submitted 401(k) Plan.

The following description of the Plan provides general information. Participants and other interested parties should refer to the plan document for a more complete description of the Plan's provisions.

Eligibility and Participation

The Plan covers all employees of the Company and its related entities; except for temporary employees and those employees covered by a collective bargaining agreement (which does not specifically provide coverage of such employees). Employees are eligible to participate in the Plan on the first day of the month coinciding with or next following having attained age 18 and the completion of three months of service with the Company. Employees are able to commence salary deferrals on the effective date of participation and on the first day of any payroll period after eligibility.

Contributions

Each year, subject to the provisions of the Plan and limitations of the IRC provisions, participants may contribute up to 100% of pre-tax annual compensation; as defined in the plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Participants receive employer matching contributions on a pay period basis. For the years ended March 31, 2025 and 2024, the Company matched 100% of the participants' pre-tax contributions; up to 3% of eligible compensation.

Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions (including those rolled over from another qualifying plan), related matching contributions, an allocation of plan earnings (losses), benefit payments and an allocation of plan expenses. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

The full amount credited to a participant's account shall be fully vested upon attaining normal retirement age, death, or by reason of permanent disability. Participants are always 100% vested in amounts attributable to their salary deferrals. For participants who meet eligibility conditions during any plan year, employer discretionary contributions shall vest at a rate of 20% per year after two years of service, and are 100% vested after six years of service. A year of service is credited upon the completion of at least 1,000 hours of service during the plan year. Hours of service are determined using an equivalency method, participants are credited with 190 hours for each month worked.

Notes Receivable from Participants

In accordance with the plan document, participants are not allowed to borrow funds from their accounts.

Payment of Benefits

The Plan provides for the payment of benefits to the participant or beneficiary at retirement, death, disability, or termination of employment. Participants terminating their employment with the Company or attaining age 59 1/2 are entitled to withdraw all or a portion of their vested account balance. "Hardship" distributions, as outlined in the plan document, are permitted subject to the approval of the Company. Participants who qualify for retirement benefits and withdrawals will receive their benefits in the form of a lump sum cash distribution. Benefits under the Plan shall be distributed solely from the assets of the Trust. The benefit to which a participant is entitled is the benefit that can be provided directly from the participant's vested account balance.

Upon termination, automatic distributions are required for balances of less than \$5,000. Automatic distributions below \$5,000 made without the participant's consent are rolled into an individual retirement account designated by the trustee.

Forfeitures

Forfeitures of employer matching contributions are used to offset plan administrative expenses and reduce the Company's matching contributions. During the years ended March 31, 2025 and 2024, forfeitures of \$23,783 and \$31,433, respectively, were used to reduce employer matching contributions. No forfeitures were used to offset plan administrative expenses during the plan years ended March 31, 2025 and 2024, respectively.

Administrative Expenses

Expenses related to the administration of the Plan, including fees of the independent public accountants, are paid by the Company. The investment options have certain management fees which reduce the overall return on assets. The net appreciation in fair value of investments includes these fees.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

NOTE 3 - SUMMARY OF FINANCIAL DATA CERTIFIED BY THE CUSTODIAN

Management, for the years ended March 31, 2025 and 2024, has elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule was obtained by management and agreed to or derived from information certified as complete and accurate by American United Life Insurance Company (the asset custodian of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

Financial Accounting Standard Board (FASB) Accounting Standard Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Levels 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements

Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from corroborated observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025 and 2024:

Pooled Separate Accounts : Valued at quoted market prices, which represent the net asset value of shares held by the pooled separate accounts at year end. The net asset value of the pooled separate accounts is not a publicly-quoted price in an active market, but it is based on underlying investments, which are traded in an active market. The investment is classified within the Level 2 of the hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into fully benefit-responsive investment contracts with American United Life Insurance Company (AUL). AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the investment contract. The investment contract is presented on the face of the statement of net assets available for plan benefits at contract value which approximates the fair value in arriving at net assets available for plan benefits. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the investment contracts value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at March 31, 2025 and 2024 was \$369,797 and \$587,550, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 3%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Company believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

The investment contracts does not permit the insurance company to terminate the agreement prior to the schedule maturity date.

NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. Investments are managed by AUL. Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of investments. These transactions qualify as party-in-interest transactions for which a statutory exception exemption exists.

NOTE 7 - PLAN TERMINATION

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants will become 100% vested in all Company contributions.

NOTE 8 - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - TAX STATUS

The Company adopted the American United Life Insurance Company Defined Contribution Prototype Plan and Trust, which obtained its latest opinion letter on March 31, 2014. In this letter, the Internal Revenue Service (IRS) states that the Plan is acceptable under Section 401 of the IRC for use by the employers for the benefit of their employees. Although the Plan has been amended since receiving the opinion letter, the Company believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
