## NOTE 1 – PLAN DESCRIPTION

The following description of the Woodruff & Sons, Inc. 401(k)/Profit Sharing Retirement Plan (“the Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering all non-union full-time employees of Woodruff & Sons, Inc. (“the Company”) who have one year of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions: Participants may contribute up to 100% of pretax or after-tax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may contribute a matching contribution to each participant at a discretionary percentage at the option of the Board of Directors. Additional profit sharing contributions may also be made at the option of the Company’s Board of Directors. Contributions are subject to certain limitations. The Company made a profit sharing contribution of \$350,000 to the Plan for the year ended March 31, 2025, and no employer matching contributions.

Participant Accounts: Each participant’s account is credited with the participant’s contribution and an allocation of the Company’s contribution, the Plan’s earnings and forfeitures of employer profit sharing contributions and employer matching contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. “Graded” vesting in the remainder of their account plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Payment of Benefits: On termination of service, a participant may elect to receive a distribution in the form of either a single lump-sum or in substantially equal installments, in an amount equal to the value of the participant’s vested interest in his or her account. In certain circumstances, participants may make “hardship withdrawals” as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Forfeitures: Forfeited balances of terminated participants’ nonvested accounts are reallocated to eligible participants, used to reduce employer contributions, or used to pay plan expenses.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments, other than the fully benefit responsive investment contract, are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount plan participants generally receive when executing transactions under the terms of the contract and plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. All pooled separate accounts held by the Plan at March 31, 2025 and 2024, totaling \$7,153,166 and \$7,583,241, respectively, were measured at net asset value using the practical expedient and therefore not classified within the fair value hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES** (Continued)

Pooled Separate Accounts: Participants may direct the investment of their account into various sub-accounts of American United Life Insurance Company Separate Account II (“Separate Account II”), each of which is also a pooled separate account of American United Life Insurance Company (“AULIC”). The fair values of units of participation in Separate Account II and in each of the sub-accounts of Separate Account II are based on the net asset values, as a practical expedient, of the funds reported by the fund managers as supported by the unit prices of actual purchases and sales transactions occurring as of or close to the financial statement date. The sub-accounts offer each participant a full spectrum of investment options, from core funds for broadly diversified portfolios to specialty funds for complementing existing strategies, which all depend on the level of risk the participant prefers. Additionally, the Plan also offers target retirement date sub-accounts within Separate Account II. These are a series of diversified funds, each of which has a pre-determined underlying asset mix that will adjust over time toward a more conservative allocation until the selected target date. The pooled separate accounts provide for daily redemptions by the Plan with no advance notice requirements and have redemption prices that are determined by the fund’s net asset value per share or per unit, as applicable.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Payment of Benefits: Benefits are recorded when paid.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks as well as the risks associated with global events. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 – TRADITIONAL INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan holds a traditional fully benefit-responsive investment contract with AULIC that is reported at contract value. The contract value of the Plan’s fully benefit-responsive investment contract at March 31, 2025 and 2024, respectively, was \$4,093,729 and \$4,094,098. AULIC maintains the contributions in a general account. AULIC’s general account is credited with earnings based upon the contractual crediting interest rate and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. There are no reserves against contract values for credit risk of the contract issuer or otherwise.

**NOTE 3 – TRADITIONAL INVESTMENT CONTRACT WITH INSURANCE COMPANY** (Continued)

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances may include payments needed in excess of a stated buffer fund, plan withdrawals that exceed 20% of the beginning Deposit Account balance over a rolling twelve-month period, Company mergers, sales of assets, mass layoffs, the implementation of any early retirement incentive programs, spin-offs, bankruptcy, complete or partial plan terminations, or corporate restructuring as specified by the individual contract.

The contract limits the circumstances under which the issuer may terminate the contract. Examples of circumstances that would allow the issuer to terminate the contract include plan termination, failure to agree to plan amendments necessary to comply with laws/regulations, failure of the contract holder to provide information required by the contract, contract holder creating a competing plan investment option, or upon receipt of 30 business days' prior written notice as specified by the individual contracts. If one of these events were to occur, the issuer could terminate the contract at amounts less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

Prior to October 15, 2021, contributions made into the contract were directed into the AUL Fixed Fund. Effective October 15, 2021, the AUL Fixed Fund was closed to future contributions. Effective October 15, 2021, all future contributions into the contract are directed into the AUL Stable Value Account. The balance of the AUL Fixed Fund was \$3,579,824 and \$3,679,495 at March 31, 2025 and 2024, respectively. The balance in the AUL Stable Value Fund was \$513,905 and \$414,603 at March 31, 2025 and 2024, respectively. The crediting interest rates of the contract are based on agreed-upon formulas with the issuer, as defined in the contract agreement, but cannot be less than 4% for the AULIC Fixed Fund and 0% for the AULIC Stable Value Account as specified by the contract. Such interest rates are reviewed on an annual basis for resetting. The key factors that influence future interest crediting rates could include the following: the level of market interest rates; the amount and timing of participant contributions, transfers and withdrawals into/out of the contracts; and the duration of the underlying investments backing the contracts.

**NOTE 4 – CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at March 31, 2025 and 2024, and net appreciation in fair value of investments and interest for the year ended March 31, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by American United Life Insurance Company (AUL).

**NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of the Plan's termination, participants will become 100% vested in their employer contributions and earnings thereon.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

The Plan's investments with AULIC are considered to be party-in-interest investments. Fees paid to AULIC are considered party-in-interest transactions. Some administrative expenses of the Plan are paid directly by the Company.

**NOTE 7 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated August 19, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended from the original prototype document, plan management believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 31, 2025 and 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 8 – SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through January 14, 2026, which is the date the financial statements were available to be issued.

The investment options of the Plan include various portfolios within an AUL separate account. The separate account in turn invests in investment portfolios of certain open-end management investment companies. AUL receives indirect compensation from these investment companies for the services provided by AUL.

The compensation received by AUL is computed by each investment company by multiplying the daily account balance of the AUL separate account's interest in a particular portfolio by a predetermined percentage rate negotiated with the investment company. This indirect compensation is not charged to the plan or participants accounts but is paid directly by the investment company.

The investment company, the underlying investment portfolio, and the annual compensation percentages are shown below.
