Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The Professional Musicians, Local 47 and Employers’ Health and Welfare Fund (the “Fund”) is a multiemployer welfare benefit plan providing benefits to participants and their dependents. All benefits are provided through insurance contracts. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The Fund collects contributions from employers under terms of the Collective Bargaining Agreement with the Musicians' Union Local 47. The Fund also receives a co-payment of the aggregated benefit premium for health benefits, premiums on a self-payment basis for continued benefit eligibility (“COBRA”), and dependent premiums for coverage subject to the terms of the Fund.

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE FUND.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Fund were prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Fund administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results may differ from those estimates.

C. Contributions

Employer contributions are contributions made by employers as a percentage of gross wages paid to members during the year. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year. Participant contributions are contributions made by employees for coverage during the year. Participant contributions received in advance of the month worked or the month of coverage are reported as deferred participant contributions.

D. Employer Payroll Compliance Program

Employer remittance reports were accepted as submitted, without examination or verification of employers’ payroll records. The system of internal control provides for examination of employers’ payroll records under a separate payroll compliance program.

E. Investment Valuation and Income Recognition

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 provides the framework for measuring fair value. That framework provides a fair value

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 - Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

E. Investment Valuation and Income Recognition (Continued)

Realized gains or losses from the sale of investments and unrealized appreciation in the fair value of investments are reported as net appreciation of investments. Investment purchases and sales are recorded on the trade date. Investment income, realized gains and losses on sale of investments and investment expenses are recorded on the accrual basis.

F. Benefits

Benefit obligations reported on the statements of benefit obligations consists of premiums payable, which is an estimate of premiums for coverage during the year, unpaid at the end of the year; future benefits based on participants' accumulated eligibility and carry-forward contribution bank is an estimate of future benefits costs to be incurred based on participants' accumulated eligibility credits and participants' contribution bank. The statements of changes in benefit obligations reports the components of the changes in benefit obligations.

NOTE 3 - TAX-EXEMPT STATUS

No provision for federal or state income tax is made. The Fund has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701(i).

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Fund and recognize a tax liability if the Fund has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Fund is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - FUND ADMINISTRATION
