**NOTE 1: DESCRIPTION OF PLAN**

The following description of Elm Street Development, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering eligible employees of Elm Street Development, Inc., and Legend Management Group, LLC (Company). The Plan was established on January 1, 1998. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan's investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the plan administrator.

The Company retains Charles Schwab Trust Bank as the corporate trustee and The Newport Group as the third-party administrator.

**Eligibility** - Employees, excluding collectively bargained (union) employees, nonresident aliens, and leased employees, age 21 or older who complete six months of service may elect to contribute salary deferral contributions beginning on the first day of the month following the completion of the eligibility requirements. Employees become eligible to share in the safe harbor, employer matching, and nonelective profit-sharing contributions after one year of service and may enter immediately for matching and nonelective profit-sharing contributions.

**Contributions** - Each year, participants may contribute 100% of pretax annual compensation up to the maximum contribution permitted by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of salary deferrals, employer contributions, and rollover accounts into a diversified menu of investment options offered by the Plan. The Company will make safe harbor matching contributions in an amount equal to the sum of 100% of a participant's elective deferrals that do not exceed 3% of eligible compensation, plus 50% of elective deferrals that exceed 3% but do not exceed 5% of eligible compensation. Additional profit-sharing amounts may be contributed at the option of the Company's individual Trustee. Contributions are subject to limitations to comply with the nondiscrimination requirements of the Internal Revenue Code (IRC).

**Participant Accounts** - Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and plan earnings. Certain administrative expenses are paid from the earnings of the investment alternatives held by the participants. Allocations are based on the eligible participant's earnings, account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTE 1: DESCRIPTION OF PLAN - CONTINUED**

*Vesting* - Participants are immediately vested in their voluntary contributions plus actual earnings thereon and safe harbor contributions from the employer. Vesting in additional employer discretionary matching and nonelective profit-sharing contributions is based on years of continuous service. After two years of continuous service, a participant becomes 40% vested in matching contributions in the Plan. The vesting percentage increases by 20% each year until the participant becomes fully vested in his or her account after five years.

*Notes Receivable from Participants* - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding balance of all loans made from the Plan during the one-year period ending on the day before the loan is made, or 50% of their vested account balance. Loan terms range from one to five years or up to 15 years for the purchase of a primary residence. Only one loan can be outstanding at any given time. If the participant has an existing loan, another loan cannot be granted until the existing loan is paid in full. Existing loans cannot be refinanced, and a second loan cannot be obtained for the purpose of paying off the existing loan. Loans are secured by the balance in the participant's account and bear a fixed rate of interest equal to the prime rate plus 1%. Principal and interest are paid ratably through semi-monthly payroll deductions. Upon termination of employment, the loan balance is due and payable immediately, or the outstanding balance is considered a taxable distribution.

*Payment of Benefits* - Upon termination of service due to death, disability, retirement (age 62), or separation from service, a participant may elect to receive an amount equal to the value of his or her eligible account balance paid through a single lump-sum payment or amount equal to the value of the vested interest in his or her account, partial withdrawal for required minimum payments, or delay withdrawal until a future date, if the account balance is over \$5,000. A participant may elect to receive the benefit directly or through a direct rollover to an individual retirement account or another eligible retirement plan. An active participant who has reached age 59½ may withdraw all or a portion of his or her entire account while still employed with the Company. A participant may request a withdrawal of all or a portion of his or her rollover account at any time.

After separation from service a participant may delay withdrawal until a future date, but the plan administrator may automatically distribute balances of terminated participants that do not exceed \$1,000. If a participant has an account balance of \$1,000 or less and the participant does not make an affirmative election to request a distribution, the vested account balance will be paid in a lump-sum distribution.

***Payment of Benefits - Continued***

As required under Section 401(a)(9) of the IRC, a participant who is not a five percent or more owner of the Company must begin receiving required minimum distributions from the Plan by April 1 of the calendar year following the later of (1) the calendar year following the year in which the participant reaches age 73, or (2) the calendar year in which the participant retires.

***Hardship Withdrawals*** - Participants may withdraw their employee pretax contributions, employer matching, and profit-sharing contributions in the form of a hardship withdrawal to satisfy an immediate financial need as defined by the Plan. The participant must first exhaust all other assets reasonably available prior to obtaining a hardship withdrawal.

***Forfeitures*** - Upon termination from service, the nonvested portion of a participant's account is forfeited. Forfeitures can be first used to reduce administrative expenses, and then to reduce future employer contributions. As of December 31, 2024 and 2023, the forfeited nonvested accounts totaled \$258 and \$22, respectively. Forfeitures totaling \$3,805 and \$2,880 were used to reduce employer contributions in 2024 and 2023, respectively.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting*** - The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates*** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition*** - Investments are reported at fair value. Fair value is the price that would be received for the sale of an asset, or paid for the transfer of a liability, in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the Trustees. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED**

*Participant Contributions Receivable* - As of December 31, 2024 and 2023, the Plan had \$43,386 and \$44,113, respectively, in contributions receivable from participants.

*Employer Contributions Receivable* - As of December 31, 2024 and 2023, the Plan had \$29,590 and \$24,503, respectively, in contributions receivable from the employer.

*Notes Receivable from Participants* - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If the participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

*Payment of Benefits* - Benefits are recorded when paid.

*Administrative Expenses* - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Costs associated with participant-initiated transactions are paid by the respective participants' accounts.

*Subsequent Events* - The Plan's policy is to evaluate events and transactions subsequent to its year end for potential recognition in the financial statements or disclosure in the notes to the financial statements. The plan administrator has evaluated events and transactions through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

**NOTE 3: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used as of December 31, 2024 and 2023.

***Registered Investment Companies (Mutual Funds)*** - Registered Investment Companies (Mutual Funds) are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan purports its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5: RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Participant loan origination fees are paid out of the relevant participants' accounts. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

**NOTE 6: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their employer contributions. Any unallocated forfeitures would be allocated to participant accounts and distributed in such a manner as the Company may determine.

**NOTE 7: TAX STATUS**

The underlying prototype profit-sharing plan has obtained an opinion letter dated November 30, 2020, from the Internal Revenue Service (IRS), which stated that the form of the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since it received its last opinion letter, the plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, maintains that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan, and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS or DOL. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's federal Form 5500 is subject to examination by the IRS and DOL, generally for the three years after it was filed.

**NOTE 8: RISKS AND UNCERTAINTIES**

The Plan invests in various registered investment companies (mutual funds). Registered investment companies are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in their values will occur in the near term, and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**NOTE 9: COMMITMENTS AND CONTINGENCIES**

In the normal course of business, there may be various commitments and contingencies outstanding, which are not reflected in these financial statements. In the opinion of the plan administrator, the outcome of such events, if any, would not have a material effect on the Plan's financial position or operations.

The Plan was amended effective October 1, 2024, to recognize prior service with ESDC II, Inc. for purposes of eligibility and vesting.

**NOTE 11: SUBSEQUENT EVENTS**

Subsequent to year-end, effective January 1, 2025, the Plan was amended and restated under Newport Group's non-standardized defined contribution pre-approved plan document. The new adoption agreement confirms the Plan's participation in a multiple employer plan (MEP), and does not identify the Employer as part of a controlled group, whereas the prior (2022) adoption agreement reflected controlled-group status.
