NOTES TO FINANCIAL STATEMENTS MARCH 31, 2025 AND 2024

1. DESCRIPTION OF PLAN

The following description of OUP USA Thrift Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a voluntary contributory thrift plan, established on January 1, 1966 to provide retirement benefits for employees of the United States operations of the Chancellor, Masters and Scholars of The University of Oxford, operating as OUP USA (the "Plan Sponsor" or "Employer") and their beneficiaries. The Plan is designed to conform to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Administrative Committee oversees the Plan. The Administrative Committee consists of the individuals required under the Plan document and as appointed by the President of OUP USA. Fidelity Management Trust Company (Fidelity) is the trustee and custodian of the Plan and Fidelity Workplace Services, LLC (FWS) is the recordkeeper of Plan assets.

Eligibility

All employees who have completed one year of eligible service (1,000 hours) were eligible to become members of the Plan. Effective August 31, 2020, the Plan was amended to freeze the Plan effective September 4, 2020. The Plan was frozen to new participants and to resumption of participation effective August 31, 2020 and no contributions may be made or received with respect to amounts paid after that date. The Plan was also amended to discontinue the automatic increase feature for paychecks issued after April 3, 2020.

Contributions

Participating employees could elect to make contributions to the Plan from 1% to 12% of their gross earnings (through freeze date). The Employer contributed a minimum of 25% of an employee's contributions. The Employer could also elect to contribute an additional supplemental match equal to the percentage of an employee's basic contribution. To receive this match, the employee had to be employed as of the last day of the Plan year. Contributions were subject to annual limits established by the Internal Revenue Service. Participants directed the investment of all contributions made on their behalf into various investment options offered by the Plan.

1. DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with an allocation of (a) Plan earnings (losses) and (b) Plan expenses. Allocations are based on participant account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in their account balances.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balances. The notes are secured by the balance in the participant's account and bear interest rate at the prime rate in effect as of the date of the loan issuance. Notes must be repaid within five years, unless the funds borrowed are used toward the purchase of a primary residence, in which case the note may be repaid over 15 years. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

A request for a distribution may be made by a participant at any time. A participant or their beneficiary may elect to receive either a total or partial lump-sum payment of their account balance, installment payments over a period that does not exceed the life expectancy of the participant, or payment in the form of an annuity.

Administrative Expenses

Administrative expenses paid by the Plan include investment advisory, auditing, legal, recordkeeping and transaction fees. Expenses not paid by the Plan are paid by the Plan Sponsor.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investments

Investments are reported at fair value (except for fully benefit responsive investment contracts, which are reported at contract value). Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

All investments are participant directed.

Fair Value Measurement - Definition and Hierarchy

Accounting Standards Codification (ASC) Section 820 establishes a framework for measuring fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Section 820 are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input (with level 3 being the lowest) that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

Registered investment companies: Registered investment companies, which are valued at the net asset value of shares held at year end based on quoted market prices in active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no changes in fair value methodology during 2025 and 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the amounts of net assets available for benefits and the amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, political, currency, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

5. INVESTMENTS AT CONTRACT VALUE

The Plan has fully benefit-responsive contracts with a Stable Value Fund, issued under a group fixed annuity contract by The Lincoln National Life Insurance Company. Contract value is the relevant measure for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Stable Value Fund invests in a diversified portfolio of fixed income instruments. Contract value, as reported by Lincoln Investment Management Company (“LIMCO”), represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The issuing insurance company is contractually obligated to repay principal and interest at a specified rate to the Plan. Interest is credited to the contract at interest rates that reflect the performance of the underlying portfolio, but are guaranteed to be no less than 1%. Such interest rates are reset quarterly based on the underlying portfolio and current new money investment yields and are guaranteed for each 3-month period, and have a guaranteed minimum crediting rate of 1%. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. Participants will receive the principal and earnings credited to their accounts on withdrawal for allowed events. These events include transfer to other Plan investment options, and payments because of retirement, termination of employment, disability, death and in-service withdrawals as permitted by the Plan.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan’s termination, participants will remain 100% vested in their accounts.

7. INCOME TAX STATUS

The IRS has determined and informed the Plan by a letter dated February 11, 2016, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

8. PARTY-IN-INTEREST TRANSACTIONS

Fidelity is the trustee and custodian of the Plan and FWS is the recordkeeper of the Plan’s assets. As such, transactions between Fidelity, FWS, and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants are party-in-interest transactions.

9. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agreed to Form 5500 in total as of and for the years ended March 31, 2025 and 2024.

10. SUBSEQUENT EVENTS

Subsequent events have been evaluated through January 14, 2026, which is the date the financial statements were available to be issued.
