# OUP USA TAX DEFERRED ANNUITY PLAN

## NOTES TO FINANCIAL STATEMENTS MARCH 31, 2025 AND 2024

---

### 1. DESCRIPTION OF PLAN

The following description of OUP USA Tax Deferred Annuity Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan, established on October 1, 1987 to provide retirement benefits for employees of the United States operations of the Chancellor, Masters and Scholars of The University of Oxford, operating as OUP USA (the "Plan Sponsor" or "Employer") and their beneficiaries. The Plan is designed to conform to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Administrative Committee oversees the Plan. The Administrative Committee consists of the individuals required under the Plan document and as appointed by the President of OUP USA. Teachers Insurance and Annuity Association (TIAA), College Retirement Equities Fund (CREF), and The Lincoln National Life Insurance Company (Lincoln) are the insurance companies with respect to certain investments of the Plan. Fidelity Management Trust Company (Fidelity) is the trustee and custodian of the Plan and Fidelity Workplace Services, LLC (FWS) is the recordkeeper of the Plan's assets.

Effective September 1, 2020, the Plan was restated through the adoption of a 403(b) Volume Submitter Plan. With this restatement, the Plan Sponsor added an employer matching contribution provision to the Plan. Also with this restatement, the Plan Sponsor moved the 7% non-elective employer contribution that was previously made to the OUP USA Defined Contribution Retirement Plan to the Plan for all participants hired or rehired on or after September 1, 2020. All participants hired before September 1, 2020 continued to receive the 7% non-elective employer contribution in the OUP USA Defined Contribution Retirement Plan until April 1, 2023, when the OUP USA Defined Contribution Retirement Plan was amended to temporarily suspend employer contributions. The 7% non-elective employer contribution previously made to the OUP USA Defined Contribution Retirement Plan for certain eligible participants hired or rehired prior to September 1, 2020, as defined by the plan document, are now made to the Plan, effective April 1, 2023.

#### **Eligibility**

Eligible employees of the Plan Sponsor, as defined in the Plan document, may begin participation in the Plan upon their hire. Participation in the Plan is entirely voluntary.

#### **Contributions**

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined by the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans as defined under Section 402 of the Internal Revenue Code (the Code).

## 1. DESCRIPTION OF PLAN

### **Contributions (Continued)**

The Plan provides for automatic employee deferrals, which start at 3% of eligible compensation and increase 1% annually, up to a 6% deferral. An employee must opt out of participation if they opt not to contribute. Participants direct the investment of their contributions into various investments offered by the Plan. Annual contributions to the Plan may not exceed the amount permitted under Section 415 of the Internal Revenue Code.

Effective September 18, 2020, the employer contributes matching contributions equal to 50% of an eligible employee's deferrals (up to 6% of compensation). In addition, prior to April 1, 2023, the employer made contributions to the Plan for each eligible participant hired or rehired on or after September 1, 2020 based upon 7% of their compensation as defined by the Plan document. Effective April 1, 2023, the employer makes contributions to all eligible plan participants based upon 7% of their compensation as defined by the Plan document.

### **Participant Accounts**

Each participant's account is credited with the (1) participant's deferrals, (2) employer's matching contributions, (3) employer non-elective contributions, as applicable, and (4) allocation of (a) Plan earnings (losses) and (b) Plan expenses. Allocations are based on participant account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately fully vested in any voluntary employee contributions.

Effective September 1, 2020, for both the employer matching contribution and the employer non-elective contribution, participants hired on or after September 1, 2019 are fully vested after the completion of three years of service or the earlier of normal retirement date, death or disability. Participants hired on or before August 31, 2019 become fully vested in employer non-elective contributions after the completion of three years of service or the earlier of normal retirement date, death or disability and are fully vested in employer matching contributions upon receipt.

### **Payment of Benefits**

Upon termination of employment, retirement, death, disability, or reaching 59 ½ years of age, a participant or their beneficiary may elect to receive either a total or partial lump-sum payment of their account balance, installment payments over a period that does not exceed life expectancy of the participant, or payment in the form of an annuity.

In addition, participants can withdraw funds during employment through the use of a hardship distribution. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

### **Notes Receivable from Participants**

Participants can borrow against their account balance a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Notes receivable are secured by the balance in the participant's account and bear an interest rate at the prime rate. Notes must be repaid within five years, unless the funds borrowed are used toward the purchase of a primary residence, in which case the note may be repaid over 15 years. Principal and interest are paid ratably through payroll deductions.

## 1. DESCRIPTION OF PLAN (Continued)

### **Administrative Expenses**

Administrative expenses paid by the Plan include investment advisory, recordkeeping and transaction fees. Expenses not paid by the Plan are paid by the Plan Sponsor.

### **Forfeitures**

Forfeitures of non-vested account balances are used to reduce the Employer's contributions or pay plan expenses. No forfeitures were used to reduce the Employer's contributions in 2025 and 2024. At March 31, 2025 and 2024, unallocated forfeitures amounted to approximately \$455,000 and \$151,000, respectively.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

### **Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Investments**

Investments are reported at fair value (except for fully benefit responsive investment contracts, which are reported at contract value). Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

All investments are participant directed.

### **Fair Value Measurement - Definition and Hierarchy**

Accounting Standards Codification (ASC) Section 820 establishes a framework for measuring fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC Section 820 are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Fair Value Measurement - Definition and Hierarchy (Continued)

- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input (with level 3 being the lowest) that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

*Registered investment companies:* Registered investment companies are valued at the net asset value of shares held at year end based on quoted market prices in active markets.

*Pooled separate accounts:* The fair values of interest pooled in separate accounts are valued at the net asset value of shares held at year end based on quoted market prices in active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no changes in fair value methodology during 2025 and 2024.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the amounts of net assets available for benefits and the amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

### Contributions Receivable and Allowance for Credit Losses

The Plan records a receivable for employer contributions that are remitted to the Plan subsequent to the Plan's year-end. The Plan considers an expected allowance for credit losses that is updated to reflect any changes in credit risk since the receivable was initially recorded. The estimated allowance for credit losses is based on historical, current, and future conditions.

The Plan has not experienced any historical credit losses relative to employer contributions receivable, current and future economic conditions are not expected to change relative to historical financial information, and the full amount outstanding was received subsequent to year end. Therefore, management has determined that no allowance for credit losses was necessary as of March 31, 2025 and 2024.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, political, currency, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

## 3. FAIR VALUE OF FINANCIAL INSTRUMENTS

## **5. INVESTMENTS AT CONTRACT VALUE**

The Plan has fully benefit-responsive contracts with TIAA and a Stable Value Fund, issued under a group fixed annuity contract by The Lincoln National Life Insurance Company. Contract value is the relevant measure for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Stable Value Fund invests in a diversified portfolio of fixed income instruments. Contract value, as reported by Lincoln Investment Management Company ("LIMCO"), represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The issuing insurance company is contractually obligated to repay principal and interest at a specified rate to the Plan. Interest is credited to the contract at interest rates that reflect the performance of the underlying portfolio, but are guaranteed to be no less than 1%. Such interest rates are reset quarterly based on the underlying portfolio and current new money investment yields and are guaranteed for each 3-month period, and have a guaranteed minimum crediting rate of 1%. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. Participants will receive the principal and earnings credited to their accounts on withdrawal for allowed events. These events include transfer to other Plan investment options, and payments because of retirement, termination of employment, disability, death and in-service withdrawals as permitted by the Plan.

TIAA maintains Plan contributions for the fully benefit-responsive contracts in separate accounts. The accounts are credited with contributions and earnings on the underlying investments and are charged for Plan withdrawals. Earnings on the underlying investments are guaranteed by TIAA at a rate of interest of 3%. When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified rate of interest, is guaranteed by TIAA's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years.

## **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their accounts.

## **7. INCOME TAX STATUS**

The Plan Sponsor has adopted a volume submitter plan document that has received an advisory letter from the IRS dated August 7, 2017, stating that the form of the volume submitter plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the volume submitter plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRS and, therefore, believes that the Plan is qualified tax-exempt. Therefore, no provision for income tax has been included in the Plan's financial statements.

## **8. PARTY-IN-INTEREST TRANSACTIONS**

TIAA, CREF and Lincoln are the insurance companies with respect to certain investments of the Plan. Fidelity is the trustee and custodian of the Plan and FWS is the recordkeeper of the Plan's assets.

As such, transactions between TIAA, CREF, Lincoln, Fidelity, FWS and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants are party-in-interest transactions.

## **9. RECONCILIATION TO FORM 5500**

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agreed to Form 5500 in total as of and for the years ended March 31, 2025 and 2024.

## **10. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through January 14, 2026, which is the date the financial statements were available to be issued.
