## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator

WCMCAA 403(b) Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of WCMCAA 403(b) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of WCMCAA 403(b) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 31, 2025 and 2024, and for the year ended March 31, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

## Notes to Financial Statements

March 31, 2025

### **1. Description of the Plan**

The following brief description of the WCMCAA 403(b) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

#### **General**

The Plan is a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established effective April 1, 1999. The Plan sponsor is West Central Missouri Community Action Agency (the Company).

Employees who normally work more than 20 hours per week are eligible to participate in the Plan on their date of hire. Employees are eligible to participate in the employer matching portion of the Plan after three months of service on the next semi-annual entry dates of April 1 and October 1.

Complete information regarding employee eligibility is described in the plan documents, summary plan descriptions, and adoption agreement. Employee participation in the Plan is voluntary.

#### **Contributions**

Employees may contribute up to 100 percent of their eligible compensation or the amount permitted by Internal Revenue Service (IRS) regulations, which was limited to \$23,000 in 2024, the year in which the majority of the Plan year occurred. Employees who meet certain age requirements are also permitted to make catch-up contributions. The Plan also permits rollover contributions.

The Company may make discretionary matching contributions as outlined by the Plan agreement. During the 2025 Plan year, the Company made matching contributions of fifty percent of employee deferrals up to six percent of eligible compensation. All contributions are subject to maximum amounts as permitted by the Internal Revenue Service (the IRS).

#### **Participant Accounts**

All Plan investments are participant directed. Plan participants have the option of having their contributions invested in a variety of pooled separate accounts or a fixed account.

Each participant's account is credited with the participant's contributions, and allocations of (a) the Company's contributions, (b) Plan earnings or losses, and (c) charged with distribution administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Under the provisions of the Plan, participants are immediately 100 percent vested in their contributions plus actual earnings thereon. Vesting in the Company contributions portion of their accounts plus earnings thereon are 100 percent vested upon contribution.

#### **Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account or in installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account. If the participant's balance is below \$5,000, the vested account balance may only be distributed in lump sum payment. In-service distributions are permitted after age 59 ½. Hardship distributions are not permitted.

#### **Administrative Expenses**

Substantially all the costs of administering the Plan are paid by the Company. Certain costs such as distribution fees are paid by participants.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants would remain vested in their account balances.

#### **2. Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The financial statements are prepared on the accrual basis of accounting.

##### **Valuation of Investments and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The fixed income account is valued at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value approximates fair value, which is calculated at liquidation value based on an actuarial formula as defined under the terms of the contract. There are no unobservable inputs. There is a one year restriction on redemption of the entire investment in this fund, although there are no restrictions on participant directed investments.

Purchases and sales of securities are accounted for on a trade-date basis. Dividend income and interest from investments is included with net appreciation on the Plan's investments to be shown as net investment earnings on the financial statements. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

##### **Benefits**

Benefits are recorded when paid.

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Distribution fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

##### **Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **3. Investment Information Certified by Insurance Company**

All investment information disclosed in the accompanying financial statements and schedule, including investments held at March 31, 2025 and 2024, and net appreciation in fair value of investments, interest income, and dividends for the year ended March 31, 2025, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by American United Life Insurance Company, the insurance company of the Plan. All investments are participant directed.

#### **4. Fair Value Measurements**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

#### 4. Fair Value Measurements (continued)

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Pooled separate accounts invest directly in the underlying mutual funds (as indicated by the name of the pooled separate accounts which mirror the names of the underlying mutual funds). The pooled separate accounts with underlying mutual fund investments are valued based on the observable NAV of the underlying investment. There are no restrictions on the redemption of these investments.

#### 5. Group Annuity Contract

The Plan maintains a traditional fully benefit-responsive guaranteed investment contract with American United Life Insurance Company (AUL), which contains both the fixed income account and stable value account, totaling \$239,002 for 2025 and \$312,369 for 2024. AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

#### **5. Group Annuity Contract (continued)**

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

#### **6. Income Tax Status**

On November 22, 2017, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since receiving the determination letter; however, the plan administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. The plan sponsor has indicated it will take any necessary steps to maintain the tax-qualified status of the Plan.

Accounting principles generally accepted in the United States require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position more likely than not, would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 31, 2025, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **7. Administration of Plan Assets**

The Plan's assets are held by the insurance company of the Plan. Employee contributions are held and managed by the insurance company, which invests cash received, interest, and dividend income and makes distributions to participants. The record keeper of the plan administers the payment of interest and principal on the participant notes receivable.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

#### **8. Related Party Transactions**

As noted in Notes 1 and 7, the Plan has a number of service providers. Such parties are parties-in-interest under ERISA.

#### **9. Subsequent Events**

Management has evaluated all subsequent events through January 14, 2026, which represents the date the financial statements were available to be issued.
