Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted, and the application of existing policies was not changed during year. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. There were no significant estimates in the financial statements.

The financial statement disclosures are neutral, consistent, and clear.

Auditors are required to use professional judgment to identify areas of the audit that have a high risk of material misstatement and perform special audit consideration in those areas. Within our audit, we focused additional consideration in the following areas below:

- Management override of controls
- Improper revenue recognition

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. There were no misstatements detected as a result of audit procedures that were more than trivial.

There were no known uncorrected misstatements that were more than trivial.

Reportable Findings

We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated as of the date of the audit report.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

Our responsibility for the ERISA-required supplementary schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplementary schedule, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplementary schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Appendix II

Matters for Management's Consideration

In planning and performing our audit of the financial statements of the Plan as of and for the year ended March 31, 2025, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

However, during our audit we became aware of matters for management's consideration that are opportunities for correcting noncompliance and strengthening internal controls. This letter does not affect our report dated January 13, 2026, on the financial statements of the Plan. Our comments and recommendations regarding those matters are:

Incorrect Application of Roth Contribution Election

During our testing of participant contributions, we noted that one participant did not receive Roth deductions on the final payroll dated June 28, 2024. Plan management initially believed the participant had elected a 0% Roth contribution prior to termination; however, the documentation reviewed was for a different participant. At the time of our audit, the Plan had not corrected this error or adjusted the participant's account. We recommend the Plan review the correct election for the affected participant and implement procedures to ensure participant elections are accurately matched to payroll records prior to processing payroll.

Employer Match Contributions Omitted for Participant

During our testing of employer contributions, we noted that one participant did not receive employer match contributions on the payrolls dated December 13, 2024, and December 27, 2024. The Plan management indicated they are unaware of why this occurred and, as of the date of our audit, the issue has not been corrected. We recommend the Plan investigate the cause of the missed match contributions, determine the correct amount owed to the participant, and implement controls to ensure employer match contributions are applied accurately and timely in accordance with plan provisions.
