## INDEPENDENT AUDITOR'S REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of C.J. Coakley Co., Inc. 401(k) & Davis Bacon Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Notes to Financial Statements

#### Note 1. Plan Description

The following description of the C.J. Coakley Co., Inc. 401(k) & Davis Bacon Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution and Davis Bacon plan covering eligible employees of C.J. Coakley Co., Inc. (the "Company"). Eligible employees may participate in the 401(k) and Davis Bacon portion of the Plan upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). A Committee made up of the Plan's management is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

##### Contributions

Each year, participants may elect a pre-tax salary deferral and/or a Roth salary deferral contribution of 1% to 75% of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution Plans.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and one fully benefit-responsive investment contract as investment options for participants.

Each year, the Company may make a discretionary matching contribution of a percentage of participants' elected salary deferrals with that percentage being determined by the Company each year. Participants that are 21 years of age and have completed one year of service are eligible to receive a matching contribution. The Company may also make a discretionary profit sharing contribution for those participants that are 21 years of age, have completed a year of service during the Plan year and are actively employed on the last day of the Plan year. The matching and discretionary Company contributions are invested based on options chosen by the participant. For the year ended December 31, 2024, the Company made discretionary profit sharing contributions totaling \$183,554. The Company did not make any matching contributions for the year ended December 31, 2024. Contributions are subject to certain limitations.

The Company will make a Prevailing Wage Contribution on behalf of each participant who performs services subject to the Services Contract Act, Davis-Bacon Act or similar Federal, State or Municipal Prevailing Wage Law. The Prevailing Wage Contribution shall be an amount equal to the balance of the fringe benefit payment for health and welfare for each participant (after deducting the costs of cash differential payments for the participant) based on the hourly contribution rate for the participant's employment

## Notes to Financial Statements

classification. Notwithstanding anything in the Plan to the contrary, the Prevailing Wage Contribution shall be fully vested and shall not be subject to any age or service requirements set forth in the Plan.

A Prevailing Wage law is any statute or ordinance that requires the employer to pay its employees working on public contracts at wage rates not less than those determined pursuant to that statute or ordinance for the geographical area where that contract is performed.

Amounts allocated or contributed on behalf of a participant for a Plan year shall be reduced by the Prevailing Wage Contribution made on behalf of such participant. The remaining Prevailing Wage Contribution, if any, shall be considered a Qualified Non-elective Contribution.

For the year ending December 31, 2024, the contributions made on behalf of the participants by the Sponsor for the prevailing wage contributions were \$372,373.

### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, if any, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. Participant accounts are also charged with an allocation of administrative expenses which are allocated on either a pro rata or per capita basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately 100% vested in their 401(k) contributions and the company's Davis Bacon contribution plus actual earnings thereon. Vesting in the Company's 401(k) matching and profit sharing contributions portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

### Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$2,500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest rates ranging from 4.25% to 9.50% which are commensurate with local prevailing rates. Effective January 1, 2023, the Plan was amended to change the interest rate equal to 1% above the prime rate. Principal and interest are paid ratably through payroll deductions.

### Distribution of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or an annuity as described in the Plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

## Notes to Financial Statements

Vested account balances of a participant, which do not exceed \$5,000, will be paid out in a single lump-sum payment as soon as possible following the event that entitles the participant to a distribution.

The Plan also allows pre-retirement distributions. A participant that has attained the age of 59 ½ years and has not severed employment may elect to direct the Trustee to distribute all or a portion of their fully-vested account balance. The participant will continue to be eligible to participate in the Plan on the same basis as any other employee.

### **Forfeited Accounts**

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$367, respectively. These accounts may be applied to reduce future employer contributions or pay administrative expenses. Forfeitures of \$5,661 were used to pay administrative expenses for the year ended December 31, 2024.

## **Note 2. Summaries of Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gain and losses on investments bought and sold as well as held during the year.

## Notes to Financial Statements

### Investment Contracts

Investments held by a defined contribution plan are required to be reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transaction under the terms of the Plan.

### Participant Notes Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions.

### Payment of Benefits

Benefit payments are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management related expenses and plan administration expenses are included in administration expenses.

### Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 2      Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in similar markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of different levels.

### **Note 4. Group Annuity Contract with Empower Annuity Insurance Company of America**

The Plan invests in a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America (EAICA) totaling \$2,052,975 and \$1,962,312 as of December 31, 2024 and 2023, respectively. EAICA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract.

Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

### **Note 5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

### **Note 6. Certification**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of the investments, interest and dividends, and interest from notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan.

### **Note 7. Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Company has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8. Related Party and Party-in-Interest Transactions**

Certain plan investments are shares of mutual funds and fully benefit responsive investment contracts that are managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the Plan custodians, and therefore qualify as a party-in-interest.

Empower provides certain administrative services to the Plan pursuant to an agreement between the Company and Empower. Empower receives revenue from mutual fund service providers for services Empower provides to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative services to the Plan.

If the revenue received by Empower from such mutual fund service providers exceeds the amount owed under the agreement, Empower remits the excess to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of participants. The Plan or Plan Sponsor may make a payment to Empower for administrative expenses not covered by revenue sharing.

Certain administrative, management, advisory, and audit services are provided to the Plan by CBIZ Benefits & Insurance Services, CBIZ Investment Advisory Services, and Yount, Hyde & Barbour, P.C. Therefore, amounts paid for these services by the Plan qualify as party-in-interest transactions. These fees are included as a component of administrative expenses on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

### **Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
