Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hull Lift Truck, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 31, 2025 and 2024, and for the year ended March 31, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

Notes to Financial Statements

Note 1. Plan Description

The following description of the Hull Lift Truck, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Hull Lift Truck, Inc. (the Company) who are age 21 or older, have completed at least 60 days of employment and are not covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute a percentage of pre-tax and post-tax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan includes an automatic elective deferral contribution of 3% for all eligible employees who were hired on and after April 1, 2022. The automatic contribution rate will increase by 1% each Plan year beginning with the first full year following the year that participants begin making automatic deferrals to the Plan until it reaches a maximum of 6%. Participants direct these contributions into various investment options offered by the Plan.

The Company, at the discretion of its Board of Directors, may make a matching contribution equal to a certain percentage of each participant's deferrals and an annual profit sharing contribution to the Plan. For the year ended March 31, 2025, a matching contribution of \$321,344 was made by the Company equal to 50% of participant contributions up to 3% of compensation. No profit sharing contribution was made. Employees must have completed at least 60 days of employment, have worked for at least 1,000 hours in a 12-month period, and be employed on the last day of the Plan year to be eligible to receive a Company match and/or profit sharing contribution. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions and (b) Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Payment of benefits: The Plan permits withdrawals when a participant terminates employment, reaches retirement age, or becomes disabled or deceased. A participant may elect to receive either a single lump-sum amount or installment payments over the participant or beneficiary's life expectancy equal to the vested value of their account. Participants may withdraw portions of their vested account at any time after reaching 59½. In addition, participants may make withdrawals by determination that a financial hardship, as defined by the Plan Agreement, has been incurred. Benefit payments are recorded when paid.

Forfeitures: Forfeitures of the employer matching and profit sharing contributions are used to restore participants' accounts, offset Plan expenses, and to reduce future employer contributions. For the Plan year ended March 31, 2025, approximately \$42,800 of forfeitures were used to pay administrative expenses of the Plan. The Plan's available forfeited nonvested accounts were not considered significant at March 31, 2025 and 2024.

Note 1. Plan Description (Continued)

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years or longer for the purchase of a primary residence. The notes are collateralized by the balance in the participant's account and bear interest at prime plus 2%, as of the origination date of the loan. Principal and interest are paid ratably through payroll deductions. Interest paid by the participants is credited to their respective accounts. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon terms of the Plan document.

Administration of Plan assets: Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the Plan's third-party service providers are paid directly by the Plan.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are recorded at contract value; see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See below for discussion of fair value measurements. Contract value is the relevant measurement for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Notes to Financial Statements

Note 2. Significant Accounting Policies (Continued)

Fair value measurements: Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under accounting standards are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no material changes in the methodology used at March 31, 2025 and 2024.

Shares of registered investment companies: Valued at the closing price reported on the active market on which the individual securities are traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Subsequent events: The Plan has evaluated subsequent events for potential recognition and/or disclosure through January 8, 2026, the date the financial statements were available to be issued.

On January 1, 2026, the Plan changed its third-party administrator from 1st Source Bank to Empower Trust Company, LLC. In addition, the Plan amended its governing documents to modify the Plan's year-end from March 31 to December 31 with the date of December 31, 2025, being the Plan's next year-end.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

We evaluate the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended March 31, 2025, there were no transfers in or out of Level 3.

Note 5. Common Collective Trust

The Plan entered into a fully benefit-responsive investment with 1st Source. The account is credited with earnings on the underlying investments and charged with participant withdrawals and administrative expenses.

As described in Note 2, because the common collective trust is fully benefit responsive, contract value is the relevant measurement attributable for that portion of the net assets available for benefits attributable to the common collective trust. Contract value, as reported to the Plan by 1st Source, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The common collective trust seeks to provide preservation of capital and relatively stable returns consistent with its comparatively low risk profile and liquidity. The fund invests primarily in a variety of high-quality stable value investment contracts, as well as cash and cash equivalents. It is intended that the fund's stable value investment contracts will maintain a minimum weighted-average credit quality rating of A or better and the underlying fixed income securities must be rated investment grade and meet issuer diversification guidelines. The fund is designed for long-term retirement investing.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events may limit the Plan's ability to transact at contract value, but these are primarily limited to termination of the Plan contract with 1st Source. The Plan Administrator does not believe that the termination of the contract, which could limit the Plan's ability to transact at contract value, is probable.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7. Related-Party Transactions

1st Source is the trustee as defined by the Plan; therefore, transactions with the trustee qualify as party-in-interest transactions. Total fees paid by the Plan to 1st Source for the year ended March 31, 2025, were approximately \$73,000.

Note 8. Income Tax Status

The Plan adopted a nonstandardized pre-approved plan sponsored by 1st Source. The plan provider has received an opinion letter dated June 30, 2020, from the Internal Revenue Service as to the nonstandardized pre-approved plan's qualified status. The opinion letter has been relied upon by the Plan. The Plan has been amended since the nonstandardized pre-approved plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Note 8. Income Tax Status (Continued)

The Plan Administrator has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before March 31, 2022.

Note 9. Delinquent Contributions

During the Plan year ended March 31, 2024, the Plan Sponsor inadvertently failed to deposit approximately \$27,800 of participant contributions within the required time frame as stated by the United States Department of Labor regulations. The Plan Sponsor identified approximately \$27,500 of those late remittances during the Plan year ended March 31, 2025, and made the appropriate corrections to remit lost earnings related to such late deposits. The lost earnings on the additional \$300 of late deposits will be corrected during the Plan year ended December 31, 2026. The correction and any excise taxes, if applicable, were made from the Plan Sponsor's assets and not from assets from the Plan.
