### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of University of Maryland Faculty Physicians, Inc. Money Purchase Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### *Opinion*

### ***Basis for Opinion***

**1. Description of Plan**

The following brief description of University of Maryland Faculty Physicians, Inc. Money Purchase Pension Plan (the Plan) as adopted by Maryland Medicine P.A. (MMPA) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan, established by University of Maryland Faculty Physicians, Inc. (FPI), and effective July 1, 1983, amended and restated effective January 1, 2025. MMPA adopted the plan effective April 1, 1996. The Plan is a tax deferred money purchase pension plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan covers all eligible employees of MMPA with at least 1,000 hours of service during the Plan year except for leased or temporary employees and employees covered by a collective bargaining agreement.

An employee becomes eligible on the first day of the calendar quarter following the completion of 1,000 hours of service and the attainment of 21 years of age. Contributions begin for full-time employees on the date of eligibility; however, contributions for part-time employees begin upon the completion of 1,000 hours of service.

***Trustee (Custodian) and Administration of the Plan***

The trustee and recordkeeper of the Plan is Empower Retirement, LLC. The custodians of the Plan are Empower Annuity Insurance Company of America, Empower Life & Annuity Insurance Company of New York, and Empower Trust Company, LLC (collectively, Empower). The administrator of the Plan is MMPA. Empower holds all assets of the Plan in accordance with the service provider contract with MMPA. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

***Contributions***

Each year, MMPA contributes quarterly to the Plan, on behalf of each eligible participant, an amount equal to 7.25% of the participant's total compensation, as defined by the Plan.

Participants direct their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a guaranteed investment contract as investment options for participants. Participants are neither required nor permitted to make contributions under the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing rollovers from other qualified defined benefit or contribution plans.

***Participant Accounts***

Each participant's account is participant directed and is credited with MMPA contributions according to the investment options selected by each participant. Any earnings, losses and withdrawals are allocated to the participant's account based upon the balance in each account. Participant accounts

are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Effective July 1, 2013, vesting in the MMPA plan is always 100%. Those who termed before July 1, 2013 contributions are subject to the following vesting schedule:

Upon normal retirement, death or disability, a participant becomes fully vested in the MMPA contributions.

***Payment of Benefits***

On termination of services due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments or annuity payment. If the vested account balance is less than \$5,000, the balance can be distributed in a lump sum payment without participant consent. Beginning March 31, 2024, in conformity with the provisions of the SECURE 2.0 Act, vested accounts of \$7,000 or less can be distributed without participant consent in a lump sum payment on termination.

**2. Summary of Accounting Policies**

***Basis of Accounting***

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount

participants would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions Receivable***

Employer contributions are recognized in the period to which the contributions relate in accordance with the terms in the Plan document.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Expenses incurred in the administration of the Plan are required to be paid by the Plan, unless MMPA, at its discretion, elects to pay them. For the year ended June 30, 2025, MMPA elected to pay certain expenses of the Plan. Expenses paid by MMPA are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation.

***Subsequent Events***

Events that occurred subsequent to June 30, 2025 have been evaluated by the Plan's management for potential recognition or disclosure in the financial statements through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

**3. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, Fair Value Measurement, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at June 30, 2025 and 2024. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Registered Investment Companies* - Registered investment companies are valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Accounts* - These accounts comprise mutual funds, and cash and cash equivalents. The individual investments in the self-directed brokerage accounts are valued on the basis of readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as of June 30, 2025 and 2024, and net appreciation in fair value of investments and interest and dividends for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, a qualified institution.

**5. Investment Contract**

The Plan has a fully benefit-responsive investment contract with Massachusetts Mutual Life Insurance Company (MassMutual) (MassMutual was acquired by Empower in 2020). The investment option is available under a single group annuity contract issued by MassMutual. The investment option provides for a guarantee of principal and interest. Contributions and transfers allocated to this investment option will be credited interest at a guaranteed interest rate MassMutual declares for a set period of time deemed the guarantee period. Guaranteed interest rates for new allocations are subject to change daily, and each amount allocated to the guaranteed interest account will earn interest based on this guaranteed interest rate in effect for the date that the amount is allocated to this guaranteed interest.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by MassMutual, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) plan disqualification, (3) cessation of an employment relations resulting from a merger, reorganization, layoff or the sale or discontinuance of all or any part of the plan sponsor's business, and (4) removal of a group of participants from the Plan coverage as a result of temporary absence, change in position or other occurrence qualifying as a temporary break in service under the Plan.

**6. Related Party and Party-in-Interest Transactions**

The Plan invests in shares of registered investment companies managed by Empower. Empower acts as a directed trustee for the Plan. Empower acts as the record keeper for the Plan. The Plan paid Empower \$9,105 for contract administrative fees for the year ended June 30, 2025.

**7. Plan Termination**

Although it has not expressed any intent to do so, MMPA has the right under the Plan to discontinue and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

**9. Tax Status**

The IRS has determined and informed the Plan by a letter dated June 17, 2014 that the Plan was designed in accordance with the applicable sections of the Internal Revenue Code (IRC). MMPA is responsible for reviewing the annual Required Amendments List issued by the IRS for individually designed plans to retain qualified tax status. Although the Plan has been amended since the date of the determination letter, Plan Administrator and its legal counsel believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and continues to be tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.
