Opinion on the 2025 Financial Statements

We have audited the financial statements of Azurite Professional Community 401(k) and Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of March 31, 2025, and the related statement of changes in net assets available for benefits for the period from November 1, 2024 through March 31, 2025, and the related notes to the financial statements.

As discussed in Note 1 to the financial statements, the Plan administrator and Trustees of the Plan authorized to merge the Plan with the Azurite Professional Community 401(k) Employee Stock Ownership Plan to create the Azurite Professional Community KSOP effective April 1, 2025. Our opinion is not modified for this matter.

(“APC” or the “Company”) serves as the holding company for its wholly owned subsidiaries: Miller Engineers, Inc., doing business as Souder Miller & Associates (SMA); Gallatin Operational Solutions, LLC (formerly SMA Operations, LLC) (Gallatin) and Inberg Surveying Company, Inc. (IME) (collectively the “Companies”).

Plan Merger

Effective April 1, 2025, the Plan Administrator and Trustees authorized the merger of the Plan with the Azurite Professional Community Employee Stock Ownership Plan to establish and create a Keystone Savings and Profit Sharing Plan (KSOP). A KSOP (401(k) Stock Ownership Plan) is a hybrid retirement benefit plan combining features of an ESOP (Employee Stock Ownership Plan) and a 401(k). Employees can contribute a portion of their eligible compensation (pre-tax or Roth) and may receive employer contributions, which are typically made in Company stock. This arrangement allows employees to build retirement savings through both traditional retirement investments and ownership in the Company. The Plan’s merger was completed in accordance with applicable legal requirements. As of the end of the day March 31, 2025, the title of the Plan’s investment accounts was transferred to the KSOP Trust.

With the merger:

- Balances of all participants of the Plan, as well as the ESOP, will transfer to the KSOP.
- Participants will vest according to the KSOP in all their account balances in the KSOP both before and after the merger of the Plan into the KSOP.
- Service credit for eligibility and vesting for service with NKE; Gannet Fleming West; KRW Consulting, Inc.; Gallatin Operational Solutions, LLC.; SMA Operations, LLC; Inberg Surveying Company, Inc. d/b/a Inberg-Miller Engineers; Miller Engineers, Inc. dba Souder, Miller & Associates; Souder Miller & Associates, Inc.; Southwest Engineering, Inc. for all contribution types is re-affirmed.
- The majority of the applicable plan provisions from both the 401k and ESOP will continue under the provisions of the KSOP plan document.

General

The Plan is a defined contribution plan covering all full-time employees of the Companies. For purposes of elective deferrals, the entry date is any date on or after eligibility requirements are met. Participants must be age twenty-one or older, and have six months of service with the Company to become eligible for employee deferrals and Employer discretionary contributions.

The Company is the Plan's Sponsor and serves as the Plan administrator. Certain employees of the Company serve as the Plan's trustees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute pretax deferrals or after-tax Roth contributions up to the lesser of the federal statutory limits or 100% of pretax annual compensation, as defined in the Plan. Participants who have attained the age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Effective November 1, 2023, the Company amended the Plan to include automatic enrollment at a flat deferral rate of 3%, and to allow for the rollover of in-kind assets from other plans of the employer and Roth contributions.

The Plan has elected to be a safe harbor plan, and the Company makes safe harbor nonelective contributions equal to 100% of the first 4% of compensation deferred. Effective November 1, 2023, the safe harbor nonelective contributions increased to 100% of the first 6% of compensation deferred. Employer safe harbor contributions net of forfeitures totaled \$377,839 for the period ended March 31, 2025.

The Plan may also make profit-sharing contributions at the discretion of the Company's Board of Directors. Participants who have satisfied the age and service eligibility requirements are generally eligible for an allocation of the profit-sharing contribution for a Plan year if they are employed on the last day of the Plan year. The profit-sharing contributions are allocated to all participants in the same ratio as their compensation. There were no employer profit-sharing contributions for the period ended March 31, 2025. Contributions are subject to regulatory limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer contributions, and allocations of Plan earnings (losses). Participant accounts may also be charged with an allocation of certain administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting of Accounts

Participants are immediately vested in the Employer's safe harbor contributions, as well as their employee contributions. Vesting in the Employer's discretionary matching contributions portion of their accounts plus earnings thereon is based on years of continuous service as follows:

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% percent of their vested account balance. The loans are issued by the Plan and secured by the vested balance in the participant's account. The maximum loan period is five years unless for the purchase of a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed fifteen years. Under the terms of the Plan agreement, Plan loans bear a reasonable rate of interest determined by the Plan Administrator. Principal and interest are paid through payroll deductions. Participants can have no more than two loans outstanding at a time.

Payment of Benefits

Benefits are payable in the event of retirement, disability, death, attainment of age 59½ or termination of employment. A participant may receive the value of the vested interest in their account as a lump-sum distribution or in the form of annuity payments. Effective November 1, 2023, in-service 59½ distributions are allowed from rollover contributions, and in-service distributions are also allowed upon reaching the age of 40 from transfer contributions.

Under the terms of the Plan, participants may receive a hardship distribution of the vested portion of their account balance if they have met one of the required qualifying events.

Forfeitures

Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained by the Plan and may be used to pay the Plan's administrative expenses or to reduce future Employer contributions. For the period ended March 31, 2025, there were no forfeitures. There was no balance in the forfeiture accounts as of March 31, 2025 or October 31, 2024.

2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair values.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the participants' account balances and amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement. Interest income is recorded on an accrual basis.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan permits, but does not require, the Employer to pay significant costs of Plan administration. At any time, the Employer may elect for the Plan to pay administration costs. For the period ended March 31, 2025, the Plan paid all administrative expenses, which are reflected in the accompanying statement of changes in net assets available for benefits.

Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events were evaluated for recognition or disclosure in these financial statements through January 15, 2026, the date that the financial statements were available to be issued. Plan management did not identify any subsequent events that would require additional adjustments or disclosure to these financial statements.

3) Investments and Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Quoted prices in markets that are not considered to be active or financial instruments without quoted market prices, but for which all significant inputs are observable, either directly or indirectly.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at March 31, 2025 and October 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are shares or registered investment companies (mutual funds) that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts (PSA): Valued based on unit values reported by the Plan trustee, which is principally the market value of the underlying investments, but the PSA net asset value (NAV) per unit is not a publicly quoted price. Assets measured using net asset value as a practical expedient are not assigned a level in the fair value hierarchy.

Collective Investment Trust: The collective investment trust (CIT) invests in a collective trust fund as well as a variety of separate accounts and mutual funds. The fair value of the collective investment trust and the separate accounts are not publicly quoted pricing inputs. The fair value of all these investments are used in determining the net asset value (NAV) of the CIT, which is not publicly quoted. Assets measured using net asset value as a practical expedient are not assigned a level in the fair value hierarchy.

The Plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was obtained or derived from information provided to the Plan administrator by Principal Life Insurance Company, the custodian, a qualified institution, and certified as complete and accurate:

- Investments and notes receivable from participants reflected on the accompanying statement of net assets available for benefits as of October 31, 2024.

5) Plan Termination

The Company, as the Plan's sponsor, has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

The Plan merged with the KSOP effective April 1, 2025 (Note 1). Since the Plan obligations continue under the KSOP and the KSOP will provide benefits not less than under the Plan, the Plan did not terminate. As a result, all participant accounts were transferred to the KSOP as of the end of the day March 31, 2025, and will continue to vest based on the provisions of the KSOP.

6) Tax Status

The Plan is operating as a tax exempt plan under a nonstandardized pre-approved adoption agreement. The Internal Revenue Service (IRS) has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the nonstandardized pre-approved plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan merged with the KSOP effective April 1, 2025 (Note 1), but was not terminated. However, future tax filings will be done under the tax id number of the KSOP. The Plan will file a final tax return as of and for the short period ended March 31, 2025.

GAAP requires the Plan's administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management does not believe that the Plan has taken any uncertain tax positions as of March 31, 2025. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is generally no longer subject to income tax examinations for tax years prior to 2021 (fiscal year ended October 31, 2022).

7) Related-Party and Party-in-Interest Transactions

Certain Plan assets are investments managed by Principal Financial Group, an affiliate of the custodian of the Plan. These transactions qualify as exempt party-in-interest transactions. The Employer provides certain accounting, administrative, and management services to the Plan for which no fees are charged.

For the period ended March 31, 2025, fees paid by the Plan for administrative expenses such as third-party administrative fees, recordkeeping fees, distribution, and loan fees, totaled \$37,822.
