### 1. Description of the Plan

The following description of Chicot Memorial Medical Center 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document and summary plan description for a complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan, established on April 1, 1996 and most recently amended and restated effective May 8, 2024, covering all eligible employees of Chicot Memorial Medical Center, Inc. (the Medical Center).

The Plan is subject to the provisions of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA) and its subsequent amendments.

#### *Trustee, Issuer and Administration of the Plan*

The Medical Center is the plan sponsor and plan administrator and is responsible for oversight of the Plan. Prior to April 20, 2024, the issuer of the insurance contract held in the Plan was Voya Retirement Insurance and Annuity Company (VRIAC or Issuer). VRIAC provided the recordkeeping and other administrative services. VRIAC held all assets of the Plan in accordance with the provisions of the agreement with the Medical Center.

Effective April 20, 2024, Empower Trust Company (Empower), LLC is the trustee of the Plan. The recordkeeper of the Plan is Empower Annuity Insurance Company of America (EAIC), the parent company of Empower Retirement, LLC. Empower holds all the assets of the Plan in accordance with provisions of the agreement with the Medical Center.

The Medical Center and the Plan's investment advisor (the Advisor) determine the Plan's investment offerings and monitors investment performance.

During April 20, 2024, the Medical Center changed recordkeeper from VRIAC to Empower. The Medical Plan liquidated guaranteed investment contract. The total proceeds from the liquidation amounted to \$2,500,000, resulting in a realized gain of \$150,000, which has been recognized in the statement of profit or loss. The decision to liquidate these investments was made to reallocate resources to core business operations and to enhance liquidity. As of December 31, 2025, no investments remain in the available-for-sale category.

The Company has assessed the impact of the liquidation on its financial position and concluded that there are no material adverse effects. All transactions were conducted at fair market value, and appropriate disclosures have been made in accordance with

Effective April 20, 2024, the Plan changed its recordkeeper from VRIAC to Empower. In connection with the transition, all plan assets held with the previous recordkeeper were liquidated and transferred Empower. The liquidation and transfer were completed on May 8, 2024, with total assets of approximately \$3,800,000 transferred at fair value.

### ***Eligibility***

The Plan requires the participant to be at least 18 years of age, complete one year of service and is not classified as an excluded employee. The participant is credited with a year of service after completing 1,000 hours of service during a 12-month period.

### ***Contributions***

Employees may elect on a pretax or Roth basis contributions up to certain limitations under the Internal Revenue Code (IRC). The Plan also allows catch-up contributions for participants age 50 and over based on IRC limitations. Participants can terminate or change their deferral agreements according to procedures and limitation as determined by the plan document.

The Medical Center may make a discretionary profit sharing contribution to the Plan as determined by the governing body. No profit sharing contribution was made for the year ended March 31, 2025.

All eligible participants receive safe harbor contributions equal to 100% of the participant's elective deferral not exceeding 3% of compensation, plus 50% of the participant's elective deferral in excess of 3%, but not in excess of 5% of the participant's compensation. It is the Medical Center's policy to fund employee deferrals and safe harbor contributions as soon as administratively feasible after each pay period.

Rollover contributions from other qualified plans or individual retirement accounts (IRA) may also be made to the Plan if certain criteria are met.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Medical Center's matching contributions and Plan earnings and losses and charged with an allocation of administrative expenses to the extent such expenses are paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan. The Plan provides benefits based solely upon the amount contributed to the participant's account and any income, expenses, gains and losses on investments, which may be allocated to such participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. Participants may direct the investment of their account balances into various investment options offered by the Plan.

### ***Notes Receivable from Participants***

Effective May 8, 2024, participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The maximum term of the loans is five years, unless used for the purchase of a residence, which may have a longer loan period. Participants may have two loan outstanding at a time. The loans are secured by the balances in the participants' accounts and bear interest at rates at 1% over Prime Rate on the first business day of the month the loan is originated. The interest rate is fixed for the term of the loan. Principal and interest are paid ratably through payroll deductions. Outstanding borrowings at March 31, 2025 bore interest between 8.50% and 9.50%.

### ***Payment of Benefits***

Benefits are generally payable on termination, retirement, death or disability. Benefits may be paid by either lump sum or installments over a fixed reasonable period of time. If a participant's total vested account balance is under \$5,000 but over \$1,000 at the time of termination, the balance will be rolled over to an IRA. If the balance is less than \$1,000 the participant will automatically receive a distribution of the entire vested account balance in a lump sum. Hardship distributions are also available from the vested portion of the participant's account subject to regulatory requirements.

### ***Vesting***

Participants are immediately vested in their voluntary contributions and employer safe harbor contributions and all earnings thereon.

A participant's vested percentage in the portion of their account attributable to the Medical Center's profit sharing contribution, plus earnings thereon, shall be determined under the following schedule:

### ***Forfeitures***

At March 31, 2025 and 2024, forfeited nonvested accounts, which will be used to reduce future employer contributions or administrative expenses, totaled \$750 and \$715, respectively. For the year ended March 31, 2025, the Plan did not use any forfeitures to reduce contributions or administrative expenses.

## **2. Summary of Accounting Principles**

### ***Basis of Presentation***

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions, which affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes gains and losses on investments bought and sold as well as held during the year. Realized gains and losses related to sales of investments are recorded on a trade-date basis. Expenses are recorded on the accrual basis. Capital gains are included in the net appreciation (depreciation) in fair value of investments.

During April 2024, the guaranteed investment contract was terminated, which resulted in a one-time market adjustment of \$(13,492).

### ***Contributions***

Employee contributions and safe harbor matching contributions are recorded in the period payroll deductions are made. Profit sharing contributions are recorded for the year to which they apply.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at the unpaid principal balance plus unpaid accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. The Plan classifies all participant loans with no payments received for six months as in default. Defaulted loans are deemed distributed and recorded as benefits paid to participants in the statement of changes in net assets available for benefits.

### ***Administrative Expenses***

Administrative expenses incurred by the Plan are paid directly by the Medical Center. Fees not paid by the Medical Center are paid by the Plan.

### ***Plan Termination***

Although it has not expressed any intent to do so, the Medical Center has the right under the Plan to terminate the Plan subject to the provisions of ERISA. If terminated, participants would become 100% vested in employer contributions.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Additionally, the value, liquidity, and related income of the investment securities are sensitive to changes in economic conditions. Due to the level of risk associated with certain investment securities and the level of uncertainty related to the changes in the value of investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for plan benefits.

### 3. Information Certified by Trustee and Issuer

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulation for Reporting and Disclosure under ERISA. Accordingly, VRIAC and Empower, qualified institutions, have certified that the following information included in the accompanying financial statements and supplemental schedule as complete and accurate:

- Investments as reported in the statements of net assets available for benefits as of March 31, 2025 and 2024 and notes receivable from participants as of March 31, 2025.
- Net investment income and interest earned on notes receivables as reported on the statement of changes in net assets available for benefits for the year ended March 31, 2025.
- Investment amounts included in the notes to the financial statements as of March 31, 2025 and 2024, and investment information included in the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of March 31, 2025.

At the request of the plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 5. Income Tax Status

Effective May 8, 2024, the Plan was restated with a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA, which received a favorable opinion letter from the IRS, dated November 14, 2022, stating that the form of the Plan is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. The Medical Center believes that the Plan, as amended, is currently designed and being operated in compliance with applicable requirements of the IRC, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 6. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis.

*Mutual Funds* - These are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Not Fully Benefit-Responsive Guaranteed Investment Contracts and Restricted Investments Held for Collateral* - Valued at the accumulated unit value of units held by the Plan at year end, which is included as measured at NAV practical expedient. There are no unfunded commitments. The redemption frequency is daily, and no redemption notice is required. The contract was terminated in April 2024.

*Pooled Separate Accounts* - These assets are valued based on market value of their underlying investments (Level 2). Units are determined daily by VRIAC by applying the net asset value (NAV) of the underlying fund less a management fee.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 7. Party-in-Interest and Related Party Transactions

Prior to April 2024, Plan investments were guaranteed investment contracts or shares of pooled separate accounts managed by VRIAC. VRIAC was the custodian of the Plan assets as defined by the Plan and, therefore, the transactions qualified as exempt party-in-interest transactions.

Effective April 2024, fees were paid to Empower for certain administrative fees and other service fees were paid to the investment advisor. The Plan also issues loans to participants that are secured by the vested balance of the participants' accounts. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

## 8. Delinquent Participant Contributions

During the years ended March 31, 2025 and 2023, the Medical Center failed to timely remit participant contributions to the Plan. The Medical Center is currently working on calculating lost earnings for the 2025 and 2023 late remittances. See accompanying supplemental Schedule of Delinquent Participant Contributions for the year ended March 31, 2025.

## 9. Subsequent Events

The Medical Center has evaluated subsequent events through January 14, 2026, which is the date these financial statements were available to be issued. There were no events or transactions discovered during this evaluation that require recognition or disclosure in the financial statements.
