Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Knoxville Milling Company Pension Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – liquidation basis as of March 31, 2025 and 2024 and the related statements of changes in net assets available for benefits – liquidation basis for the years then ended and the related notes to the financial statements – liquidation basis.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended March 31, 2025 and 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion on the Financial Statements section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

As described in Note 1 to the financial statements, the Plan does not have sufficient historical accounting records and supporting documents for former employees participating in the Knoxville Milling Company Pension Plan B for Non-Union Employees (Non-Union Plan) that merged into the Plan effective December 31, 2020. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements may have been affected by these conditions.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, C.H. Guenther & Son LLC, the sole member of the Plan's sponsor, approved a resolution on December 31, 2021 to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan's basis of accounting is liquidation basis. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibilities are to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedules listed in the table of contents are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion on the Financial Statements section it is inappropriate to and we do not express an opinion on these supplemental schedules.

Guenther & Son LLC (Parent of the plan sponsor, as described below) elected to terminate the Plan according to the standard termination rules under 4041(b) of the *Employee Retirement Income Security Act of 1974* (ERISA) effective March 31, 2022 or at such later date as is administratively practicable. Upon termination of the Plan, the net assets of the Plan will be liquidated and distributed, as prescribed by ERISA and its related regulations. The Plan applied for approval for the termination from the IRS and Pension Benefit Guaranty Corporation (PBGC) during 2022. The IRS has notified the plan sponsor that further information is needed for official approval. Since IRS approval is not required, the plan sponsor has decided to forgo IRS approval and proceed with liquidating the Plan and making final payments as soon as administratively feasible. All participants are fully vested upon termination and will have the option to receive a lump sum payment or an annuity for the value of their accumulated benefits.

Upon termination of the Plan, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations.

Unless otherwise noted, the below represents the provisions of the Plan prior to the effective date of the Plan termination.

General

The Plan is a defined benefit pension plan providing retirement and death benefits to all eligible employees prior to March 31, 1994, when the Plan was frozen to new participants. The plan sponsor is Knoxville Milling Company LLC (Company) a subsidiary of C.H. Guenther & Son LLC. C.H. Guenther & Son LLC (the sole member of the plan sponsor) is the sole member of the Company. The Plan is subject to the provisions of ERISA.

The Company elected to close its manufacturing operations and terminate all of its employees in June 2008. All participants not previously vested became fully vested in the Plan upon their termination.

Effective December 31, 2020, the Knoxville Milling Company Pension Plan B for Non-Union Employees (Non-Union Plan) merged with the Knoxville Milling Company Pension Plan A for Union Employees, and the name of the Plan was changed to the Knoxville Milling Company Pension Plan. The Non-Union Plan assets merged into the Plan totaled \$3,585,687, and the asset transfers were completed in January 2021. The last actuarial report for the Non-Union Plan was as of March 31, 2020 and denoted an accumulated benefit obligation of approximately \$2,300,000, which was assumed by the Plan effective December 31, 2020.

Funding Policy

The Company's funding policy is to make contributions to the Plan sufficient to satisfy the minimum funding statutory requirements of ERISA while not exceeding the maximum tax-deductible contribution limit. Contributions to the Plan made by the Company are accrued based on annual funding amounts determined by the Plan's actuary. Such amounts meet minimum requirements of ERISA and include a provision for prior service costs. No contributions were required to be made to the Plan during the years ended March 31, 2025 and 2024.

Pension Benefits

Participants in the Plan are entitled to annual pension benefits beginning at the normal retirement age of 65. Pension benefits are determined by applying various annual rates, as described in the plan document, to the participants' years of benefit service. Participants may elect to receive reduced benefits upon early retirement at age 55 as defined in the plan document. Participants may elect to receive the value of their accumulated plan benefits in the

form of a joint and survivor annuity and may, under certain circumstances, receive the value of their accumulated plan benefits as a lump-sum distribution or they may elect to receive their benefits as a life annuity payable monthly.

Death and Disability Benefits

If a participant dies at the age of 55 or older, a death benefit equal to one-half of the employee's accumulated pension benefits is paid to the employee's eligible spouse. Participants with at least 10 years of vested service who become totally disabled receive monthly disability benefits that are equal to the disability retirement benefits they have accumulated as of the time they became disabled. Disability benefits are paid until normal retirement date, at which time disabled participants begin receiving normal retirement benefits.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities and the actuarial present value of accumulated plan benefits at the date of the financial statements and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Purchases and sale of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan at the Company's discretion.

Accumulated Plan Benefits

Accumulated plan benefits are those estimated future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to:

- (A) Retired or terminated employees or their beneficiaries
- (B) Beneficiaries of employees who have died
- (C) Present employees or their beneficiaries

Benefits under the Plan are accumulated based on employees' compensation during each year of credited service. The accumulated plan benefits for active employees will equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date. Benefits payable under all circumstances—retirement, death, disability, and termination of employment—are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

Note 3. Plan Termination

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- (A) Benefits attributable to employee contributions, taking into account those paid out before termination.
- (B) Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under plan provisions in effect at any time during the five years preceding plan termination.
- (C) Other vested benefits insured by the PBGC (a U.S. government agency) up to the applicable limitations discussed below.
- (D) All other vested benefits (that is, vested benefits not insured by the PBGC).
- (E) All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the plan sponsor and the level of benefits guaranteed by the PBGC.

The Company has decided to terminate the Plan as allowed and subject to the provisions set forth in ERISA.

Note 4. Certification of Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, U.S. Bank National Association (U.S. Bank), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the accompanying statements of net assets available for benefits – liquidation basis as of March 31, 2025 and 2024
- Investment income as shown in the accompanying statements of changes in net assets available for benefits – liquidation basis for the years ended March 31, 2025 and 2024

- Investment information included in the accompanying schedule of assets (held at end of year) as of March 31, 2025

The Plan’s independent auditors did not perform auditing procedures with respect to this certified information except for comparing such certified investment information to the related investment information included in the accompanying financial statements and supplemental schedule of assets (held at end of year).

Note 5. Accumulated Plan Benefits

The actuarial present value of accumulated plan benefits is determined by an independent actuary, Willis Towers Watson, and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discount for interest) and the probability of payment (by means of decrements, such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. As of March 31, 2025, the termination plan included a bulk lump sum payment on March 13, 2025, and a plan for the remaining liabilities to be transferred outside the plan via the purchase of an annuity contract with United of Omaha Life Insurance Company (Mutual of Omaha). The present value of the annuity purchase premium on April 15, 2025, the periodic benefit payments on May 1, 2025, the expected uncashed checks for two participants to be transferred to PBGC, and a discount rate of 4.52%.

The significant actuarial assumptions used in the valuation as of March 31, 2024 were (a) life expectancy of participants according to the RP-2014 adjusted backward to 2006 with MP-2014 and projected forward to 2018 using MP-2014, (b) vested termination participants commence payment at age of 65, and (c) discount rate of 5.66%.

Due to the Plan terminating and the presentation of liquidation basis of accounting, the actuarial present value of accumulated plan benefits has been calculated as of the end of the plan year.

The foregoing actuarial assumptions are based on the Plan’s intention to terminate the Plan effective March 31, 2022 or at such later date as is administratively feasible, and based on the settlement basis as of the end of the plan year.

Note 6. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs.

The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies used for assets measured at fair value.

Money Market Fund

The money market fund is valued at the daily closing price as reported by the fund. The fund is required to publish its net asset value daily and to transact at that price. The money market fund is deemed to be actively traded.

Recurring Measurements

The following table presents the fair value measurements of assets and liabilities recognized in the accompanying statements of net assets available for benefits – liquidation basis measured at fair value on a recurring basis and the level within the fair value hierarchy in which the fair value measurements fall at March 31:

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits – liquidation basis.

The actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 8. Tax Status

The Plan obtained its latest determination letter on September 30, 2016, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC) and, therefore, not subject to tax. The Plan has been amended since receiving the determination letter. The plan administrator and the Plan's tax counsel are moving forward with Plan liquidation based on the Plan's current design.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan's investment is a money market fund managed by U.S. Bank. U.S. Bank is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The plan sponsor provides certain administrative services at no cost to the Plan.

Note 10. Subsequent Events

Subsequent events have been evaluated through January 15, 2026, which is the date the financial statements were available to be issued.

Group Annuity Contract

On April 15, 2025, the Plan entered into a qualified single premium group annuity contract with Mutual of Omaha to irrevocably assume responsibility for all remaining benefit obligations under the terminated defined benefit pension plan. The Plan paid a single premium of \$4,028,267 to United of Omaha Life Insurance Company. As a result of this transaction, the Plan will have no further obligations for benefits.

After all participant liabilities have been settled, the Plan may continue to hold residual assets, primarily related to investment earnings. These assets will be used to pay final administrative expenses, with any remaining amounts reverting to the plan sponsor in accordance the Plan provisions and applicable regulations.
