## INDEPENDENT AUDITOR'S REPORT

To the Participants and Trustees of

### Opinion

We have audited the financial statements of California Correctional Peace Officers Association Benefit Trust Fund Supplemental Benefit Plan, an employee benefit plan subject to the Employee Retirement Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and of benefit obligations as of March 31, 2025 and 2024, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended; and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of the plan as of March 31, 2025 and 2024, and the changes in its net assets available for benefits and plan benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of California Correctional Peace Officers Association Benefit Trust Fund Supplemental Benefit Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### Responsibilities of Management for the Financial Statements

**1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Method of Accounting**

The accompanying financial statements California Correctional Peace Officers Association Benefit Trust Fund Supplemental Benefit Plan (the "Plan") are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Investment Valuation, Transactions and Income Recognition**

*General*

Investments are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification ("FASB ASC") 820, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the "exit price") in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan's assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

*Level 1* - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

*Level 2* - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

*Level 3* - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities' own judgments and estimations, or some other pricing method using unobservable inputs.

*Inputs and Valuation Methods:* In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods used for each of the Plan's investment classes are presented below:

*Mutual funds* - The fair value of mutual funds is based on quoted market prices in active markets (Level 1).

*Valuation Methods, Consistency:* The valuation techniques used in the accompanying financial statements have been consistently applied.

*Transactions and Income Recognition:* Purchases and sales of securities are recorded on a trade-date basis. Dividend and interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

The state of California shall contribute a mutually agreed-upon amount to the Plan to provide eligible members an offset to an increase in benefit premiums and/or reduction of premiums for programs offered by the Plan.

For both of the years ended March 31, 2025 and 2024, the state of California contributed \$19,132,000 to the Plan.

**Benefit Obligations**

Premiums payable was calculated based upon the estimated premiums due for March and prior coverage. Dental and vision subsidies payable were calculated based upon the estimated subsidies for March and prior coverage.

**Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan invests in mutual funds. Such investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**2. DESCRIPTION OF THE PLAN**

**General**

The California Correctional Peace Officers Association Benefit Trust Fund Supplemental Benefit Plan (the "Plan") was established April 1, 2011, for the purpose of providing supplemental group vision benefits, group dental benefits, group life, accidental death and dismemberment benefits, and prepaid legal services benefits under the terms of an agreement between the Board of Directors of the California Correctional Peace Officers Association ("CCPOA") and the Board of Trustees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Eligibility**

The benefit programs are generally available to the following groups of individuals and their eligible dependents:

- a) Full-time permanent employees and permanent intermittent employees of the State of California Bargaining Unit 6 who are members in good standing of CCPOA;
- b) Employees of CCPOA;
- c) Employees of CCPOA Benefit Trust Fund; and
- d) Members in good standing of the Retiree Chapter of CCPOA.

Generally, a participant is initially eligible to receive benefits on the first day of the calendar month immediately following the date payroll deduction commences, provided the participant is at their regular work on such effective date. The coverage continues on the first day of each month.

**Benefits**

The Plan consists of the following benefit programs: the VSP Second Pair of Eyeglasses Benefit Program, the Basic Legal Benefit Program (Family Legal - Active), the Basic Life Insurance Program, Dental, and the \$5,000 AD&D Benefit Program, and Legal Defense Fund Subsidy. The benefit programs are either self-funded or insured and are described in separate Summary Program Booklets and in Evidences of Coverage/Certificates of Coverage. Benefits are recorded when paid.

**3. PRIORITIES UPON TERMINATION**

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets may be allocated among participants and beneficiaries in the manner determined by the Board of Trustees and in accordance with applicable law, or transferred to a plan operated by an Internal Revenue Code ("IRC") Section 501(c)(9) trust providing similar benefits. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

**4. TAX STATUS**

The Voluntary Employees' Beneficiary Association ("VEBA") trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service ("IRS") dated February 24, 1986, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the IRC. The VEBA trust has been amended since receiving the determination letter. However, the Plan's administrator and the Plan's counsel believe that the Plan continues to operate in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

The Plan's administrator has analyzed the tax positions taken by the Plan and has concluded that, as of March 31, 2025 and 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**5. CONCENTRATION OF CASH**

The Plan maintains its cash at one financial institution. The balance is insured by the Federal Deposit Insurance Corporation ("FDIC") up to \$250,000. Cash balances may at times exceed the insured deposit limits. Any loss incurred or a lack of access to such funds could have a significant adverse impact on the Plan's financial condition.

**6. FUNDING POLICY**

The Plan is financed by the State of California based on an agreement between the State of California and the CCPOA covering Bargaining Unit 6 Corrections.

**8. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan shares common governance with related organizations, including California Correctional Peace Officers Association Benefit Trust Fund (the "Welfare Plan"), and California Correctional Peace Officers Association Medical Plan (the "Medical Plan").

The Welfare Plan pays general and administrative expenses on behalf of the Plan. The Plan reimburses the Welfare Plan an estimated amount monthly. The Welfare Plan performs an annual allocation based upon the actual time the Welfare Plan employees spend on behalf of the Plan. As of March 31, 2025 and 2024, the Plan owed (to) or from the Welfare Plan \$1,223 and \$139, respectively. During the years ended March 31, 2025 and 2024, the Plan reimbursed the Welfare Plan for allocated expenses of \$1,465 and \$2,691, respectively.

The Welfare Plan also provides administrative services with respect to family legal plan insured benefits of the Plan. The Plan reimburses the Welfare Plan at a rate of \$0.20 per participant per month and the amounts are reflected in service fee revenue totaling \$70,416 and \$70,958, respectively, for the years ended March 31, 2025 and 2024.

The Plan also reimburses the Medical Plan for certain administrative expenses paid on behalf of the Plan. During the years ended March 31, 2025 and 2024, the Plan reimbursed the Medical Plan for administrative expenses totaling \$69,988 and \$70,610, respectively.
