Our opinion is not modified with respect to this matter.

## 1. Description of Plan

The following description of the EnerSys Inc. Hourly Employees' Pension Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### General

The Plan is a noncontributory defined benefit pension plan covering substantially all hourly nonunion employees at the Sumter, South Carolina and Richmond, Kentucky plants of EnerSys Delaware Inc. (the Company) who have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan's Retirement Committee (Committee) has overall responsibility for the operation and administration of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective December 31, 2003, the Plan was amended to freeze participation and accrued benefits under the Plan.

### Plan Termination and Liquidation

On March 28, 2024, the Board of Directors of the Company resolved to terminate the Plan effective April 30, 2024. All participants become 100% vested as a result of the decision to terminate. Upon termination, substantially all assets remaining in the Plan will be distributed to participants, subject to the applicable requirements of ERISA and in accordance with the provisions of the plan document. The Plan purchased an annuity contract from Mutual of Omaha Life Insurance Co in the amount of \$5,162,977, and the Plan's accumulated benefit obligation was fully funded as of October 31, 2024. Residual amounts of assets remain as of March 31, 2025, and the Company is determining the final and best use of these assets in order to affect the liquidation of the excess funds in 2025. The related amounts for accrued income and expenses through this date have been estimated and recorded in the accompanying financial statements.

### Master Trust

The Plan's investments are held in a Master Trust (the Master Trust), which was established for the investment of assets of the Plan and several other EnerSys Inc. sponsored retirement plans. Each participating plan has an undivided interest in the Master Trust. The assets of the Master Trust are held by Principal Trust Company and Merrill Lynch (custodians).

### Vesting

A participant's retirement benefits vest upon completion of five years of service. Disability benefits vest upon the completion of fifteen years of service.

Effective April 30, 2024, all participants in the Plan became 100% vested.

### Funding Policy

The Plan's funding policy is for the Company to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. No participant contributions are permitted. Due to the Plan being in an overfunded position, there were no minimum funding requirements for the years ended March 31, 2025 and 2024.

## Pension Benefits

Prior to plan termination and liquidation, participants are eligible for normal retirement benefits at age 65 or the fifth anniversary of participation, if later. The normal retirement pension is payable monthly as long as the participant lives, with payments ceasing upon the participant's death. Upon termination of employment other than by retirement, disability or death, if the present value of the vested accrued benefit does not exceed \$5,000, a lump sum payment may be requested. The lump sum value will be paid as soon as administratively possible after termination of employment. If the vested accrued benefit exceeds \$5,000, the assets will generally be held in a trust until the participant's normal retirement date. Retirement benefits can also be paid in the form of a joint and survivor annuity or life annuity with a certain period.

The amount of monthly pension is equal to certain benefit rates for specified benefit service years and specific groups of employees as more fully described in the plan document.

A benefit service year is credited for each 12-month period the employee is employed by the Company. Effective December 31, 2003, benefits were frozen and all benefit accruals after December 31, 2003 ceased.

Upon termination, if the present cash value of the accrued benefit is \$7,000 or less, the benefit will be distributed from the Plan in the form of a single cash payment.

## Death and Disability Benefits

Prior to October 31, 2024, participants were eligible for pre-retirement death benefits if death occurs after five years of credited service. The spouse will receive a benefit as though the participant retired on the date of death and elected a 50% qualified joint and survivor annuity.

Participants are eligible for disability benefits if disability occurs after fifteen years of credited service. The benefit will be the participant's accrued benefit to the date of disability.

Upon plan termination, the disability benefit was eliminated.

## 2. Summary of Accounting Policies

### Basis of Accounting

As a result of the resolution to terminate the Plan, the Plan considers liquidation to be imminent and, therefore, the financial statements of the Plan as of and for the years ended March 31, 2025 and 2024 are presented on the liquidation basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

## **Investment Valuation and Income Recognition**

Investments in the Master Trust are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan's interest in the investment gain of the Master Trust, in the accompanying statement of changes in net assets available for benefits in liquidation includes the Plan's allocation of interest, dividends, realized gains or losses from the sale of investments, and unrealized appreciation in the fair value of investments held by the Master Trust, and fees charged to the Master Trust, which are netted against or included with net appreciation in fair value of investments. These fees represent charges by the custodians for services provided in connection with recordkeeping and investment management. Net unrealized appreciation in fair value of investments represents the net change in the fair value of the investments held during the period. The net realized gains or losses on the sale of investments represent the difference between the sale proceeds and the fair value of the investments as of the beginning of the period or the cost of the investment if purchased during the year.

## **Payment of Benefits**

Benefits payments to participants are recorded upon distribution.

## **Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the statements of changes in net assets available for benefits in liquidation. In addition, certain investment related expenses are included in net appreciation in fair value of investments in the statements of changes in net assets available for benefits in liquidation.

## **Subsequent Events**

Subsequent events were evaluated through January 9, 2026, the date the financial statements were available to be issued.

### 3. Actuarial Present Value of Accumulated Plan Benefits

The measurement of the accumulated plan benefit obligation has historically been done as of the beginning of the Plan year, in order to determine funding required (if applicable) for that year. Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on employees' compensation during each year of credited service. The accumulated plan benefits for active employees will equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date. Benefits payable under all circumstances, such as retirement, death, disability, and termination of employment, are included, to the extent they are attributable to employee service rendered to the valuation date. Benefits to be provided via annuity contracts excluded from plan assets are excluded from accumulated plan benefits.

The actuarial present value of accumulated plan benefits is determined by the Plan's independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The computations of the actuarial present value of accumulated plan benefits were made as of April 1, 2024. As discussed in the Plan Termination disclosures of Note 1, the Plan has been relieved of its obligations as of October 2024 and only the excess funding in the Plan remains. Thus, there is no remaining benefit obligations of the Plan as of March 31, 2025 and no valuation was performed as of this date (or effectively the April 1, 2025 beginning of year). The significant actuarial assumptions used as of the April 1, 2024 valuations were as follows:

The actuarial present value of the projected plan benefit obligation at April 1, 2024 was \$7,773,718 and the fair value on the Plan's investments were \$7,435,920 as of March 31, 2024. As disclosed in Note 1, in 2024, the Plan began the liquidation process by paying certain lump sum benefit payments to former participants and purchasing annuity contracts for the remaining participants. Upon satisfaction of the obligations of all of the plans' in the Master Trust, it is estimated that the Master Trust will have excess funds remaining of approximately \$1,150,000. Approximately \$575,000 of the Master Trust excess is expected to relate to the EnerSys Inc. Hourly Employees' Pension Plan. Any excess funds remaining in the Plan could be used for either (1) the purchase of additional annuities for former plan participants, (2) used to benefit any active participants in an affiliated plan as allowable under the regulations, (3) used to pay certain expenses associated with the continued liquidation process and/or (4) could be reverted to the Plan sponsor. The exact usage of any excess funds was not finalized or known at the time of the issuance of these audited financial statements.

## 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025 and 2024.

### 5. Interest in Master Trust

The value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the trust plus actual contributions and allocated investment income less actual distributions and allocated administrative expenses. At March 31, 2025 and 2024, the Plan's interest in the net assets of the Master Trust was approximately 48% and 49%, respectively. Total investment income (including net appreciation in the fair value of investments) and administrative expenses of the Master Trust are allocated to the individual plans based upon the amount of the time the plan's assets were invested in the Master Trust.

## 6. Related-Party and Party in Interest Transactions

The Plan's investments are administered under a Master Trust agreement with Principal Trust Company and Merrill Lynch, the custodians of the Plan. Contributions are held and managed by Principal Trust Company and Merrill Lynch, who invest cash received, interest and dividend income and make distributions to participants. These transactions are party in interest transactions under ERISA.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan or Master Trust. These transactions are party in interest transactions under ERISA.

## 7. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated May 22, 2012, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits in liquidation.

Plan contributions are made (if applicable), and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements. As disclosed previously in Notes 1 and 3, the benefit obligation has been relieved as of October 2024 and thus there is no remaining risks or uncertainties related to that estimate as of March 31, 2025.





EnerSys Hourly Employees' Pension Plan is a defined benefit pension plan that was established July 1, 1991, and was last amended and restated effective as of April 1, 2019. The plan year begins April 1 and ends March 31.

### **Eligibility To Participate**

Participation under this Plan was frozen effective January 1, 2004, with respect to employees scheduled to participate on or after that date.

An employee becomes a participant in the Plan on the first day of the month following the date he meets the following requirement:

- Completes 12 months of employment.

Provided he is a member of the following eligible class of employees:

- Paid on an hourly basis, not a salaried basis.
- Employed at one of the following locations:
  - Sumter, South Carolina plant
  - Richmond, Kentucky plant
  - Branch Sales and Service worksites

### **Normal Retirement Benefit**

#### **Normal Retirement Date**

A participant is eligible for his normal retirement pension as of the first day of the month on or after the participant satisfies the following conditions:

- Attainment of age 65.
- Completion of 5 years of vesting service or the fifth anniversary of participation, if earlier.

#### **Normal Retirement Benefit**

The normal retirement pension is payable monthly as long as the participant lives, with payments ceasing upon the participant's death.

**Normal Retirement Pension Formula**

Benefit accruals under this Plan were frozen effective December 31, 2003.

If the participant retires as of his normal retirement date, his monthly pension will be equal to:

- \$12.50 for benefit service before January 1, 1996, plus
- \$15.00 for benefit service between January 1, 1996, and April 1, 1998, plus
- \$17.00 for benefit service between April 1, 1998, and April 1, 1999, plus
- \$18.00 for benefit service between April 1, 1999, and April 1, 2000, plus
- \$19.00 for benefit service after April 1, 2000.

(B) Richmond Hourly Employees:

- \$15.00 for benefit service before January 1, 1998, plus
- \$17.00 for benefit service after January 1, 1998, plus
- \$1.00 for every year of benefit service earned before July 1, 1991, under the former Exide Hourly Employees' Pension Plan.

(C) Branch Sales and Service Hourly Employees:

- \$12.00 multiplied by benefit service.

**Accrued Benefit**

The accrued benefit on any date other than the normal retirement date is determined according to the normal retirement pension formula, but based upon the participant's benefit service to date.

Benefit accruals were frozen as of December 31, 2003.

**Retirement Payment Options**

A participant may elect to receive his monthly pension in one of these optional forms of payment:

- **Lifetime Pension**
- **Joint and Survivor Pension** with 75% or 50% survivor pension.

If the present value of the vested pension does not exceed \$5,000, a lump sum is the only payment option.

If the participant is married at the time payments are to begin, the automatic form of payment will be a Joint and 50% Survivor Pension with the spouse named as survivor annuitant. If the participant is not married at the time payments are to begin, the automatic form of payment will be a Lifetime Pension.

**Employment after Retirement.** If a participant in pay status returns to employment, retirement benefits will be suspended for each calendar month during which the employee receives payment for services performed on 8 separate days.

### **Other Retirement Benefits**

#### **Late Retirement**

If a participant continues working after his normal retirement date, his pension will not commence until he actually retires. The late retirement benefit is the greater of:

- The retirement benefit accrued as of the end of the preceding plan year, as actuarially increased; or
- The normal retirement benefit determined under the pension formula using benefit service as of December 31, 2003.

#### **Early Retirement**

A participant is eligible for early retirement after attainment of age 55 and completion of 10 years of vesting service. The early retirement pension is the actuarial equivalent of the pension accrued to the date of early retirement.

### **Disability Benefit**

The participant is entitled to receive a disability benefit if he meets all of the following requirements as of the date he becomes disabled:

- Is actively employed.
- Becomes disabled and remains so for six months.
- Completes 15 years of vesting service.

The Plan Administrator makes the determination whether the participant is disabled for Plan purposes. The benefit will be payable in the form of a Lifetime Pension until the earliest of: recovery, death, or normal retirement date.

The monthly disability benefit will be equal to the appropriate benefit formula times years of vesting service. A Social Security supplement benefit will be paid until the participant is eligible for a Social Security disability benefit.

All benefit accruals under this disability provision were frozen as of December 31, 2003.

On attainment of his normal retirement date, his unreduced normal retirement pension will be payable, based on his years of benefit service and benefit formula at the time of disability.

If a participant is eligible for workers' compensation benefits or other disability benefits (other than Social Security), his disability benefit may be reduced.

## **Death Benefit**

### **Preretirement Survivor Benefit**

If a participant dies after he has become vested under the Plan but before he begins to receive a retirement pension benefit, his surviving spouse will receive a 50% survivor benefit if he has been married at least one year. Payment will begin on the date on which he first would have been eligible for retirement. The amount of his surviving spouse's benefit is equal to the 50% survivor benefit payable under the joint and 50% survivor pension option, based upon his accrued pension at the date of death and reduced for early commencement of benefits, if applicable. If the participant is not married or has not been married for a full year at the time of death, no benefit will be paid by the Plan.

## **Termination Of Employment Benefits**

### **Vesting in Accrued Pension**

If employment terminates other than by retirement or disability, the amount payable from the Plan is based upon the following vesting schedule:

<b>Years of Vesting Service</b>	<b>Vesting Percentage</b>
0–4 Years	0%
5 or More Years	100%

A Branch worksite participant who was employed in the Energy Products Group as of March 31, 1999, is 100% vested in his accrued benefit as of March 31, 1999. A participant who was an active employee of Branch as of September 1, 1999, is 100% vested in his accrued benefit as of September 1, 1999. A participant who was an active employee of Sumter as of September 9, 2001, is 100% vested in his accrued benefit as of September 9, 2001.

### **Time of Payment**

The participant may elect payment after his early retirement date, reduced to reflect the early commencement of benefits. No pension payment is available under the Plan prior to early retirement, disability, or death, with one exception. If the present value of the vested accrued benefit does not exceed \$5,000, the lump sum value can be paid following termination of employment.

### **Forfeitures and Restoration**

Forfeiture occurs when the participant terminates employment before being vested. If a participant terminates employment after he is 100% vested and receives a distribution of his accrued pension, he will be permitted to return his distribution to the Plan if he is reemployed during the restoration period. However, before repayment, the Plan will not count service credited prior to the participant's termination when determining his new accrued benefit.

## **Service Rules**

### **Eligibility Service Rules**

Eligibility service is determined using the elapsed time method.

### **Vesting Service Rules**

Vesting service is determined using the elapsed time method. Fractional years of vesting service will be credited to the completed day and then rounded to the next higher tenth of a year.

**Benefit Service Rules**

A participant is credited with a year of benefit service for each 12-month period he is employed by the employer. Fractional years of benefit service will be credited to the completed day and then rounded to the next higher tenth of a year.

- Service when the employee is not a member of the eligible class of employees.
- Service before July 1, 1991, the date the Plan was adopted.
- Service after December 31, 2003.

**Actuarial Equivalence**

Actuarial equivalence is determined as set forth below.

**Late Retirement** – Actuarial equivalence will be determined based on the following mortality table and interest rate assumptions:

**Monthly Pension** – Actuarial equivalence will be determined based on factors described in Section 1.2(b)(1)(c) of the Plan document.

Joint and 75% Survivor Pension -

Participant older than spouse:  $0.88 - 0.01 \times \text{Each Full Year of Age Difference}$

Participant younger than spouse:  $0.88 + 0.01 \times \text{Each Full Year of Age Difference}$

Maximum factor = 0.98
